ARTHUR FREDERICK GRIFFITH, being the Minister of the Crown to whom the administration of the Mining Act 1904-1970, is, for the time being, committed, hereby appoint you, the said Phillip Rennell Adams, Arthur Edward Kay and Albert Harold Telfer, to be a Committee of Inquiry on the following terms of reference, namely—

- (1) To inquire into, and report on, the operation of the Mining Act and, in particular and without limiting the generality of the foregoing, to report whether any and what amendments should be made to the Mining Act in respect of all or any of the following matters:~
 - (a) the various classes of mining tenements, rights and licences and whether any should be eliminated;
 - (b) whether any new forms of mining tenements, rights and licences are necessary;
 - (c) the temporary reservation of Crown land and the grant of rights of occupancy thereover;
 - (d) prospecting and mining on reserves;
 - (e) mining in relation to conservation, ecology, preservation of the balance of nature and preservation of the environment;
 - (f) prospecting and mining on private land;
 - the rehabilitation and restoration of land affected by mining activities;
 - (h) compensation;
 - (i) the manner in which applications for mining tenements, rights and licenses are dealt with and whether and if so what improvements are considered necessary;
 - (j) labour conditions of mining tenements:
 - (k) whether any, and if so, what sub-stances not normally known as

- minerals should be defined as minerals for the purposes of the Mining Act;
- (1) the elimination of outmoded and obsolete provisions and the restatement or replacement of others, to conform more with modern conditions, customs or usage;
- (m) offences and penalties.
- (2) If any amendments be recommended, to report whether-
 - (a) any and what transitional or other provisions should be made to existing holders of mining tenements or other persons, by reason of any change in the law; and
 - (b) any and what other Acts should be repealed or amended, consequentially.

And further appoint you, the said Phillip Rennell Adams, Chairman of the Committee of Inquiry and direct that, for the purposes of a quorum, the said Committee may be constituted by the Chairman and one other member.

- 1. Citation: This Town Planning Scheme may be cited as Shire of Perth Town Planning Scheme No. 27—Morley Drive Extension (hereinafter called "the Scheme").
- 2. Responsible Authority: The authority responsible for enforcing the observance of this Scheme is the Shire of Perth (hereinafter referred to as "the Council").
- 3. Scheme Area: The Scheme shall apply to the lands contained within the inner edge of a broken black line on the Land Use Map and on the Scheme Map. The said land is hereinafter referred to as "the Scheme Area".
- 4. General Objects: The general objects of the Scheme are—
 - (a) To improve and develop the Scheme Area to the best possible advantage.
 - (b) To make suitable provision for road and traffic within the Scheme Area.
 - (c) To make suitable provision for the better use of the land within the Scheme Area for building purposes.
 - (d) To ensure proper drainage of those parts of the Scheme Area that require drainage.
 - (e) To make provision for the creation of drainage reserves and easements.
 - (f) To make provision for public open space within the Scheme Area.
- 5. Scheme Works: The following works shall be carried out within the Scheme Area:—
 - (a) The Scheme Area shall be re-surveyed in conformity with the design shown on the Scheme Map.

- (b) Those portions of the roads shown on the Land Use Map which are shown as closed roads on the Scheme Map shall be closed and the land used for the purposes shown on the Scheme Map.
- (c) The rights of way shown on the Land Use Map shall be closed and the land used for the purposes shown on the Scheme Map.
- (d) The lands shown as roads and coloured yellow on the Scheme Map shall be constructed and drained and any necessary earthworks undertaken. Morley Drive shall, unless the Council shall decide otherwise, be constructed with a dual carriage-way.
- (e) The Scheme Area shall be drained and all necessary drainage works shall be carried out. Any drainage lines required in the Scheme Area may, if deemed necessary by the Council, be connected by a drain to a point of discharge outside the Scheme Area and the costs thereof debited to the Scheme.

- (h) Those outbuildings and fences which, in the opinion of the Council, interfere with the proper development of the Scheme Area according to the new subdivision, shall be demolished and removed.
- (i) All lots within the Scheme Area shall be supplied with reticulated water.
- 6. Acquisition of Land: The land within the Scheme Area, or so much thereof as is necessary to implement the Scheme, shall be resumed or otherwise acquired by the Council.
- 7. Council Land: Any land which shall be vested in or owned by the Council at the date upon which the Scheme shall come into operation, may be used by the Council for the purpose of this Scheme, notwithstanding that such land may be vested in or have been acquired by the Council for other purposes, and upon the coming into operation of the Scheme, such land shall be freed from any trusts covenants or conditions attachable to it.
- 8. Scheme Costs: The Scheme costs shall be as follows:—
 - (a) The administration costs of the Scheme.
 - (b) The cost of the Scheme works and of such other work as shall in the opinion of the Council be for the benefit of the Scheme Area.
 - (c) All compensation payable and all costs and expenses of determining and settling compensation.
 - (d) The cost of acquisition of any land within the Scheme Area in the event of such land being acquired other than by resumption.
 - (e) The cost of providing reticulated water to the Scheme Area.
- 9. Sale of Lots: Subject to the following provisions of this Scheme, the Council shall sell the residential lots created by the re-survey of the Scheme Area. The Council may sell the said lots either by public auction or private contract as a whole or in separate lots, upon such terms and conditions as the Council may think fit. In the event of a sale by private contract, the price shall not be less than the price recommended by the Chief Valuer of the Taxation Department of Western Australia unless, after submitting the land for sale by public auction or tender, that price has not been obtained.
- 10. Valuation of Lots: The Council may, instead of selling all or any of the residential lots, ascertain the value of them or those unsold from the Chief Valuer of the Taxation Department of

- 12. Loss of Scheme: If the Scheme shall show a loss, the amount of the loss shall be met by the Council.
- 13. Time Limit for Claims for Compensation: Claims for compensation by reason of the operation of this Scheme shall be made within six (6) months of the coming into operation of this Scheme or the date of the issue of a notice of resumption, whichever is the later.
- 14. Powers of Council: The Council, in the conduct and management of this Scheme, shall have the following powers:—
 - (a) To enter and inspect the land within the Scheme Area.
 - (b) To enter into Agreements or arrangements with the owners of any land within the Scheme Area.
 - (c) To enter into arrangements and agreements with the Crown, the Metropolitan Water Supply, Sewerage and Drainage Board and the Metropolitan Region Planning Authority.
 - (d) To acquire by purchase or otherwise any land within the Scheme Area.
 - (e) To dispose of any lots to which it becomes entitled as the owner of land within the Scheme Area at the date of the coming into operation of this Scheme upon such terms and conditions as it may think fit. - 1.2 The Scheme shall apply to the whole of the land set out in the maps forming part of the Scheme.
- 1.3 The responsible authority for carrying out the Scheme is the Council of the Shire of Wyndham-East Kimberley (hereinafter referred to as the Council).
- 1.4 Arrangement of Scheme: The Scheme Text is divided into the following Parts—

Part I.—Preliminary

Part II.—Zones

Part III.—Non-conforming Uses

Part IV.—Special Provisions

Part V.—Finance and Administration

The remaining documents of the Scheme are as follows:—

Land Use Map, marked "Map No. 2".

Scheme Map, marked "Map No. 3", or Approved Planning Scheme.

Map marked "Map No. 4" (as the case may be).

1.5 Interpretation: In this Scheme the terms used will have the respective interpretations set out in Appendix 'D' of the Town Planning Regulations, 1967, except that the following words shall be added to the definition of motel—"a cafe may also form part of such premises" and service station.

"A cafe may also form part of such premises."

PART II.—ZONES.

2.1 The Scheme area is divided into five types of zones set out hereunder—

Residential.

Commercial.

Industrial.

Recreational.

Rural.

2.2 Table No. 1 appended to Clause 2.3 of this Part indicates the several uses permitted by this Scheme in the various zones, such uses being determined by cross reference between the list of "Use Classes" on the left-hand side of the Table and the list of "Zones" on the top of that Table.

- 2.3 The symbols used in the cross reference in Table No. 1 appended to this clause have the following meanings—
 - "P" —A use that is permitted under this Scheme.
 - "AA"—A use that is not permitted unless approval is granted by the Council.
 - "IP"—A use that is not permitted unless such use is incidental to the predominant use as decided and approved by the Council.
 - "X" —A use that is not permitted.

PART III.—NON-CONFORMING USE OF LAND.

- 3.1 No provision of the Scheme shall prevent—

 (a) the continued use of any land or building
 - (a) the continued use of any land or building for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or
 - (b) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended), and any other law authorising the development to be carried out have been duly obtained and was current.
- 3.2 Where in respect of land zoned under Part II of the Scheme a non-conforming use exists or was authorised as mentioned in clause 3.1 of this Part on that land, and provided the prior consent in writing of the Council has been obtained, buildings may be extended to the limits prescribed by the Uniform Building By-Laws made under the Local Government Act, 1960 (as amended), or by any other by-laws made under that Act for the purpose of limiting the size, location and distance from boundaries and any other matter required by law

for that class of use within the boundary of the lot or lots on which the use was carried on immediately prior to the coming into force of the Scheme.

- 3.3 Discontinuance of Non-Conforming Use:
 - (a) Notwithstanding the preceding provisions of this Part, when a non-conforming use of any land or building has been discontinued, such land or building shall not thereafter be used other than in conformity with the provisions of the Scheme.
 - (b) The Council may effect the discontinuance of a non-conforming use by the purchase of the affected property, or by the payment of compensation to the owner or the occupier or to both the owner and the occupier of that property, and may enter into an agreement with the owner for that purpose.

PART IV.—SPECIAL PROVISIONS.

4.1 Amenity: The Council may refuse to approve any plans of development or redevelopment of lots if in its opinion the siting, appearance, design and harmony of the proposed buildings would be detrimental to or destroy the amenities of the neighbourhood, nor shall any building be so constructed, finished or left unfinished that its external appearance would disfigure the locality or tend to depreciate the value of adjoining properties. Further, all land and buildings shall be so maintained as to preserve the amenities of the area in which they are situated.

4.2 Appeals:

- (a) Any person wishing to develop land who is aggrieved by a decision of the Council exercising the discretionary powers embodied in clause 2.2 and 2.3 of Part II or clause 4.1 of this part may appeal to the Minister against that decision.
- (b) An appeal under subclause (a) of this clause shall be made within 30 days of receipt of notice of such decision of the original application, the clause or clauses under which the decision was taken, the reasons given for the decision, the clause under which the appeal is made and the reasons for the appeal.
- (c) The decision of the Minister on an appeal shall be final.

PART V.—FINANCE AND ADMINISTRATION.

- 5.1 Disposal of Land: The Council may deal with or dispose of any land which it owns or which it has acquired pursuant to the provisions of the Scheme, in accordance with the Act and in conformity with the provisions of the Scheme, and for such purpose may make such agreements with other owners as it deems fit.
- 5.2 Compensation: Claims for compensation by reason of the Scheme shall be made not later than six months from the date on which notice of approval of the Scheme is published in the Government Gazette.
- 5.3 Entry to Premises: The Council may by an authorised officer enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed.
- 5.4 Penalties: Any person who fails to comply with any of the provisions of the Scheme is guilty of an offence and without prejudice to any other remedy given herein is liable to such penalties as are prescribed by the Act.


