WHEREAS by section 5 of the Cemeteries Act, 1897, the Governor may appoint such place or places in each district as he shall deem expedient a reserve for the burial of the dead; and whereas it is deemed expedient that Reserve 16941, should be reserved for the burial of the dead: Now, therefore the Governor acting with the advice and consent of the Executive Council, doth by this proclamation appoint Reserve 16941 as a reserve for the burial of the dead, to be known as the Ravensthorpe Cemetery.

Rights in Water and Irrigation Act, 1914-1964. PROCLAMATION

WESTERN AUSTRALIA, TO WIT, DOUGLAS KENDREW, Governor. [L.S.] By His Excellency Major-General Sir Douglas Anthony Kendrew, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honour-able Order of the Bath, Commander of the Most Excellent Order of the British Empire, Companion of the Distinguished Service Order, Governor in and over the State of Western Australia and its Dependencies in the Com-monwealth of Australia.

WHEREAS it is enacted by section 27 of the Rights in Water and Irrigation Act, 1914-1964, that the Governor, without constituting any irrigation district under Part IV of the said Act, may, on the recommendation of the Minister and acting with the advice of the Commissioners appointed under subsection (4) of section 3 of the Act, at any time and from time to time by Proclamation declare that Part III of the said Act shall extend to and have effect in and throughout any portion of the State to be defined in the proclamation, and shall apply to and have effect in relation to all rivers, streams, watercourses, lagoons, lakes, swamps or marshes situated within that portion of the State specified and defined aforesaid, but that no such declaration shall be made until after the expiration of thirty days after notice of intention to make such declaration has been given to the local authority or local authorities in or through whose district or districts such rivers, streams, water-courses, lagoons, swamps, lakes or marshes run or are situate to the intent that before the making of such declaration any objection by such local authority or local authorities may be considered: And whereas the Minister has recommended and the Commissioners have advised the Governor by Proclamation to declare that Part III of the said Act shall extend to and have effect in relation to that portion of the State that is defined in the Schedule to this Proclamation and shall apply to and have effect in relation to all rivers, streams, watercourses, lagoons, lakes, swamps, and marshes situated within that portion of the State; and whereas after due notice given the local authority or local authorities concerned have not made any objection to the proposed declaration: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council and on the re-commendation of the Minister and with the advice of the Commissioners and in exercise of the powers conferred by the said Act, do hereby declare that Part III of the Rights in Water and Irrigation Act, 1914-1964, shall extend to and have effect in and throughout the portion of the State as defined in the Schedule hereto and shall apply to and have effect in relation to all rivers, streams, watercourses, lagoons, lakes, swamps and marshes situated within that portion of the State.

#### ORDER IN COUNCIL.

#### L. & S. Corres, 265/70 (MR709).

WHEREAS by section 288 of the Local Government Act, 1960-1970, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the Government Gazette to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street; and whereas the Shire of Canning has requested that certain lands named and described in the schedule hereunder, which have been reserved for a street within its municipal district be declared a public street: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be a public street, and such land shall, from the date of this Order, be absolutely dedicated to the public as a street within the meaning of any law now or hereafter in force.

## ORDER IN COUNCIL.

F.D. 25/67.

WHEREAS the enactment contained in section 74 of the Constitution Act, 1889, whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council, does not apply to minor appointments which by Act of Legislature or by Order in Council may be vested in the heads of departments or other officers or persons within the State; and whereas it is desirable that the appointment of persons as employees of the Forests Department and its branches at a daily or weekly rate of wages should be vested in Ian Dale Scambler or any person appointed to temporarily act in place of such officer: Now, therefore, His Excellency the Governor by and with the advice of the Executive Council hereby vests in Ian Dale Scambler and any person appointed to temporarily act in place of such officer the appointment of persons as employees of the Forests Department at a daily or weekly rate of wages.

## Fire Brigades Act, 1942-1966. ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by subsection (2) of section 5 of the Fire Brigades Act, 1942-1966, that for the purposes of the Act the Governor may, from time to time, by Order in Council—

- (a) adjust the boundaries of a fire district; and
  - (b) remove the name of a fire district or local authority in or from Part II of the Second Schedule of that Act;

and whereas by subsection (4) of that section the municipal and road districts mentioned in Parts I and II of the Second Schedule to the Act were united into one fire district under the name of the Metropolitan Fire District; and whereas by subsequent Orders in Council the boundaries of the Metropolitan Fire District have been adjusted from time to time; and whereas by such an Order in Council published in the Government Gazette on the 11th July, 1969, part of the municipal district of the Shire of Armadale-Kelmscott was included in the Metropolitan Fire District; and whereas by an Order in Council published in the Government Gazette on the 3rd March, 1961, a portion of the municipal district of the Shire of Armadale-Kelmscott was constituted a fire district with the name of Armadale Fire District; and whereas by subsequent Orders in Council the boundaries of the Armadale Fire District have been adjusted from time to time; and whereas it is now expedient that—

- (a) the boundaries of the respective fire districts be adjusted; and
- (b) the Shire of Armadale-Kelmscott be removed from Part II of the Second Schedule to the Act:

Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby—

- (a) adjust the boundaries of the Metropolitan Fire District and the Armadale Fire District by the excise from the Metropolitan Fire District and the addition to the Armadale Fire District of that portion of land described in the Schedule to this Order in Council; and
- (b) remove the Shire of Armadale-Kelmscott from Part II of the Second Schedule to the Act.

#### ORDER IN COUNCIL.

Corres. 3037/68.

WHEREAS by section 33 of the Land Act, 1933-1969, it is *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that Reserve No. 30598 should, subject as aforesaid be granted in fee simple to Fremantle Hospital Board to be held in trust for "Hospital Purposes": Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the beforementioned reserves about be direct that the beforementioned reserve shall be granted in fee simple to the aforesaid body, to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Metropolitan Water Supply, Sewerage, and Drainage Act, 1909-1970. Metropolitan Water Supply.

## ORDER IN COUNCIL.

## M.W.B. 825842/70.

WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909-1970, it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply, Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Shire of Rockingham-Warnbro.

Twelve-inch Feeder Main in Safety Bay Road.

The construction of a twelve inch diameter water main, about seven thousand, one hundred feet in length, complete with valves and all other necessary apparatus, and shown on plan M.W.B. 10694.

This Order in Council shall take effect from the 2nd day of October, 1970.

- (3) Immediately surrounding all buildings, haystacks, and fuel ramps, situated on the land.

Definition of "Firebreak". For the purpose of the above Regulation a firebreak shall be deemed to be a strip of land not less than 8ft. in width clear of all infiammable material by either ploughing, cultivating, burning, etc., so that such strip cannot carry fire.

For the purpose of this regulation any made road cleared to a width of not less than 20ft., of all infiammable material will be accepted as a firebreak.

Townsites:

All town lots shall conform with the following prior to the 31st October, 1970 in each year and maintained in such order until the 1st April, of the following year.

- (1)  $\frac{1}{4}$  acre or less to be cleared and maintained free of all grass and debris of an inflammable nature.
- (2) Over  $\frac{1}{4}$  acre to be cleared and maintained free of all debris of an infiammable nature to a width of 8ft immediately inside of all external boundaries.

Where it is not considered practicable or advisable by reason of possible erosion or other effect to adhere in detail to the Regulations, a variation of such may be applied for from the nearest Fire Control Officer.

PURSUANT to powers contained in section 33 of the above Act, you are hereby required on or before the 15th day of November, 1970, to clear of all inflammable material firebreaks not less than 6 feet wide in the following positions on all rural and townsite land owned or occupied by you and thereafter to maintain the firebreaks clear of infiammable material up to and including the 30th March, 1971:—

1. On land which is divided by or abuts a cleared or partly cleared road or railway reserve, a firebreak shall be provided within three chains of the boundary of the road or the railway reserve.

3. Immediately surrounding or within one chain of the perimeter of any drum or drums situated on the land which are normally used for the storage of fuel, whether they contain fuel or not.

4. Townsite Land: All inflammable materials to be removed from lots less than one-half acre. Where townsite land exceeds one-half acre, firebreaks be constructed ten feet wide immediately surrounding or within one chain of the perimeter of all buildings and haystacks on the land. Where adjoining lots are held by one owner or occupier the lots are deemed to form one piece of land.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer not later than the 15th day of October, 1970, for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine or not less than \$10 nor more than \$200, and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.
