Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 172 of the Companies Act, 1961-1970, being satisfied that—

- (c) it is in the public interest that allegations of fraud, misfeasance or misconduct by persons who are or have been concerned with the formation or management of Travellers Insurance Corporation Limited should be investigated under that Division;
- (d) having regard to the nature of the business carried on by Travellers Insurance Corporation Limited, its management, shareholding, capital and financial failure, the company should be investigated under that Division,

do hereby declare that Travellers Insurance Corporation Limited is a company to which that Division applies.

Child Welfare Act, 1947-1970.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 19 of the Child Welfare Act, 1947-1970 that the Governor may by Order in Council (*inter alia*) appoint a special magistrate or special magistrates for any court or courts established under that section and may, in like manner, amend, vary or revoke any appointment made under that section; and whereas it is now expedient that those powers should be exercised in the manner hereinafter appearing: Now, therefore, His Excellency the Governor acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth appoint Terence Syddall as a special magistrate for every Children's Court heretofore established under the said section.

Child Welfare Act, 1947-1970.

ORDER IN COUNCIL.

WHEREAS by section 19 of the Child Welfare Act, 1947-70, it is provided (*inter alia*) that the Governor may, by order in Council—

- (a) establish special courts to be called Children's Courts and determine the area in and for which each court shall exercise jurisdiction, by reference to Magisterial Districts;
- (b) appoint, as Special Magistrates, Magistrates or persons who may from time to time, temporarily or otherwise, be assigned to or occupying the office or performing the duties of a Magistrate assigned to one or more Magisterial Districts; and
- (c) appoint such persons, male or female, as he thinks fit, to be members of any particular Children's Court;

Now therefore, His Excellency the Governor, in exercise of the powers conferred by the above-mentioned provisions of the said Act and with the advice and consent of the Executive Council, doth—

- (a) establish a special court to be called a Children's Court at Gascoyne Junction to exercise jurisdiction within the area known as the Gascoyne Magisterial District; and
- (b) appoint—
 - (i) Jocelyn Martin Forrest, Stipendiary Magistrate, Carnarvon, to be a Special Magistrate for; and
 - (ii) Peter Martin Butler, and Doris Jean Viveash, of Gascoyne Junction, to be Members of the Children's Court at Gascoyne Junction.

ORDER IN COUNCIL.

Constitution of Esperance Water Reserve.

ORDER IN COUNCIL.

P.W.W.S. 794/70.

WHEREAS it is enacted by section 9 of the Country Areas Water Supply Act, 1947-1964, that the Governor may by Order in Council constitute a Water Reserve: Now, therefore, His Excellency the Governor by and with the consent of the Executive Council doth hereby constitute the Esperance Water Reserve as defined in the schedule hereunder and assign the name of Esperance Water Reserve thereto.

Schedule.

Esperance Water Reserve.

All that portion of land bounded by lines starting from the southwestern corner of Esperance Location 1395 and extending generally southeasterly along the northern side of a surveyed road passing along the southern boundary of that location and Locations 1421 and 1420, through Location 667, the southern boundaries of Locations 1603 and 925 to the southeastern corner of the lastmentioned location; thence northerly along the eastern boundary of that location to the southwestern corner of Location 756; thence easterly along the southern boundary of that location and Locations 755, 754, 750 and onwards to and along the southern boundary of Location 712 to the southwestern corner of Location 711; thence easterly along the southern boundary of the southwestern severance of that location and onwards to and along the southern boundary of the northeastern severance of that location aforesaid and the southern boundaries of Locations 710, 700, 1044 and 293 to the southwestern corner of Location 319; thence easterly, northerly, again easterly and again northerly along boundaries of that location to the southwestern corner of Location 1054; thence southeasterly and easterly along the southern boundary of that location to its southeastern corner; thence northeasterly to the southwestern corner of Reserve 2779, a point on the northern side of Road Number 11996; thence easterly along that side and onwards to a point situate in prolongation northerly of the western boundary of Location 835; thence southerly to and along that boundary and southeasterly and southwesterly along boundaries of that location to the northwestern corner of Location 1610; thence generally southeasterly along southwestern boundaries of that location to the southernmost southwestern corner of Location 835 aforesaid; thence southeasterly and easterly along boundaries of that location to a point situate in prolongation northerly of the western boundary of Location 811; thence southerly to and along that boundary to the northwestern corner of Location 812; thence southerly and generally southeasterly along boundaries of that location to its southernmost southeastern corner; thence easterly to the westernmost northwestern corner of East Location 9; thence south-

erly and easterly along boundaries of that location to the western boundary of Esperance Location 818; thence southerly along that boundary and onwards to the northeastern corner of East Location 22; thence southerly along the eastern boundary of that location and onwards to the high water mark of Esperance Bay; thence generally westerly along that mark and the high water mark of the Southern Ocean to the prolongation southeasterly of the eastern boundary of Esperance Location 952; thence northwesterly to and along that boundary to the northeastern corner of that location; thence northwesterly and generally northeasterly along the southwestern and northwestern sides of a surveyed one chain road passing through Location 471, as shown on Lands and Surveys Original Plan 1723 to an eastern boundary of that location; thence northerly along that boundary and onwards to a southern boundary of Dalyup Agricultural Area Lot 2; thence generally northeasterly along southern and eastern boundaries of that lot to the southeastern corner of Lot 3; thence northerly along the eastern boundary of that lot and onwards to and along the eastern boundary of Lot 6 to the southeastern corner of Lot 7; thence northerly and northeasterly along boundaries of that lot to the southeastern corner of Lot 47; thence northeasterly along boundaries of that lot and onwards to the southeastern corner of Lot 25; and thence easterly to the starting point, as bordered blue on Plan P.W.D., W.A. 46090-1-1.

Metropolitan Main Drainage.

ORDER IN COUNCIL.

M.W.B. 488742/70.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1970 it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct, provide, and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Shire of Perth.

Maylands-Inglewood Drainage Area.

Eighth Avenue Branch Drain—Amplification.

The construction of approximately two thousand feet of fourty eight inch diameter, fortytwo-inch diameter and thirtysix-inch diameter piped drain together with all necessary apparatus and things connected therewith and as shown on plan M.W.B. 10719.

This Order in Council shall take effect from the 11th day of December, 1970.

Twelve-inch Feeder Main in Helena Valley Road.

The construction of a twelve-inch diameter water main, about one thousand one hundred feet in length, complete with valves and all other necessary apparatus, and as shown on plan M.W.B. 10768.

- Principal regulations. 1. In these regulations the Poisons Act Regulations, 1965 published in the *Government Gazette* on the 29th June, 1965 and amended from time to time thereafter by notices published in the *Government Gazette*, are referred to as the principal regulations.
- Reg. 51A amended. 2. Regulation 51A of the principal regulations is amended—
 (a) by deleting the words—
 "Methyl phenidate"
 in line twelve of subregulation (1); and
 (b) by substituting for the passage "regulation." in line four of paragraph (b) of subregulation (7) the following—
 " regulation; or
 (c) a person acting in accordance with regulation 51B of these regulations."
- Reg. 51B added. 3. The principal regulations are amended by adding immediately after regulation 51A the following regulation:—
 51B. (1) In this regulation—
 "drug addict" means a person, not being a person who is a registered patient under regulation 51A of these regulations, who suffers from a state of periodic or chronic intoxication produced by the repeated consumption of a drug of addiction, which state is often characterised by a desire to continue taking the drug of addiction, a tendency to increase the dose and a psychic and physical dependence on the effect of the drug of addiction.
- (2) Any medical practitioner who is treating a drug addict and considers it necessary for the purposes of such treatment that the drug addict should receive rational supplies of any drug of addiction shall forthwith notify the Commissioner of the case of that drug addict by forwarding to the Commissioner the appropriate form prescribed in the Notification of Diseases (Non Communicable) Regulations, 1958, and the Commissioner may then at his discretion give to that medical practitioner written permission to prescribe for that drug addict such maximum quantities of the drug of addiction in question as the Commissioner shall deem necessary.
- (3) A medical practitioner who prescribes a drug of addiction for the treatment of a drug addict—
 (a) without the written permission of the Commissioner; or
 (b) in excess of the quantity permitted by the Commissioner,
 commits an offence against these regulations.
- (4) A medical practitioner who has been prescribing or supplying any drug of addiction for any patient, other than a registered patient under regulation 51A of these regulations, for a continuous period of two months shall not prescribe or supply any further quantity of any drug of addiction for that patient—
 (a) until he has reported the case of that patient to the Commissioner; and
 (b) until the Commissioner has given him written permission to prescribe and supply specified maximum quantities of any drug of addiction to that patient,
 and the Commissioner may at his discretion require further periodic reports from the medical practitioner and may from time to time specify in writing the maximum quantity of any drug of addiction that the medical practitioner may prescribe or supply to that patient.

- (1) That the period from five o'clock in the forenoon of January 1, 1971, until seven o'clock in the afternoon of December 31, 1971, shall be an open season in respect of those species of wild duck in the Second Schedule hereto in those parts of the State which lie within the boundaries of the Kimberley, North-West and Eastern Divisions, as defined in section 28 of the Land Act, 1933, with the exception of those areas defined in the First Schedule hereto.
- (2) That a person shall not take any wild duck or the egg of any wild duck for the purpose of keeping it in captivity, or for the purpose of aviculture, or for the purpose of sale.
- (3) That a person shall not sell any wild duck.
- (4) That a person shall not take any wild duck by any means other than a shot-gun licensed pursuant to the Firearms and Guns Act, 1931 and having a calibre less than thirty one-fortieths of an inch in internal diameter (ten gauge), provided that this restriction shall not prohibit a person who is a native within the meaning of the Native Welfare Act, 1905, from using any native artifact in the taking of wild ducks.
- (5) That a person shall not take or attempt to take wild ducks from any boat, raft, launch or other type of boat which is powered by any type of motor or engine or which is propelled or towed by any means other than by hand.
- (6) That a person shall not take or attempt to take more than eight wild ducks in any one day of the open season.
- (7) That a person shall not have under his control or in his possession or keep in any cool store or any freezing chamber or other premises at any one time—
 - (a) on opening day more than eight wild ducks;
 - (b) on any day other than opening day of the open season, more than sixteen wild ducks.
