AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, on the 20th day of October, 1971, the following Order in Council was authorised to be issued:—

Fire Brigades Act, 1942-1966.

ORDER IN COUNCIL.

WHEREAS it is provided by subsection (3) of section 5 of the Fire Brigades Act, 1942-1966, that an Order in Council made pursuant to the provisions of that section may from time to time be varied or cancelled; and whereas an Order in Council was made pursuant to section 5 of that Act on the 1st September, 1971, and published in the *Government Gazette* on the 10th September, 1971, for the purpose, *inter alia*, of adjusting the boundaries of the Kojonup Fire District; and whereas there was an error in the Order occurring in the description of that portion of land as described in the schedule thereto; and whereas it is now expedient to cancel that Order; and whereas it is provided by subsection (1) of section 5 of the Fire Brigades Act, 1942-1966, that, subject to the provisions of that section, the municipal districts and parts thereof constituted as fire districts prior to the coming into operation of the Fire Brigades Act Amendment Act, 1959, as set out in the Second Schedule to the Fire Brigades Act, 1942-1966, are for the purposes of that Act fire districts under the respective names as set out in that schedule; and whereas a part of the municipal district of the Shire of Kojonup is such a fire district with the name Kojonup Fire District; and whereas it is further provided, *inter alia*, by subsection (2) of that section that for the purposes of the Act the Governor may from time to time, by Order in Council adjust the boundaries of a fire district: Now, therefore, His Excellency the Governor, acting with the advice and consent of Executive Council, doth hereby—

- (a) cancel the Order in Council made on the 1st September, 1971 and published in the *Government Gazette* on the 10th September, 1971; and
- (b) adjust the boundaries of the Kojonup Fire District so that the boundaries of that fire district are as set out in the schedule to this Order in Council.

Schedule.

Description of Boundaries of Kojonup Fire District.

All that portion of land bounded by lines starting at the southwestern corner of Kojonup Location 7571 and extending northerly along the western boundary of that location and onwards to the northern boundary of Location 84; thence easterly along that boundary and the northern

boundary of Location 1 to a point situate in prolongation northerly of the western boundary of Location 134; thence southerly to the southern boundary of Location 1 aforesaid; thence easterly along that boundary, the southern boundary of Kojonup Lot 225 and onwards to the eastern side of Dearle Road; thence southerly along that side, the eastern boundary of Lot 92 and onwards to the northern side of Broomehill Road (Road Number 351); thence northwesterly along that side to a point situate north of the intersection of the southern side of Partridge Road (Road Number 10432) and the western side of the Kojonup-Katanning Railway Reserve; thence south to that intersection; thence generally southwesterly along the western side of the Kojonup-Katanning Railway Reserve aforesaid to the left bank of a tributary of the Kojonup Brook; thence generally southerly upward along that bank to the northern boundary of Kojonup Location 778; thence westerly along that boundary to the eastern side of the Albany Highway; thence southeasterly along that side to a point situate in prolongation easterly of the northern boundary of Location 2431; thence westerly to and along that boundary to its northwestern corner; thence westerly to the south-eastern corner of the western severance of Location 1086; thence westerly along the southern boundary of that severance to the southeastern corner of Location 147; thence northerly and northwesterly along boundaries of that location and onwards to the eastern boundary of Location 162; thence northerly and generally northeasterly along boundaries of that location and the western side of Soldier Road (Road Number 8917) and onwards to the southern boundary of Kojonup Lot 252; thence easterly along that boundary to the starting point.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1971, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any Municipality, Body Corporate, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corres. 6134/97.—That Reserve No. 4313 should vest in and be held by the Shire of Dowerin in trust for the purpose of "Conservation of Natural Vegetation".

Corres. 3760/70.—That Reserve No. 31221 should vest in and be held by the Minister for Native Welfare in trust for the purpose of "Orchard and Horticultural Development".

Corres. 964/66.—That Reserve No. 31223 should vest in and be held by the Shire of Dandaragan in trust for the purpose of "Recreation".

Corres. 3744/71.—That Reserve No. 31224 should vest in and be held by the Shire of Koorda in trust for the purpose of "Park".

Land Act, 1933-1971.

ORDER IN COUNCIL.

Corres. 1187/11.

WHEREAS by section 33 of the Land Act, 1933-1971, it is, *inter alia*, made lawful for the Governor by Order in Council, to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient that Reserve No. 13263 should, subject as aforesaid be granted in fee simple to the Western Australian Fire Brigades Board to be held in trust for "Fire Brigade Station": Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the before-mentioned reserve shall be granted in fee simple to the aforesaid body, to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor.

Corres. 12349/08.—That Reserve No. 24504 should vest in and be held by the Shire of Gosnells in trust for the purpose of "Wildlife Park".

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned Reserves shall vest in and be held by the abovementioned bodies, in trust for the purposes aforesaid with power to the said bodies subject to the approval in writing of the Minister for Lands being first obtained, to lease the whole or any portion of the said Reserves for any term not exceeding 21 years from the date of the lease subject nevertheless to the powers reserved to him by section 37 of the said Act.

WHEREAS it is enacted, *inter alia*, by subsection (2) of section 691 of the Local Government Act, 1960-1971, that the power given by that Act to make Orders includes power from time to time to vary those orders; and whereas by an Order published in the *Government Gazette* on the 11th November, 1966, that portion of the district of the Shire of Kojonup set forth in the schedule to that Order, was declared to be an area within which the Kojonup Shire Council may impose, in respect of the rateable property therein, a greater rate than it imposes elsewhere in the district: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of Executive Council, hereby varies that Order by excising the area of land described in the schedule hereunder from the area within which a greater rate may be imposed than that imposed elsewhere in the district.

ORDER IN COUNCIL.

L.G. 435/63.

WHEREAS it is enacted, *inter alia*, by subsection (2) of section 691 of the Local Government Act, 1960-1971, that the power given by that Act to make Orders includes power from time to time to revoke those Orders for the purpose of substituting other Orders for those revoked; and whereas by an Order published in the *Government Gazette* on the 26th June, 1970, those portions of the district of the Shire of Carnarvon set forth in the schedule to that Order were declared to be areas within which the Carnarvon Shire Council may impose, in respect of the rateable property therein, a greater rate than that which it imposes elsewhere in the district: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of Executive Council, hereby revokes that Order, and, under the powers conferred by subsection (4) of section 548 of the Local Government Act, 1960-1971, hereby declares those portions of the district of the Shire of Carnarvon described in the schedule hereto, to be areas within which the Carnarvon Shire Council may impose, in respect of the rateable property therein, a greater rate than that which it imposes elsewhere in the district.

Valuation and Rating.

ORDER IN COUNCIL.

L.G.D. 374/66.

WHEREAS by order published in the *Government Gazette* on the 18th August, 1961, the Shire of Balingup was authorised to adopt valuations assessed on the annual value of certain rateable land in its district, particulars whereof were set forth in the schedule to that order; and whereas by order published in the *Government Gazette* on the 26th March, 1970 the Shires of Balingup and Donnybrook were united to form one municipality named the Shire of Donnybrook, the name of which was altered to that of the Shire of Donnybrook-Balingup by order published in the *Government Gazette* on the 17th July, 1970; and whereas it is provided, *inter alia*, by subsection (14) of section 533 of the Local Government Act, 1960-1971 that, at the request of the council of a municipality which is a shire, the Governor may revoke an order made under that section authorising the council to adopt valuations assessed on annual value of any rateable property in its district: Now, therefore, His Excellency the Governor, acting with the advice and consent of Executive Council, hereby revokes the abovementioned order published in the *Government Gazette* on the 18th August, 1961 in so far as that order authorises the Shire of Donnybrook-Balingup to adopt valuations assessed on annual value of rateable land contained within the townsite of Mullalyup.

Explosives and Dangerous Goods Act, 1961-1967.

ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 14 of the Explosives and Dangerous Goods Act, 1961-1967, that the Governor may from time to time by Order in Council, classify explosives and declare any specified explosive to be an authorised explosive for the purposes of that Act and that the Governor shall not so classify or declare any explosive until the Chief Inspector has defined the composition, quality and character of that explosive; but such definition in respect of the explosive is not required to be published in the Order in Council classifying that explosive; and whereas it is further enacted that an Order in Council made under the said section may be cancelled or from time to time varied by a subsequent Order in Council; and whereas the Chief Inspector has defined the composition, quality and character of the explosive hereinafter mentioned and it is now expedient that the Order in Council made by the
