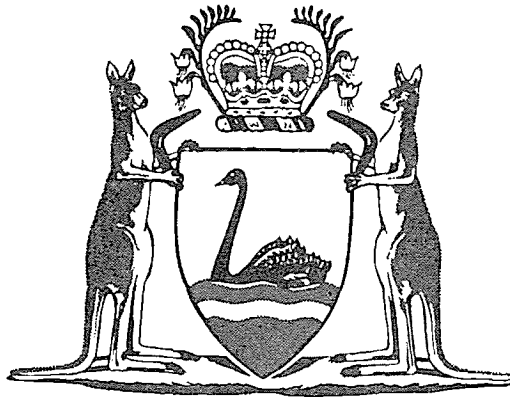

 - 1.1 the abolition of the Department of Native Welfare and the Child Welfare Department.
 - 1.2 the establishment of the Aboriginal Affairs Planning Authority and the Department for Community Welfare;

- (2) transferred, under the provisions of Section 10 of the Public Service Act, 1904–1972—
 - 2.1 the officers and offices detailed in schedule “A” from the Department of Native Welfare to the State Housing Commission;
 - 2.2 the officers and offices detailed in schedule “B” from the Department of Native Welfare to the Aboriginal Affairs Planning Authority;
 - 2.3 the officers and offices detailed in schedule “C” from the Department of Native Welfare and the Child Welfare Department, to the Department for Community Welfare;

- (3) reclassified and/or retitled as indicated, those positions marked with an asterisk in schedules “A”, “B” and “C”;
