### Determination—Quantity Surveyors

Pursuant to Section 12 of the Public Service Arbitration Act, 1966-1970, the Public Service Board hereby gives notice that the titles, salaries or salary ranges allocated to offices and salary within each salary range allocated to officers covered by the Public Service Professional Division (Quantity Surveyors) Salaries Agreement, No. 19 of 1972 as at September 20, 1972, shall be in accordance with the following Determination.
