### TAXI-CARS (CO-ORDINATION AND CONTROL) ACT, 1963-1973.

HIS Excellency the Governor in Executive Council acting pursuant to the provisions of the Taxi-cars (Co-ordination and Control) Act, 1963-1973, has been pleased to make the regulations set out in the schedule hereunder.

#### Schedule. Regulations.

**Principal Regulations.** 1. In these regulations the Taxi-cars Regulations, 1964 as reprinted pursuant to the Reprinting of Regulations Act, 1954 and published in the *Government Gazette* on the 4th March, 1970, with amendments up to and including the 9th November, 1969, and amended from time to time thereafter by notices so published, are referred to as the principal regulations.

**Part X amended.** 2. Part X of the principal regulations is amended—  
(a) by substituting for Appendix A an appendix as follows:—

#### Appendix A.

#### Fares and Charges.

#### TAXI-CARS, OTHER THAN PRIVATE TAXI-CARS.

	Cents
Flagfall .. .. .	27
Distance Rate—for each 0.2 kilometre (or part thereof) .. .	3
Minimum charge .. .	30
Detention charge—for each 36 seconds or part thereof .. .	3
Surcharge—between the hours of midnight and 6.00 a.m. ....	10

#### Special Hirings:

##### Weddings:

14 dollars for the first two hours or part thereof, plus 1 dollar per quarter hour or part thereof thereafter.

Plus 1 dollar Booking Fee.

##### Funerals:

4 dollars for the first hour or part thereof, plus 75 cents per quarter hour or part thereof thereafter.

Where during the course of a special hiring a taxi-car is required to travel more than 16 kilometres, a charge of 15 cents per kilometre shall be paid for each additional kilometre or part thereof.

#### Luggage:

For luggage carried in the boot of a taxi—20 cents.

No charge shall be made for 1 suitcase and a brief case carried in the boot of a taxi.

Baby carriages and wheelchairs are exempt from this charge.

#### Cleaning:

Where soiled or befouled during hiring—

Requiring 30 minutes or less cleaning time .... \$1.00

Requiring more than 30 minutes, but less than 60 minutes cleaning time .... \$2.00

Requiring more than 60 minutes cleaning time .... \$5.00

#### PRIVATE TAXI-CARS.

	Cents
Distance Rate—for each one kilometre or part thereof ..	15
For return journey by nearest practicable route (for each one kilometre or part thereof) ....	15
Hourly Rate—for each quarter hour or part thereof ..	\$1.50
Fare to be charged at distance rate or hourly rate, whichever is the greater.	
Minimum Charge .....	\$3.00

#### Special Hirings:

##### Weddings:

17 dollars for the first two hours or part thereof, plus \$1.50 per quarter hour or part thereof thereafter.

Plus 1 dollar Booking Fee.

##### Funerals:

8 dollars for the first hour or part thereof, plus 1 dollar per quarter hour or part thereof thereafter.

Where during the course of a Wedding or Funeral a Private Taxi-Car is required to travel more than 16 kilometres a charge of 18 cents per kilometre shall be paid for each additional kilometre or part thereof.

(b) by substituting for Appendix C an appendix as follows:—

Fare to be charged at distance rate or hourly rate whichever is the greater.	
2. A hiring continued in the part of the State to which the Act does not apply but completed in part of the State to which the Act does apply—	
Distance Rate:	Cents
For whole journey—for each kilometre or part thereof ....	15
Hourly Rate:	
For each quarter hour or part thereof ....	\$1.50
Fare to be charged at distance rate or hourly rate whichever is the greater.
