SCHEDULE

NURSES REGULATIONS, 1973.

PART I.—PRELIMINARY.

Citation and Commence-ment.

1. These regulations may be cited as the Nurses Regulations, 1973 and shall come into operation on the First day of January, 1974.

Application.

2. These regulations are in addition to and not in derogation of the Midwives Regulations, 1959 made under the provisions of the Health Act, 1911, as reprinted and published in the *Government Gazette* of the 6th May, 1968.

Revocation.

- 3. (1) The Nurses Regulations published in the Government Gazette on 29th December, 1969, as amended by subsequent notices published in the Government Gazette on 13th January, 1971, and 25th January, 1972, are hereby revoked.
- (2) The Midwifery Nurses Regulations published in the Government Gazette on 29th December, 1969, are hereby revoked.
- (3) The Nursing Aides Regulations published in the Government Gazette on 29th December, 1969, are hereby revoked.
- (4) The Nurses Board of Western Australia (Members Fees) Regulations, 1969, published in the Government Gazette on 29th December, 1969, are hereby revoked.

Inter-pretation.

- 5. (1) In these regulations,-
 - "approved" means approved in writing by the Board;
 - "Board" means the Nurses Board of Western Australia established under the Act;

"controlling authority" means-

- (a) in the case of a public hospital, the Board of Management of the hospital, or where there is no such Board of Management, the Minister;
- (b) in the case of a private hospital, the person or persons responsible for the control of the hospital;(c) in the case of an educational institution, the person or
- persons responsible for the control of the institution;
- "education" includes theoretical and practical instruction in nursing for the purposes of obtaining the qualifications referred to in these regulations;
- "First Professional Examination" means the examination taken at the end of the first year of the course in the subjects for that year:
- "matron" means the matron or director of nursing in charge of a hospital or institution at which persons are educated as nurses;
- "Registrar" means the person appointed to be the Registrar for the purposes of the Act;
- "Secretary" means the secretary for the time being of the Board;
- "school of nursing" means a hospital or an institution or a group of hospitals or institutions, approved by the Board as a school for the education of student nurses;
- "student midwife" means a person who has been accepted by the controlling authority to be educated to qualify as a midwifery
- "syllabus" means a list of the contents of the course;
- "the Act" means the Nurses Act, 1968.
- (2) In these regulations words importing the female gender include the male.

PART II.—REGULATIONS OF GENERAL APPLICATION TO SCHOOLS OF NURSING.

- Schools may 6. (1) The controlling authority of a hospital of of the land the beapproved apply to the Board in the Form No. 1 in Appendix 1 to these regulations approved and classified as a school of to have the hospital or institution approved and classified as a school of nursing and on making such application shall undertake to furnish the Board such information as it may, at any time or from time to time, require regarding the students and the education being given.
 - (2) The approval if granted shall be in writing signed by the Chairman of the Board and shall be in Form No. 2 in Appendix 1 to these regulations.
 - (3) An approval granted under this regulation shall remain in force until revoked by the Board by notice in writing signed by the Chairman of the Board in Form No. 3 in Appendix 1 to these regulations.
 - (4) An approval granted under this regulation may be revoked by the Board at any time.

Inspection.

The Board has the right to inspect hospitals or institutions applying to be approved and to withhold or withdraw approval if in its opinion the necessary conditions have not been fulfilled or maintained

Listing.

8. A list of hospitals or institutions approved as schools of nursing shall be maintained by the Board and such list may be amended whenever the Board shall so direct.

General require-ments.

- A hospital or group of hospitals may be approved as a school of nursing if it fulfils and continues to fulfil the following conditions:-
 - (a) the matron is a registered general nurse who, in the opinion of the Board, has suitable qualifications and experience to undertake the education of nurses in the subjects prescribed in relation to that school:

they relate.

- (b) the buildings, equipment and other facilities available, including a school of nursing, are adequate, in the opinion of the Board, for educational purposes;
- (c) the proportion of qualified staff to students constitutes a sufficient teaching staff to ensure adequate supervision of the students' duties;
- (d) the hospital conducts an examination at the end of each course of instruction in the subject or subjects prescribed, and at the conclusion of the final examination furnishes to each successful student a certificate that she has attended the prescribed course of lectures, has had the necessary practical nursing experience, has passed her hospital examinations, and has completed her educational period;
- (e) the hospital maintains records of the theory and practical experience received, the result of all examinations undertaken by each student during her course, and supplied to each student a copy of the record applying to herself on completion of her education or at any time she discontinues; and
- (f) it otherwise complies with the requirements of these regulations.

(1) The syllabuses of the various courses are set out in Appendices 2 to 9 to these regulations.

(2) For the purposes of giving effect to the syllabuses set out in the Appendices to these regulations, the Board may from time to time issue supplementary written instructions for use in schools of nursing and any instructions so issued shall be deemed to be part of the course to which

Syllabuses.

PART III.-THE VARIOUS SCHOOLS.

(1) The provisions of this regulation apply to schools of nursing for general nurses and are in addition to the general requirements set out in regulation 9 of these regulations.

(2) In the total clinical field of the school, the average daily availability of patients should not be less than two hundred and fifty.

- (3) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators and other resource personnel approved by the Board, in accordance with the syllabus prescribed in Appendix 2 to these regulations.
- (4) The period of education, exclusive of sick leave and leave other than ordinary leave, shall not be less than-
 - (a) in the case of a student indexed by the Board other than a nurse registered as a mental health nurse, a tuberculosis nurse, or a children's nurse, three years in a general school of nursing other than a children's hospital registered as a general school of nursing;
 - (b) in the case of a student registered by the Board as a mental health nurse or as a tuberculosis nurse, two years in a general school of nursing;
 - (c) in the case of a student registered by the Board as a children's nurse, six months in a general school of nursing;
 - (d) in the case of a student being educated in a children's hospital recognised as a general school of nursing, three and one-half years of which not less than six months must be in an adult hospital.
- (5) An applicant for admission as a student shall be not less than seventeen years of age.
- (1) The provisions of this regulation apply to schools of nursing Midwifery for midwifery nurses and are in addition to the general requirements set out in regulation 9 of these regulations.

(2) The matron shall be a registered midwifery nurse.

(3) An average of not less than five hundred confinements shall have taken place, or be expected to take place, each year.

General.

- (4) Facilities shall be available, to the satisfaction of the Board, for teaching by specialist obstetricians.
- (5) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators and other resource personnel approved by the Board, in accordance with the syllabus prescribed in Appendix 3 to these regulations; and for the instruction of student midwifes in obstetric anaesthesia in accordance with the syllabus.
- (6) The period of education, exclusive of sick leave and leave other than ordinary leave, shall not be less than—
 - (a) in the case of a student indexed by the Board, other than a nurse registered as a general nurse, two years in a midwifery school of nursing; or
 - (b) in the case of a student registered by the Board as a general nurse, one year in a midwifery school of nursing.
- (7) An applicant for admission as a student shall be not less than twenty-one years of age, but this requirement does not apply to an applicant who is a registered general nurse.

Mental Health nurses.

- 13. (1) The provisions of this regulation apply to schools of nursing for mental health nurses and are in addition to the general requirements set out in regulation 9 of these regulations.
 - (2) The matron shall be a registered mental health nurse.
- (3) In the total clinical field of the school the average daily availability of patients should not be less than two hundred and fifty.
- (4) The school shall have, and be able to provide clinical experience for such periods as are approved by the Board, in—
 - (a) a long stay unit;
 - (b) a short stay unit;
 - (c) a psychiatric day hospital unit (or general hospital short stay psychiatric unit).
- (5) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators and other resource personnel approved by the Board, in accordance with the syllabus prescribed in Appendix 4 to these regulations.
- (6) The period of education, exclusive of sick leave, and leave other than ordinary leave, shall not be less than— $\,$
 - (a) in the case of a student indexed by the Board, other than a registered general nurse, three years in a mental health school of nursing;
 - (b) in the case of a student registered by the Board as a general nurse, eighteen months in a mental health school of nursing.
- (7) An applicant for admission as a student shall be at least seventeen years of age.

Mothercraft nurses.

- 14. (1) The provisions of this regulation apply to schools of nursing for mothercraft nurses and are in addition to the general requirements set out in regulation 9 of these regulations.
- (2) The matron shall be a registered nurse in the midwifery and child health divisions.
 - (3) Provision shall be made for-
 - (a) residential accommodation for students;
 - (b) accommodation for not less than four nursing mothers;
 - (c) a sitting and dining room for mothers;
 - (d) at least four cots for artificially fed babies;
 - (e) facilities for examination of mothers and babies, breast care, test feedings, and weighing and measuring babies;
 - (f) bathing and dressing facilities;

- (g) a properly equipped food dispensary;
- (h) lecture and demonstration room;
- (i) isolation room;
- (j) sun verandahs;
- (k) facilities for practical instruction of students in keeping of records:
- (1) facilities equivalent to those existing at a recognised pre-school centre for observation of pre-school children in relation to their general development.
- (4) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators and other resource personnel approved by the Board, in accordance with the syllabus prescribed in Appendix 5 of these regulations.
- (5) The period of education, exclusive of sick leave and leave other than ordinary leave, shall not be less than fifteen months.
- (6) An applicant for admission into a school of nursing for mother-craft nurses shall be at least sixteen and one-half years of age.
- (1) The provisions of this regulation apply to schools of nursing Dental for dental nurses and are in addition to the general requirements set out in regulation 9 of these regulations.
 - (2) The matron shall be a registered dental nurse.
- (3) The school shall be constituted under the Hospitals Act, 1927, as a hospital and the average daily availability of dental patients shall be not less than one hundred.
- (4) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators and other resource personnel approved by the Board, in accordance with the syllabus prescribed in Appendix 6 to these regulations.
- (5) The period of education, exclusive of sick leave and leave other than ordinary leave, shall not be less than two years or in the case of a registered general nurse, not less than one year.
- (6) An applicant for admission as a student shall be at least sixteen years of age.
- (1) The provisions of this regulation apply to schools of nursing for child health nurses and are in addition to the general requirements set out in regulation 9 of these regulations.

- (2) The matron shall be a registered nurse in the midwifery and child health divisions.
 - (3) Provision shall be made for-
 - (a) limited residential accommodation for students;
 - (b) accommodation for not less than six mothers and their babies;
 - (c) a sitting and dining room for mothers;
 - (d) at least four cots for artificially fed babies;
 - (e) facilities for examination of mothers and babies, breast care, test feedings, and weighing and measuring babies;
 - (f) bathing and dressing facilities;
 - (g) a properly equipped food dispensary;
 - (h) a lecture and demonstration room;
 - (i) an isolation room:
 - (j) sun verandahs;
 - (k) facilities for practical instruction in office work and keeping of

- (4) Provision shall be made for-
 - (a) students to receive systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators and other resource personnel approved by the Board, in accordance with the syllabus prescribed in Appendix 7 to these regulations;
 - (b) a hospital examination at the end of seventeen weeks; and
 - (c) the issue of certificates to successful students on completion of the prescribed courses to the satisfaction of the matron and the Director of Child Health Services.
- (5) (a) The period of education, exclusive of sick leave and leave other than ordinary leave, for a person who is a registered general and midwifery nurse shall be a period of twenty-six weeks, including nine weeks at approved child health centres.
- (b) A child health centre shall not be approved unless the buildings, equipment, appliances and daily average attendance are acceptable to the Board and the nurse in charge is a registered general, midwifery, and child health nurse who has had adequate experience to enable her to undertake the education of child health nurses.

Nursing aides.

- 17. (1) The provisions of this regulation apply to schools of nursing for nursing aides and are in addition to the general requirements set out in regulation 9 of these regulations.
- (2) In the total clinical field of the school the average availability of patients should not be less than fifty.
- (3) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators or other resource personnel approved by the Board, or both, in accordance with the syllabus pescribed in Appendix 8 to these regulations.
- (4) Exclusive of sick leave and leave other than ordinary leave, the period of education shall not be less than twelve months.
- (5) An applicant for admission as a student shall be at least sixteen and one-half years of age.

Mental Health nursing aides.

- 18. (1) The provisions of this regulation apply to schools of nursing for mental health nursing aides and are in addition to the general requirements set out in regulation 9 of these regulations.
 - (2) The matron shall be a registered mental health nurse.
- (3) In the total clinical field of the school, the average daily availability of patients should be not less than two hundred and fifty and the school shall be able to provide clinical experience in a long stay unit and a short stay unit.
- (4) Provision shall be made for the systematic instruction in theoretical and practical nursing during the period of education by qualified nurse educators or other resource personnel approved by the Board, or both, in accordance with the syllabus prescribed in Appendix 9 to these regulations.
- (5) Exclusive of sick leave other than ordinary leave, the period of education shall not be less than twelve months.
- (6) An applicant for admission as a student shall be at least sixteen and one-half years of age.

PART IV.—ENROLMENT, EDUCATIONAL PROGRAMME, EXAMINATION and REGISTRATION.

Division I.—Enrolment.

Application for admission as a student.

- 19. An application for admission as a student into a school of nursing shall be made in the handwriting of the applicant and signed by her, and the application shall be made to the matron and shall be accompanied by—
 - (a) her certificate or extract of birth;
 - (b) two personal references;

- (c) a certificate as to physical and mental fitness from a legally qualified medical practitioner and from a legally qualified dental practitioner in respect of oral hygiene; and
- (d) evidence satisfactory to the Board of the attainment of the prescribed educational qualification, or such other qualification as the Board deems to be an equivalent or higher qualification.
- 20. Every student nurse shall forthwith on admission to a school of nursing supply the information required of her in the Student Nurses Index Enrolment Form and shall hand the form to the matron of the school of nursing who shall complete the form and forward it to the Board.

Nurses Student Index Enrolment Form.

Educational

quanfications.

- 21. The prescribed educational qualifications are—
 - (a) in respect of an applicant for the general hospital based diploma course—
 - (i) English (Language or Literature): Fourth Year Level;
 - (ii) Mathematics: Not below Elementary Mathematics at Third Year level; (but it is strongly recommended that a Mathematics subject shall be continued until completion of Fourth Year);
 - (iii) Social Science: Fourth Year level in a Social Science subject such as History, Geography or Economics;
 - (iv) Science: Fourth Year level in a Science subject such as Biology, Human Biology, Physics or Chemistry;
 - (v) Elective Subjects: One other subject at Fourth Year level;
 - (b) in respect of an applicant for the midwifery, mental health or dental course—
 - Completion of three years of the Achievement Certificate of the Board of Secondary Education with **credit** passes in two of the following: English (Intermediate), Science (Intermediate), Social Studies (Intermediate) and a pass in the other area at Intermediate level;
 - A pass in Mathematics at the Elementary level is also required but a pass at ordinary level or better may compensate for a lower grade in another core subject.
 - Whilst no elective subjects are specified, students are expected to show a breadth of education in the elective area;
 - (c) in respect of an applicant for the mothercraft, nursing aide or mental health nursing aide course—
 - Completion of two years of the Achievement Certificate of the Board of Secondary Education with credit passes in two of the following: English (Intermediate), Science (Intermediate), Social Studies (Intermediate) and a pass in the other area at Intermediate level.
 - A pass in Mathematics at the Elementary level is also required but a pass at ordinary level or better may compensate for a lower grade in another core subject.
 - Whilst no elective subjects are specified, students are expected to show a breadth of education in the elective area.
- 22. Nurses qualified for registration in one division of the register and who by virtue of this are entitled to a reduced education period for another division of the register, are not required to meet the general educational requirements as stipulated.

Nurses qualified in another division.

Division II.—Educational Programme.

23. (1) Education shall be continuous and any period in excess of ten working days in any year of her education (calculated from the date of commencement of the course) during which a student has broken her education owing to illness or for other reasons satisfactory to the

Broken period of education. Board, shall be made up so that she completes the full period of nursing education required by these regulations.

(2) Where the break in education in any one year exceeds the period of one calendar month, the student shall, in addition to making up the time involved, undergo a further one week's education for each calendar month (or part thereof) of the break.

Leave.

- 24. (1) The maximum amount of continuous sick leave or other leave which a student may be granted without reference to the Board is six calendar months.
- (2) Every application for more than six calendar months' continuous sick leave or other leave in any one year of the course shall be referred to the Board, for its approval or otherwise.

Cessation or transfer of training.

25. Where a student nurse has ceased her education at any one school of nursing, for a reason satisfactory to the Board, the Board may permit her to complete her education in the same or another school of nursing, but in that event the period of education required by these regulations shall be increased by one week's extra training for each calendar month (or part thereof) of the break in education.

Persons coming from outside the State. 26. In the case of a person coming from outside the State, and presenting satisfactory evidence of previous nursing education the Board may allow her to complete education at a school of nursing in this State, under such conditions at it may determine.

Division III.—Examination.

Examina-

- 27. (1) The Board shall hold examinations for students at such times and at such places as the Board determines.
- (2) The examination and assessment of students shall be by way of a written, practical or oral examination; or by any combination of these, as the Board determines.
- (3) Where the examiners, having considered the marks obtained by the student in a written paper, determine that an oral examination is necessary for the purposes of deciding whether that student has failed, passed or passed with credit in any examination conducted by the Board, the Board may require a student to attend before an examiner for an oral examination.
- (4) (a) Where the examiners have a reasonable doubt as to the ability of any candidate to practise nursing without endangering her patients, the Chairman of the Board may require the candidate to attend a special oral examination, at a time and place specified.
- (b) The Board may disqualify any candidate who fails to attend a special oral examination in terms of the Chairman's requirement.

First Professional Examination.

28. For students undergoing a whole period of education as general, mental health or midwifery nurses as required by these regulations the Board shall hold a First Professional Examination at the end of the first year of the course in the subjects for that year.

Alternative method of assessment.

- 29. (1) Notwithstanding the provisions of regulation 28 of these regulations, the Board may exempt a student from the First Professional Examination in any case where—
 - (a) an alternative method of assessment satisfactory to and approved by the Board is undertaken by the school of nursing and is conducted between the ninth and fifteenth months of the course of that student; and
 - (b) all requirements of the Board in relation to the conducting and subsequent appraisals of the hospital assessment are complied with.

but the Board may at any time, upon giving such notice as is reasonably practicable, vary, amend or cancel any approval given under this regulation in respect of any school of nursing.

(2) A candidate who in the opinion of the Board successfully completes an assessment under this regulation may be issued with a certificate.

30. (1) Where a candidate fails to satisfy the examiners at a Board or school of nursing examination, such candidate may be permitted to sit for one, but not more than one, deferred examination in the subject or subjects in which she failed.

Deferred examina-

- (2) A student who fails to comply with subregulation (1) of this regulation shall discontinue that course, but the Board may permit her to commence another approved course of nursing education.
- (3) Notwithstanding anything contained in subregulation (1) of this regulation, where a student fails to pass the First Professional Examination or other Board or school of nursing examination for a second time, the Board may, having regard to the nature of the case, permit her to continue her education and to sit for one further deferred examination.
- 31. Candidates for examinations held under the jurisdiction of the Board shall make application to the Registrar or the Secretary in the form prescribed and shall pay the prescribed fee not later than one month before the date set for the examination.

Application for examina-

32. (1) In order to be eligible to sit for any Board or school of nursing examination, a student shall attend at least two-thirds of the lectures and demonstrations prescribed.

Eligibility for examination.

- (2) A student shall not be eligible to sit for examination for registration until she has completed her nursing education and essential clinical experience and passed all stipulated Board and school of nursing examinations.
- (3) Notwithstanding the provisions of subregulation (2) of this regulation where the end of the student's course falls between two examinations she may sit for the examination to be held on the date nearer to her finishing date, but she shall nevertheless complete her term of education.
- (4) Where a person who is a candidate for an examination for registration produces a certificate of nursing education from an institution outside the State and approved by the Board, and satisfies the Board concerning the reasons and circumstances of her application, the Board may permit the candidate to sit for the examination for registration if the Board is satisfied that her previous nursing education is equal in all respects to that required in this State.
- 33. (1) A candidate who fails to pass the examination for registration shall, unless exempted therefrom by the Board, sit for the next following similar examination, and if she also fails to pass that next following examination, the Board may require her to undergo additional education for such time not exceeding twenty-five per centum of the period prescribed for the education of that candidate as the Board approves before she again presents herself, upon payment of the prescribed fee, as a candidate for an examination for registration, in which case such examination shall be that next following the completion of further education so approved.

Examination failure.

- (2) A school of nursing may make application within fourteen days of the release of results, to the Board for, and on payment of the prescribed fee, obtain on behalf of a candidate from the school who has failed an examination, a comprehensive report from the appropriate examiner of the written examination paper submitted by such candidate at an examination.
- (3) Any examiner who submits a report to the Board under subregulation (2) of this regulation shall be paid by the Board such fee as the Board determines.
- 34. Any communication which schools of nursing or candidates may desire to make on the subject of the examinations, shall be made to the Board and not to the examiners, and should any such communication be addressed to the examiners it shall not be dealt with by them but shall be referred to the Board.

Communications on examina-

Division IV.—Registration.

- 35. (1) Every nurse, nursing aide and mental health nursing aide who applies for registration under the provisions of section 20 of the Act shall—
 - (a) make application to the Board in writing on the prescribed form. duly completed and signed by her;

Application for registration.

- (b) complete, sign and make the statutory declaration endorsed on or attached to that form; and
- (c) lodge with the Board the documents, duly completed and signed, which by this regulation she is required to complete and sign.
- (2) In the case of a nursing aide, subject to subregulation (4) of this regulation, an applicant shall not be qualified for registration unless—
 - (a) being a student, she has passed the examination for registration, and has otherwise complied with the requirements of these regulations; or
 - (b) not being a student, she has-
 - (i) passed the General First Year Professional Examination of the Board, or completed an assessment under regulation 29 of these regulations, and has completed not less than twelve months' education in a general school of nursing;
 - (ii) completed not less than twelve months' education in a general school of nursing and has passed the examination for registration;
 - (iii) completed twelve months' education in mental health nursing and has passed the First Year Examination thereof and has subsequently undertaken a further six months' education within a general or nursing aide school of nursing and successfully passed the Board's General Nursing Aide Registration Examination.
- (3) In the case of a mental health nursing aide, subject to subregulation (4) of this regulation, an applicant shall not be qualified for registration unless—
 - (a) being a student, she has passed the examination for registration, and has otherwise complied with the requirements of these regulations; or
 - (b) not being a student, she has—
 - (i) passed the Mental Health First Year Professional Examination of the Board, or completed an assessment under regulation 29 of these regulations, and has completed not less than twelve months' education in a mental health school of nursing;
 - (ii) completed not less than twelve months' education in a mental health school of nursing and has passed the examination for registration;
 - (iii) completed twelve months' education in general nursing and has passed the First Year Examination thereof and has subsequently undertaken a further six months' education within a mental health or a mental health nursing aide school of nursing and successfully passed the Board's Mental Health Nursing Aide Registration Examination.
- (4) Subject to subregulation (5) of this regulation a person who is qualified for registration as a nursing aide or a mental health nursing aide pursuant to subregulation (2) or subregulation (3) of this regulation shall not be registered unless and until she has, after becoming so qualified, undertaken and completed a period of supervised experience for not less than six months at an approved institution and has received and lodged with the Board a report in the approved form in respect of her service and conduct at that institution that is satisfactory to the Board.
- (5) The following persons shall be excused the six month period of supervised practice referred to in subregulation (4) of this regulation—
 - (a) a registered general nursing aide who has completed not less than twelve months' education in a mental health nursing aide school of nursing and has passed the examination for registration;
 - (b) a registered mental health nursing aide who has completed not less than twelve months' education in a general nursing aide school of nursing and has passed the examination for registration.

36. For the purposes of subregulation (4) of regulation 35 of these regulations an institution may be approved as affording supervised experience if it fulfils, and continues to fulfil, the following conditions-

Institution approved as providing supervised experience.

- (a) an average daily bed occupancy of twelve or above;
- (b) at least five registered nurses employed full-time to give an around-the-clock cover for supervision;
- (c) there is a suitable person on the permanent staff who will accept the responsibility for counselling and evaluating the aides at the end of the first, third and sixth months;
- it provides areas of experience acceptable to the Board, including medicine, surgery, geriatric, maternity, psychiatry or paediatric nursing; and
- (e) there are suitable residential facilities if required.
- 37. A person not otherwise provided for under section 20 of the Act Applicants who produces evidence satisfactory to the Board of having been educated from outas a nurse in any part of the world other than in this State, and who has undergone to the satisfaction of the Board such further education (if any) and passed such examinations (if any) as the Board directed, shall be entitled to registration on payment of the required fee.

from out side this State.

38. Every nurse registered by the Board shall receive a Certificate of Registration in the Form No. 6, Form No. 7, or Form No. 8 in Appendix 1 to these regulations, as the case may require, and her name shall be entered in the register.

Certificate

The badge appearing in this regulation is prescribed for the use of a person who is registered in the division of general nurses. The prescribed badge for all other divisions of nursing is of a similar design but with the appropriate division of nursing shown on the badge.



40. A copy of a Certificate of Registration, or a duplicate badge, may be issued if it is proved to the satisfaction of the Board that the original certificate or the original badge as the case may be has been lost or accidently destroyed; and upon payment of the required fee.

Duplicate certificates and badges.

- 41. Particulars of any honour conferred on a registered nurse by a reigning sovereign or head of state shall, upon application by the nurse, be inserted in the register without payment of a fee.
 - Registration of Honours.
- 42. Any nurse who has a certificate for a post basic course approved for recognition by the Board, shall on application have this qualification endorsed on her registration certificate, and in the register, without payment of a fee.

Post basic certificates.

43. An application for the renewal of a Certificate of Registration shall Renewal be made in the Form No. 11 in Appendix 1 to these regulations.

Upon application to the Board in the Form No. 10 or Form No. 11 in Appendix 1 to these regulations, as appropriate, by a person whose name has been removed under section 28 or section 32 of the Act, the Board may restore to the register the name which has been removed.

Restoration to register

Where a nurse has not practised for a period exceeding five years the Board may, before registering her as a nurse, require the nurse to undertake an approved refresher course for non-practising nurses or to submit a report to the satisfaction of the Board after a period of re-orientation in an approved hospital.

Require-Refresher

PART V.—APPEALS FROM DECISIONS OF THE BOARD.

Appeal.

- 46. (1) Appeals pursuant to section 33 of the Act from decisions of the Board shall be brought by notice in writing signed by the person aggrieved.
- (2) The notice shall set out the substance of the decision complained of and the date of the decision and also fully state the ground on which the appeal is brought; and an address for service shall be given at which notices and documents relating to the appeal may be delivered or given to the appellant.
- (3) The appeal shall be entered by the appellant in the office of the Local Court at Perth and the notice of appeal shall be filed therewith within three months after the date of the Board's decision appealed against.
- (4) Notice of such entry shall be given to the Board by the appellant within two days after entry and a copy of the notice of appeal shall be delivered therewith.
- (5) The appeal shall come on for hearing on such day as the Magistrate of the Local Court appoints, such day to be not less than seven days after entry, and notice thereof shall be sent to the appellant at the appointed address for service, and to the Board.
- (6) Either party may, without further or special order, adduce evidence on affidavit to be filed at least two clear days before the hearing.
- (7) The appeal may be determined on the material before the Board when giving its decision, which may be ascertained in such manner as the Magistrate thinks proper, or on fresh evidence either oral or by affidavit, or partly in one way and partly in another, and the Magistrate may rehear the testimony of any witness whether by way of examination or cross-examination, and any party concerned may be represented by counsel.
- (8) The result of the appeal shall be embodied in a formal order and a minute thereof shall be entered by the Board in its register.

PART VI.—PENALTIES, FEES AND REMUNERATION.

Penalty.

47. A person who fails to comply with the provisions of these regulations commits an offence.

Penalty: Fifty dollars.
