1. In these regulations the regulations made under the provi- Principal sions of the Abattoirs Act, 1909, published in the Government regulations. Gazette on the 14th April, 1938 and as amended thereafter from time to time by notices so published are referred to as the principal regulations. regulations.

- 2. The principal regulations are amended by substituting for Reg. 19 regulation 19 the following regulation— $\,$
