WHEREAS by section 31 of the Land Act, 1933-1972, the Governor may by Proclamation and subject to such conditions as may be expressed therein, classify as of Class A any lands of the Crown reserved to Her Majesty for any of the purposes specified in the said section; and whereas it is deemed expedient that Reserve No. 29457 for the purpose of "Protection of Meteorite Crater" as described hereunder, should be classified as of Class A: Now, therefore I, the Governor with the advice of Executive Council do by this my Proclamation classify as of Class A the reserve described hereunder.

ORDER IN COUNCIL

WHEREAS section 74 of the Constitution Act, 1889–1970, provides, *inter alia*, that the Governor in Council may vest in heads of departments, or other officers or persons within that State power to make minor appointments to public offices under the Government of the State : Now therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council hereby vests in Kenelm Nordon Wingfield Digby, Administration Officer, Public Works Department and in any person temporarily appointed to perform the normal duties of the said Kenelm Nordon Wingfield Digby during his absence or incapacity, the power to make appointments in respect of the Department specified in Column 1 of the Schedule hereto, of employees in the categories specified respectively in Column 2 of the Schedule hereto in relation to that Department, on such terms and conditions as are contained from time to time in the Awards and/or Agreements specified respectively in Column 3 of the Schedule hereto in relation to those categories of employees

Notice to all Owners and/or Occupiers of Land in the Shire of Goomalling.

PURSUANT to the powers contained in section 33 of the above Act, you are hereby required on or before the 31st day of October, 1976, to remove from the land owned or occupied by you all inflammable materials or to clear firebreaks in

If it is considered to be impractical for any reason to clear firebreaks or to remove inflammable material from the land as required by this notice you may apply to the Council or its duly authorised officer not later than the 15th day of October, 1976, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

"Inflammable material" is defined for the purpose of this notice to include bush, timber, boxes, cartons, paper and like inflammable materials, rubbish and also any combustible matter, but does not include green standing trees or growing bushes and plants in gardens and lawns.

- (c) Clear firebreaks not less than two metres wide around and within one hundred metres of all buildings, haystacks and fuel ramps.
