- (i) the registration of a foreign company incorporated under a law of a State or Territory of the Commonwealth which corresponds to the said Act by such a name if he is satisfied that the Minister administering that corresponding law has consented to the registration of the foreign company by that name in that State or Territory and he is not of the opinion that the name of the foreign company is otherwise undesirable or
- (ii) the reservation of a name of a recognized company, an intended recognized company or the name to which a recognized company proposes to change its name if the Minister administering a declared law of a participating State being the place of incorporation or intended incorporation or place in which the recognized company has been incorporated and proposes to change its name has consented to the registration of that recognized company or intended recognized company by that name in that participating State and the Commissioner is of the opinion that the name of the recognized company or intended recognized company is not otherwise undesirable.
- 1. Names suggesting connection with members of the Royal Family or Royal patronage, for example, names which include the words "Royal", "King"; "Queen", or "Crown".
- 2. Names suggesting connection with the Crown, the Commonwealth of Nations, the Government of the Commonwealth of Australia or of a State or of any other part of the Queen's dominions, possessions, or territories, for example, names which include the words "Commonwealth", "Federal", "State", "Empire", "Imperial", or "National".
- 3. Names suggesting connection with the government of a foreign country or with the United Nations.
- 4. Names suggesting connection with a government department, authority or instrumentality or a municipal or other local authority.

5. Names containing the following words or any

words of like import: "Bank", "Banker", "Banking", "Building Society", "Chamber of Commerce", "Chamber of Manufacturers", "Chartered", "College of Advanced Education", "College of Advanced Technology", "College of Teacher Education", "Consumer", "Co-operative", "Co-operative Housing Society", "Credit Union", "Dianetics", "Executor", "Friendly Society", "Guarantee", "Institute of Advanced Education", "Institute of Advanced Technology", "Institute of Teacher Education", "Made in Australia", "Oxfam", "Savings", "Scientology", "Starr Bowkett", "Stock Exchange", "Trust", "Trustee", "Uni-versity".

- 6. Names suggesting connection with ex-service-men's organisations or that its members are totally or partially incapacitated, for example, names which include the words "Anzac", "Ex-servicemen", "Returned Soldier", "Blind" or "Blinded".
- 7. Names that are misleading as to the nature, objects or purposes of the company or in any other manner.
- 8. Names that are blasphemous or likely to be offensive to members of the public.
- 9. Names that are likely to be confused with or mistaken for-
  - (a) the name of a company, recognised company to which Division 2A of Part XI of the Companies Act, 1961-1975 applies, registered foreign company, association, building society, co-operative society, co-operative housing society, credit union, or friendly sochousing iety; or
  - (b) a registered business name.
- 10. Names that are likely to be confused with or mistaken for the name reserved by or on behalf inistaken for the name reserved by or on behalf of a company, a recognized company, a foreign company to which Division 3 of Part XI of the Companies Act, 1961 applies, an intended company, intended recognized company or a company which it is proposed to register as a foreign company.
- 11. In the case of an intended company which intends to carry on business in a participating State, a name that would not be available under a provision of the declared law of that State corresponding to section 22 of the Companies Act, 1961.

  - (c) All Properties exceeding 2 025 hectares: Where the total area of a property exceeds 2 025 hectares additional firebreaks of not less than 3 metres in width must be provided in such positions as to divide the property into areas not exceeding 2 025 hectares, each area being completely surrounded by a firebreak.
  - (d) Where the bush on land owned or occupied by you has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether you intend to burn the bush or not) you shall forthwith clear a firebreak not less than 20 metres wide immediately inside the external boundaries of land on which bulldozed, chained or otherwise prepared bush is situated.

2. Townsite Land: Clear of all infiammable materials, firebreaks at least 2 metres wide immediately inside all external boundaries of the land and also immediately surrounding all buildings and/or haystacks or groups of buildings and/or haystacks situated on the land.

3. Bulk or Drum Fuel Storage Sites: All bulk or drum Fuel Storage sites to be totally cleared of inflammable materials for a minimum distance of 6 metres around the storage site.

4. No Firebreaks will be permitted on any Road or other Reserves.

Note: Council will consider approval of other than perimeter firebreaks where a more suitable alternative can be provided. Approval to such alternatives will only be considered if submitted with the endorsement of the Bush Fire Brigade for the area concerned and will be on a yearly basis.

  - (1) Where there are no openings in the walls of the dwelling-NIL.
  - (2) where there are no major open-ings\*\* to habitable rooms-1.0 metres.




