Metropolitan Water Supply.

ORDER IN COUNCIL.

M.W.B. 605351/76.

WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909-1975, it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Shire of Wanneroo—Mirrabooka.

Mirrabooka Reservoir Chlorination House.

The construction of a brick building approximately one hundred and thirty four square metres in area and the installation of chlorination equipment and all necessary apparatus, and shown on plan M.W.B. 13772.

This Order in Council shall take effect from the 22nd day of October, 1976.

WHEREAS by the Metropolitan Water Supply, Sewerage, and Drainage Act, 1909-1975, it is provided that, subject to the provisions of the Act, the Metropolitan Water Supply, Sewerage and Drainage Board shall, with the approval of the Governor, have power to construct provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with and plans sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, does hereby empower the Metropolitan Water Supply, Sewerage and Drainage Board to undertake the construction of the following works under the said Act, namely:—

Shire of Wanneroo.

460 mm and 305 mm Feeder Main in Marmion Avenue and Mullaloo Drive-Mullaloo-Pinnaroo.

The Construction of—

- (a) A three hundred and five millimetre diameter water main approximately fifty metres in length.
- (b) A four hundred and sixty millimetre diameter water main approximately one thousand five hundred and seventy metres in length.

The above works will be complete with valves and all other necessary apparatus, and shown on plan M.W.B. 13594.

This Order in Council shall take effect from the 22nd day of October, 1976.

PROCLAMATION

WESTERN AUSTRALIA, ] By His Excellency Air Chief Marshal Sir Wallace  
To Wit: ] Kyle, Knight Grand Cross of the Most Honourable  
WALLACE KYLE, Order of the Bath, Commander of the Most  
Governor. Excellent Order of the British Empire, Companion  
[L.S.] of the Distinguished Service Order, Distinguished  
Flying Cross, Knight of Grace of the Most  
Venerable Order of the Hospital of St. John of  
Jerusalem, Governor in and over the State of  
Western Australia and Its Dependencies in the  
Commonwealth of Australia.

WHEREAS it is enacted by subsection (1) of section 46 of the Supreme Court Act, 1935-1976, that the Governor may by proclamation declare that such places in Western Australia as he thinks fit are circuit towns; and whereas it is enacted by subsection (2) of section 10 of the Juries Act, 1957-1976, that the jury district for the Supreme Court and for each Circuit Court, shall consist of such Assembly District or Districts or such part or parts of such Assembly District or Districts, as the Governor determines and declares, and is thereby authorized to determine and declare by proclamation from time to time; and whereas it is enacted by subsection (3) of section 10 of the Juries Act, 1957-1976 that where a circuit town is declared after the coming into operation of that Act pursuant to the power conferred by section 46 of the Supreme Court Act, 1935 or any other Act for the time being in operation, the Governor may by the proclamation declaring the circuit town, or by subsequent proclamation, declare what Assembly District or Districts or part or parts of an Assembly District or Districts, shall constitute the jury district for the Circuit Court of the circuit town so proclaimed: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, do hereby—

- (a) determine and declare that the jury district for the Supreme Court shall consist of the Assembly Districts specified in the second column of the First Schedule to this proclamation;
- (b) assign to the jury district specified in the second column of the First Schedule the name specified in the third column of that Schedule;
- (c) declare that such places in Western Australia as are specified in the first column of the Second Schedule to this proclamation are circuit towns;
- (d) determine and declare the jury district for a Circuit Court of a circuit town specified in the first column of the Second Schedule to this proclamation shall constitute the Assembly District or Districts or part or parts of the Assembly District or Districts specified opposite and corresponding to that circuit town in the second column of that Schedule;
- (e) assign to a jury district specified in the second column of the Second Schedule the name specified opposite and corresponding to that jury district in the third column of that Schedule.

##### Shire of Manjimup.

##### Notice to Owners and/or Occupiers of Land.

PURSUANT to the powers contained in section 33 of the above Act all owners and occupiers of land in the Shire of Manjimup are hereby required on or before the 1st day of December, 1976, to clear firebreaks or remove all inflammable material from the land owned and/or occupied by them and thereafter to maintain such firebreaks clear of all inflammable material until the 15th day of April, 1977, with the following requirements.

##### 1. Rural Lands: Firebreaks of not less than two (2) metres wide in the following positions:—

- (i) Inside and along boundaries of all pastures or grass lands.
- (ii) Inside and along the common boundaries of all land where this land abuts public roads on which there is a road formation.
- (iii) On all land not less than two (2) metres in width and within a minimum of twenty (20) metres and parallel to any boundary of a Railway Reserve and Timber Tramway Reserve.

Firebreaks in the situation described hereunder be accepted as complying with requirements of this notice, so far as it applies to the common boundary between the land of an owner or occupier, and the abutting land referred to hereunder:—

- (a) Where the land of an owner or occupier abuts on a public road and the owner or occupier has burned or cleared to the satisfaction of the Inspecting Officer, the bush between the road formation and the common boundary.
- (b) Where the land of an owner or occupier abuts on Crown Land or Reserve, the owner or occupier has cleared a firebreak not less than two (2) metres wide, on the Crown Land or Reserve along the common boundary.

##### 2. Townsite Lands:

- (i) Townsite lots having an area of not more than 2 024 square metres shall be completely cleared of all material of an inflammable nature and maintained free of such material.
- (ii) On townsite lots having an area of more than 2 024 square metres, firebreaks not less than two (2) metres wide shall be provided and maintained inside and along the boundaries of the lots. Where several adjoining lots are held or used by the owner and/or occupier the firebreaks may be provided inside and along the external boundaries of the group or lots.

##### 3. Rural and Townsite Lands:

- (i) Firebreaks of not less than three (3) metres wide must be provided immediately surrounding all buildings, haystacks, fuel depots, drum ramps and drums both full and empty.

If, for any reason, it is considered impracticable to comply with any provision of this notice, a written application for a variation may be made to the Shire Council and must reach the Shire Clerk before the 22nd day of November, 1976.

Any such application must bear the signature of the Fire Control Officer of the area signifying his agreement to the variation. If permission for variation is not granted the terms of the notice must be complied with.

The penalty for failure to comply with this notice is a fine of not less than \$10.00 nor more than \$200 in addition to which the Council may have the works carried out and may recover the costs to of such work from the owner and/or the occupier. The Shire Council will accept constructed firebreaks along road verges.

4. By adding a new Clause under Part IV after Clause 45 as follows: 45.1 Special Rural Zone: The following provisions shall apply specifically to all land included in the Special Rural Zone in addition to any provisions which are more generally applicable to such land under this Scheme—

- (a) The objective of the Special Rural Zone is to select areas within the rural areas wherein closer subdivision will be permitted to provide for such uses as hobby farms, horse breeding, rural-residential retreats, intensive agriculture including market gardens and viticulture, and also to make provision for retention of the rural landscape and amenity in a manner consistent with the orderly and proper planning of such areas.
- (b) The provisions for controlling subdivision land uses and development etc. relating to specific Special Rural Zones will be as laid down in the Schedule (Appendix E) to the Scheme and future subdivision will accord with the Plan of Subdivision for the specified area referred to in the Schedule and such Plan of Subdivision shall form part of the Scheme.

- (iii) A plan or plans showing contours at such intervals as to adequately show the land form of the area and physical features such as existing buildings, rock outcrops, trees or groups of trees, lakes, creeks, swamps, orchards, wells etc.
- (iv) Information regarding the method whereby it is proposed to provide a potable water supply to each lot.
- (c) The Scheme provisions for a specific Special Rural Zone shall include a Plan of Subdivision showing:
  - (i) The proposed ultimate subdivision including lot sizes and dimensions.

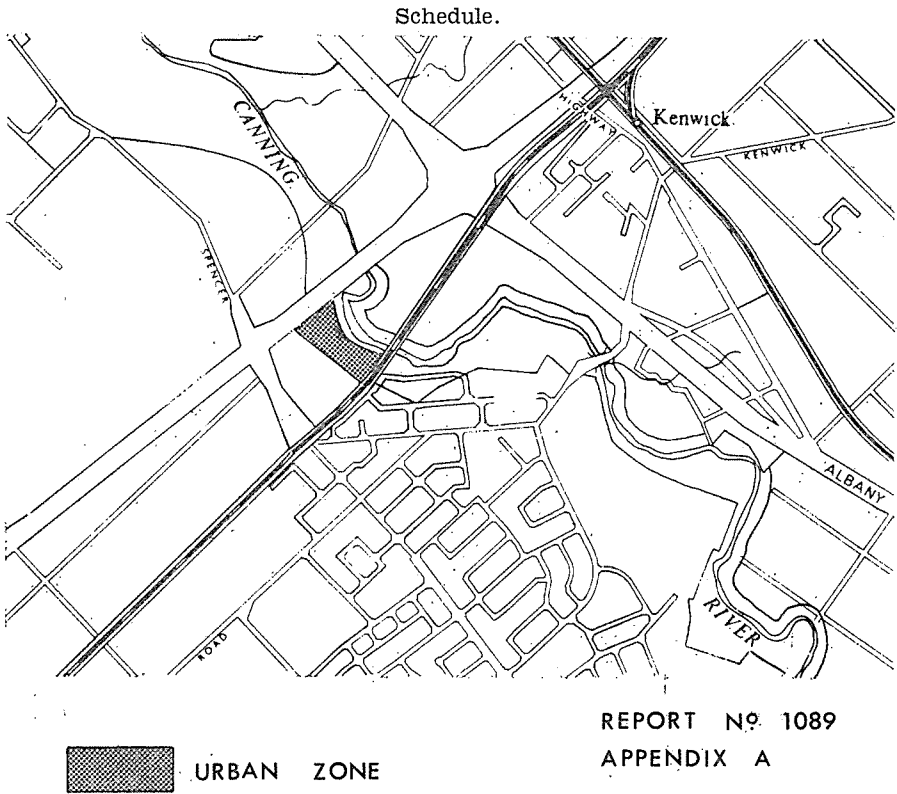
