WHEREAS the Conservator of Forests has given notice in writing to the Minister of the Crown for the time being administering the Forests Act, 1918-1976, that he considers that earth, soil or trees in the areas of public land specified in the Schedule to this proclamation may be, or may become, infected with the forest disease known as jarrah dieback (Phytophthora cinnamomi); and whereas that Minister, after consultation thereon with the Minister of the Crown for the time being administering the Mining Act, 1904–1973, has recommended to me, the Governor, that the areas be constituted forest disease risk area: the areas be constituted forest disease risk area: Now, therefore, I the Governor acting pursuant to the powers conferred by section 40D of the Forests Act, 1918-1976, and with the advice and consent

of the Executive Council, hereby constitute the areas of public land specified in the Schedule to this proclamation forest disease risk areas to be know as Jarrah Dieback Risk Areas Nos. 2.1, 2.2, 2.3, 2.4 and 2.5 respectively.

Jandakot Groundwater Scheme—Located within: Town of Canning, Town of Cockburn and Shire of Armadale-Kelmscott.

Description of Proposed Works:

The construction of a groundwater scheme at Jandakot with a designed daily output of 45 000 cubic metres. The pumping of water from the wells and output of water from the Treatment Plant will not be continuous, but will be regulated having regard to requirements for sound management of the aquifer. Works to be constructed will consist of:—

- 1. Raw water rising mains to connect a well-field to the Treatment Works. The mains will be underground and constructed of steel or asbestos cement pipes. Where the pipelines traverse private property a 10 metre easement will be taken out over the route. An access road and overhead power lines will be constructed within the easement. The nominal diameter and lengths of the rising mains are:—
 - 1.1 A rising main, 600 mm and 800 mm in diameter about 4 600 metres in length.
 - 1.2 A rising main, 200 mm, 225 mm, 375 mm, 450 mm and 525 mm in diameter about 6 630 metres in length.
 - 1.3 A rising main 200 mm, 225 mm. 250 mm, 300 mm and 375 mm in diameter about 3 850 metres in length.
 - 1.4 A rising main 200 mm, 225 mm, 300 mm, 375 mm, 450 mm and 525 mm in diameter about 7 080 metres in length.
 - 1.5 A rising main 200 mm, 225 mm, 250 mm, 375 mm and 450 mm in diameter about 3 860 metres in length.
- 2. Thirty shallow groundwater wells and four shallow artesian wells will be sunk in the area.

The shallow groundwater wells will be cased with 280 mm nominal outside diameter steel casing, equipped with stainless steel screens, and will range in depth between 35 and 75 metres. The maximum daily output from each well is anticipated to range between 400 and 2000 cubic metres per day.

The shallow artesian wells will be cased with 340 mm and 240 mm nominal outside diameter steel casing, equipped with stainless steel screens, and will range in depth between 250 and 500 metres.

The maximum daily output from each well is anticipated to range between 2 000 and 10 000 cubic metres per day.

The thirty shallow groundwater wells will be numbered 10, 20, 30, 40, 50, 60, 70, 80, 90, 100, 110, 120, 130, 140, 150, 210 220, 230, 240, 250, 260, 270, 280, 290, 300, 310, 330, 340 and 350 and the four shallow artesian wells will be numbered 45, 105, 335 and 405.

Apart from Well 405 to be located at the Treatment Works site, the sites for the wells will vary in area from 1600 to 4500 square metres. All sites will be purchased by the Board, and provided with a stock proof perimeter fence and an inner security fence around the wellhead installation. The wellhead installation will comprise of pump, motor, switchboard, a section of above and below ground steel pipeline and ancillary valves and fittings. A brick building of approximately 20 square metres will be constructed on each of the shallow artesian well sites to house electrical equipment.

- 3. The Groundwater Treatment Works will comprise of aerators, clarifiers, filters, clearwater tank, pumping station operation building and associated works. These structures will be constructed principally in concrete, brick or steel, and will contain the necessary mechanical and electrical plant.
- 4. A clearwater Rising Main to deliver water from the Treatment Works to the Water Supply System. The main will be laid below ground in steel pipe of nominal diameter 800 mm, and will be about 900 metres in length.
- 5. The mains are to be complete with air valves and section valves in underground pits and all other necessary apparatus connected therewith.
- 6. The above works shall be constructed as described herewith and in accordance with Plan M.W.B. 15026.

The Localities in which the Proposed Works will be Constructed or Provided:



LOCAL GOVERNMENT (LONG SERVICE LEAVE) REGULATIONS.

Citation.

1. These regulations may be cited as the Local Government (Long Service Leave) Regulations.

Definitions.

Transitional and saving provisions.

- 2. In these regulations-
- "Commission in Court Session" and "Registrar" have the respective meanings given to those expressions in the Industrial Arbitration Act, 1912;
- "effective date" has the meaning given to that expression in section 161 of the Act, that is to say, the date on which these regulations take effect;
- "employer" means the municipality by which a worker is employed or, in the case of the joint employment of a worker by two or more municipalities, those municipalities;
- "long service benefit" means long service leave with pay or a lump sum payment in lieu of long service leave or in lieu or on account of pro rata long service leave;
- "Minister" means the Minister for Local Government;
- "municipality" means a municipality constituted under the Act or a county council or regional council constituted under section 329 of the Act;
- "national service" means service under the National Service Act, 1951 of the Parliament of the Commonwealth as amended or under any Act passed in substitution for that Act;

"regulation" means one of these regulations;

"subregulation" means a subregulation of the regulation in which the term is used;

"superseded long service benefits scheme" means-

- (a) the Long Service Leave Act, 1958;
- (b) by-laws made pursuant to section 230 of the Act as enacted before the effective date; or
- (c) the provisions relating to long service benefits in an industrial award or agreement in force under the Industrial Arbitration Act, 1912;

"the Act" means the Local Government Act, 1960;

- "the Board" means the Board of Reference constituted under regulation 12;
- "worker" means an officer or employee employed by a municipality.
- 3. (1) Subject to subregulation (4) where a worker has become entitled to a long service benefit under a superseded long service benefits scheme and has not been granted that benefit before the effective date he shall retain his entitlement to that benefit on and after the effective date.
 - (2) Notwithstanding anything contained in these regulations-
 - (a) where a worker was in the service of an employer on the 1st July, 1977 and by-laws in force immediately before the effective date, being by-laws made by the employer pursuant to section 230 of the Act as enacted before the effective date, provided for entitlements to long service leave after periods of continuous service of less than ten years, the worker shall continue to become entitled to such long service leave after such periods of continuous service as were, respectively, prescribed in those by-laws until his service with that employer terminates;

SCHEDULE—continued.

- (b) where a worker who was in the service of an employer on the 1st July, 1977 leaves that service and that worker—
 - (i) does not enter service that is regarded, for the purposes of these regulations, as continuous with his service with that employer;
 - (ii) would, under the provisions of by-laws in force immediately before the effective date, being by-laws made by that employer pursuant to section 230 of the Act as enacted before the effective date, have been entitled to a payment on account of pro rata long service leave; and
 - (iii) is not entitled to a payment in lieu of pro rata long service leave under regulation 6 or is entitled to such a benefit on terms less favourable than those that would have applied to him under the by-laws mentioned in subparagraph (ii) of this paragraph,

that worker shall, on the termination of that service, be entitled to a payment on account of *pro rata* long service leave in accordance with the by-laws mentioned in subparagraph (ii) of this paragraph.

- (3) Where a worker commences a period of long service leave to which he is entitled by reason of subregulation (1) or paragraph (a) of subregulation (2) he shall be entitled to be paid for that leave in accordance with the relevant superseded long service benefits scheme.
- (4) Where a worker is entitled to long service leave by reason of subregulation (1) or paragraph (a) of subregulation (2) and his service with an employer is terminated before he has taken or fully taken that leave his entitlement to that leave shall cease but he shall be entitled, on account thereof, to a payment in accordance with the relevant superseded long service benefits scheme.

Service.

- 4. In determining the entitlement of a worker to long service benefits under these regulations the service that shall be taken into account is—
 - (a) in every case—continuous service with one or more employers after the 30th June, 1977; and
 - (b) in the case of the worker who was in the service of an employer on the 1st July, 1977—continuous service with that employer between the 1st July, 1967 and the 30th June, 1977 (both dates inclusive),

and that service shall be deemed to include-

- (c) any period of absence from duty on any annual leave or long service leave;
- (d) any period of absence from duty necessitated by sickness of or injury to the worker but only to the extent of three months in each calendar year; and
- (e) any period during which the service of the worker was or is interrupted by national service but only if the worker as soon as reasonably practicable after the completion of that national service resumed or resumes his service with his former employer or entered or enters the service of another employer,

but shall not include-

- (f) any absence from duty on leave without pay unless the employer determines otherwise; or
- (g) service in respect of which the worker has become entitled to a long service benefit before the effective date under the provisions of a superseded long service benefits scheme.

Continuity of service.

- 5. For the purpose of determining the entitlement of a worker to long service benefits under these regulations the service of a worker shall be regarded as continuous notwithstanding—
 - (a) any absence of the worker from duty if leave of absence has been granted by his employer;
 - (b) the absence of the worker on account of national service if by operation of regulation 4 the period of absence is deemed to be included in the service of the worker for the purposes of these regulations;
 - (c) there being a period of time between the worker leaving the service of one employer and entering the service of another employer if the period is used for recreation leave or as travelling time and does not exceed—
 - (i) the period in respect of which payment has been made by the first-mentioned employer in lieu of the worker's accrued and pro rata leave entitlements; or
 - (ii) two weeks,

whichever is the longer.

SCHEDULE—continued.

Entitlement to leave.

- 6. (1) The long service benefits to which a worker shall be entitled by reason of continuous service with one or more employers shall be as provided in this regulation.
- (2) Subject to subregulation (5) a worker is entitled to thirteen weeks long service leave in respect of each ten years' continuous service that he completes.
- (3) Where the service of a worker who has previously become entitled to long service leave under subregulation (2) is terminated in any circumstances otherwise than by his employer for serious misconduct, and the worker does not within the time specified in subparagraph (i) or (ii) of paragraph (c) of regulation 5, whichever is the longer, enter the service of another employer the worker shall be entitled to a payment calculated under subregulation (1) of regulation 8 in lieu of an amount of pro rata long service leave on the basis of one and three-tenths weeks leave for each year of continuous service that he has completed since he last became entitled under subregulation (2) to an amount of long service leave, and, for the purpose of calculating that payment, the worker shall be deemed to have commenced that leave immediately prior to the termination of his service.
- (4) Where the service of a worker who has completed at least seven years continuous service but has not previously become entitled to long service leave under subregulation (2) is terminated—
 - (a) by his death:
 - (b) on account of sickness or injury of such a nature as to prevent him from continuing his present employment; or
 - (c) by his retirement on account of his having reached the age of sixty-five years or on such later date as his employer may approve,

the worker shall be entitled to a payment calculated under subregulation (1) of regulation 8 in lieu of an amount of *pro-rata* long service leave on the basis of one and three-tenths weeks leave for each year of continuous service that he has completed and, for the purpose of calculating that payment, the worker shall be deemed to have commenced that leave immediately prior to the termination of his service.

(5) Where a worker is entitled to long service leave by reason of subregulation (2) and his service with an employer is terminated before he has taken or fully taken that leave his entitlement to that leave shall cease but he shall be entitled, in lieu thereof, to a payment calculated in accordance with subregulation (1) or (2) of regulation 8, whichever is applicable.

Taking leave

- 7. (1) Where a worker is entitled to long service leave—
 - (a) at least two months' notice of the date from which the leave is to be taken shall be given by one party to the other unless otherwise agreed in writing between the parties;
 - (b) the employer shall not require the worker to commence the leave within six months of the date on which the worker became entitled to it;
 - (c) the leave taken shall be inclusive of any public holidays allowable under the worker's conditions of employment but shall not be inclusive of any annual leave;
 - (d) the leave may be granted and taken in one consecutive period or, if the worker and the employer so agree, in not more than three separate periods.
- (2) Subject to subregulation (1) long service leave shall be taken at the earliest practicable date.

Payment for or in lieu of leave.

- 8. (1) Subject to subregulation (2) a worker who commences or is deemed to commence a period of long service leave or pro rata long service leave under regulation 6 shall be entitled to be paid for each week of that period at the ordinary time rate applicable to his usual classification (excluding all allowances) in the week immediately preceding the commencement or deemed commencement of the leave.
- (2) Where the commencement of long service leave under regulation 6 has been postponed to meet the convenience of the worker beyond the period of six months mentioned in paragraph (b) of subregulation (1) of regulation 7 the rate of payment for or in lieu of that leave shall be the rate applicable to him for ordinary time (excluding all allowances) when he became entitled to the leave unless otherwise agreed in writing between the employer and the worker.
- (3) A payment for long service leave shall be made by the employer in full before the worker commences the leave or, where the employer and the worker jointly agree, by periodical payment.
- (4) In any case to which paragraph (b) of subregulation (2) or subregulation (4) of regulation 3 or subregulation (3), (4) or (5)

SCHEDULE-continued.

of regulation 6 applies the payment to which the worker is entitled in lieu or on account of long service leave or *pro rata* long service leave, as the case may be, shall be paid by the employer—

- (a) upon termination of the service of the worker otherwise than by death—to the worker; or
- (b) upon termination of the service of the worker by death to the personal representative of the worker upon request by the personal representative.

Contribution towards cost of benefit.

ⁿ 9. (1) In this regulation "cost", in relation to a long service benefit, means—

- (a) in the case of leave granted to and taken by a worker the total amount paid by the employer pursuant to subregulation (3) of regulation 8;
- (b) in a case in which a payment is made by the employer under subregulation (4) of regulation 8 in lieu or on account of long service leave or pro rata long service leave—the amount of that payment.
- (2) Where a long service benefit is granted and taken by or in respect of a worker and the service in respect of which the benefit accrued includes, in addition to service with the municipality with which he is serving at the time of, or immediately before, the benefit is taken, a period of service with one or more other municipalities, the council of the first-mentioned municipality shall bear the cost of the benefit but may, in respect of that period of service, recover from the council of each such other municipality a contribution towards the cost determined in accordance with subregulation (3).
- (3) The contribution towards any cost of a long service benefit that may be recovered from the council of a municipality pursuant to subregulation (2), in respect of a period of service with that municipality shall be determined in accordance with the formula—

$$C = \frac{(L \times S \times P)}{TS}$$

where-

- C is the amount of the contribution that may be recovered from that council;
- L is the amount of long service leave or *pro rata* long service leave for or in lieu of which the cost is paid (expressed in weeks);
- S is that period of service (expressed in completed weeks);
- P is the weekly rate of pay for ordinary time applicable to the usual classification of the worker (excluding all allowances) in the week immediately preceding the end of that period of service; and
- TS is the total period of service in respect of which the long service benefit accrued (expressed in completed weeks).
- (4) Where a worker is or was employed jointly and concurrently by two or more municipalities the cost of a long service leave benefit shall be divided equally between the councils of those municipalities unless they have agreed to meet the cost on some different basis, and, in relation to a contribution towards the costof a long service leave benefit, the formula mentioned in subregulation (3) shall, to such extent as is necessary be modified so that the council of each municipality contributes in equal proportions unless they have agreed to contribute on some different basis.

Worker not to be employed during leave.

- 10. (1) A worker shall not, during any period when he is on long service leave, engage in any employment for reward in substitution for the service from which he is on leave.
- (2) If, during a period of long service leave, a worker fails to comply with subregulation (1) he shall forfeit his right to the unexpired portion of the period, and the employer shall be entitled to withhold any further payment in respect of the period and to reclaim any payments already made in respect of the period.
- (3) Where pursuant to subregulation (2) an employer reclaims any payments made in respect of a period of long service leave it shall make an appropriate refund to the council of any municipality that has contributed towards those payments under regulation 9.

Records to be kept by employers.

- 11. (1) Each employer shall, during the service of a worker in his service and for a period of ten years thereafter keep a record from which can readily be ascertained—
 - (a) the name of the worker and his classification;
 - (b) the dates on which the service of the worker commenced and terminated;
 - (c) details of any absence of the worker from duty;
 - (d) the entitlement of the worker to long service leave;
 - (e) details of any long service benefit granted to the worker during or on termination of his service.

SCHEDILE-continued.

(2) An employer shall make copies of the records kept pursuant to subregulation (1) available to the worker or to another employer upon written request being made to it in that regard.

Constitution of Board of Reference.

- 12. (1) A Board of Reference is hereby constituted for the purposes of these regulations.
 - (2) Subject to subregulation (3) the Board shall consist of—
 (a) one member who shall be appointed in writing by the Confederation of Western Australian Industry (Inc.);
 - (b) one member who shall be appointed jointly and in writing by the Municipal Officers Association of Australia and the

 - Association of Professional Engineers, Australia;

 (c) one member who shall be appointed in writing by the Trades and Labor Council of Western Australia; and

 (d) one member who shall be Chairman and who shall be appointed in writing by the Minister from amongst persons who are Industrial Magistrates referred to in section 103 of the Industrial Arbitration Act, 1912.
- (3) The person appointed pursuant to paragraph (b) of sub-regulation (2) shall only be a member of the Board for the purposes of the determination of matters relating to persons who are or, at the relevant time, were officers within the meaning of the Act and the person appointed pursuant to paragraph (c) of subregula-tion (2) shall only be a member of the Board for the purposes of the determination of matters relating to persons who are not or, at the relevant time, were not officers within the meaning of the Act.
- (4) An appointment required under paragraph (a), (b) or (c) of subregulation (2) shall be conveyed to the Minister as soon as practicable after the effective date and, thereafter, whenever a vacancy occurs in the office of a member of the Board referred to in that paragraph. to in that paragraph.
- (5) Each of the organisations refered to in paragraphs (a), (b) and (c) of subregulation (2) may appoint, in the same manner as members are appointed, deputy members one of whom may deputise for the member for whom he is deputy at any sitting of the Board.
- (6) A member or deputy member of the Board shall hold office at the pleasure of the organisation or person by which or by whom he was appointed.
- (7) A person who is or has been a member or deputy member of the Board is not personally liable for anything done or omitted in good faith in, or in connection with, the exercise or purported exercise of any authority, power or jurisdiction conferred by these regulations.

- Functions of questions and disputes referred by a party thereto from time to time arising for determination concerning, or in relation to, or in connection with, the provision of long service benefits under these regulations and rights and liabilities in respect of such benefits including, without derogation from the generality of the foregoing, guestions and disputes questions and disputes
 - (a) as to whether a person is or is not, or was or was not, a worker;
 - (b) as to whether and when and to what extent a worker is or has become entitled to a long service benefit;
 - (c) as to whether and to what extent a deceased person's personal representatives are or have become entitled to a long service benefit;
 - (d) as to the rate of pay to be applied for the purposes of calculating the payment to be made for or in lieu or on account of long service leave or pro rata long service leave or for the purposes of subregulation (3) of regulation 9;
 - (e) as to whether the termination by a worker of his service was or was not justified because of injury or sickness,

but do not include power, authority or jurisdiction to make an order or give a direction to enforce compliance by an employer with any obligation imposed on it by this Act.

14. (1) The Board may, for any purpose connected with, or related to, the carrying out of its functions—

Power to hold inquiries.

- (a) hold any inquiry;
- (b) summon witnesses; (c) receive evidence on oath or affirmation;
- (d) administer an oath or affirmation; and
- (e) require the production of documents or records.
- (2) A person who having been lawfully summoned to appear at an inquiry before the Board does not appear in obedience to the summons, or who appears, whether summoned or not, and-
 - (a) refuses to be sworn or affirmed as a witness
 - (b) refuses to answer any question he is lawfully required to answer; or
 - (c) refuses to produce any document or record he is lawfully required to produce,

commits an offence against these regulations.

Penalty: Two hundred dollars.

SCHEDULE—continued.

Determination, notification and appeal.

- 15. (1) Where the Board makes a determination of any question or dispute, the Chairman shall, at the request of any party to the question or dispute, issue to the party a certificate in writing signed by him certifying as to the determination.
- (2) Any party to a question or dispute on which the Board has made a determination under these regulations may appeal against the determination to the Commission in Court Session.
- (3) Notice of an appeal under subregulation (2) shall be lodged with the Registrar and served upon the other party or parties to the question or dispute within twenty-one days of the determination of the Board.
- (4) An appeal under subregulation (2) shall be heard and determined in the manner prescribed under the Industrial Arbitration Act, 1912, for appeals referred to in section 89 of that Act, with such modifications as are necessary.

Enforcement.

- 16. (1) An obligation imposed by these regulations may be enforced against a person or municipality by civil proceedings in a court of competent jurisdiction.
- (2) In any proceedings under subregulation (1) a determination of the Board, or of the Commission in Court Session on appeal to it under subregulation (2) of regulation 15, shall, according to its tenor, be conclusive evidence of the existence, nature and extent of an obligation imposed by these regulations.

- 1. In these regulations the Dog Act Regulations, 1976, published in the Government Gazette on 24th December, 1976, are referred to as the principal regulations.
 - 2. Regulation 4 of the principal regulations is amended—
 - (a) by inserting after the designation "4." the subregulation designation "(1)"; and
 - (b) by adding three further subregulations as follows:—
 - (2) The concessional registration rate in respect of dogs owned by pensioners is applicable only in respect of persons who are pensioners within the meaning of that term as defined under the National Health Act, 1953, of the Parliament of the Commonwealth.
 - (3) The concessional registration rate in respect of dogs kept in an approved kennel establishment licensed under section 27 of the Act is applicable only where the person registering the dogs does not elect to pay a separate registration fee in respect of each such dog.
 - (4) The concessional registration rate in respect of registration after 31st May in any year is applicable only in respect of an annual registration and not in respect of a three year registration period.
- 3. The Second Schedule to the principal regulations is amended, as to the provision in respect of concessional registration rates—
 - (a) by deleting the passage "under section 561 of the Local Government Act, 1960", in item 4, and substituting the passage "pursuant to regulation 4(2)"; and
 - (b) by adding a further item as follows-
 - 8. Dogs kept in an approved kennel establishment licensed under section 27 of the Act, where not otherwise registered, \$50.00 per establishment. .
