| Principal regulations. | 1. In these regulations the Fremantle Port Authority Regulations, 1971, published in the <i>Government Gazette</i> on the 10th day of December, 1971, as amended from time to time by notices so published, are referred to as the principal regulations. |
| Reg. 289 amended. | 2. Regulation 289 of the principal regulations is amended by deleting the words "the Manager"—
(a) in line three;
(b) in line four; and
(c) in line six,
and inserting in lieu thereof the words "an authorised person", in each case. |
| Reg. 290 amended. | 3. Regulation 290 of the principal regulations is amended by deleting the words "the Manager", in the last line, and inserting in lieu thereof the words "an authorised person". |
| Reg. 290A added. | 4. The principal regulations are amended by adding immediately after regulation 290 a regulation as follows— |
| Interpretation of "authorised person". | 290A. In regulations 289 and 290 of these regulations "authorised person" means the General Manager to the Port Authority, a person appointed to be in charge of any wharf or other premises vested in the Port Authority, a member of the Police Force, and any other person acting on the instructions of the General Manager to the Port Authority. |

- Regs. 305A and 305B added.
- Persons in breach of regulations to give name and address and leave premises when required to do so.
- Persons in breach of regulations may be apprehended and removed from premises.
5. The principal regulations are amended by adding immediately after regulation 305 the following regulations—
- 305A. A person shall, if and when required so to do by a member of the Police Force who reasonably believes that the person is on any wharf or other premises vested in the Port Authority in breach of regulation 269, 288, 289, or 290 of these regulations, give his name and address and if required by the member of the Police Force leave the wharf or such other premises or such part of the wharf or such other premises as may be specified by the member of the Police Force.
- 305B. A member of the Police Force may apprehend or remove or apprehend and remove from any wharf or other premises vested in the Port Authority a person who is committing a breach of regulation 269, 288, 289, 290 or 305A of these regulations.

GERALDTON PORT AUTHORITY ACT, 1968-1976.

Geraldton Port Authority,
Geraldton, 5th April, 1978.

THE Geraldton Port Authority acting pursuant to the provisions of the Geraldton Port Authority Act, 1968-1976, hereby makes the regulations set forth in the Schedule hereunder.

REGULATIONS.

- Principal regulations.
1. In these regulations, the Geraldton Port Authority Regulations, 1969, published in the *Government Gazette* on the 13th March, 1969, and amended by notices so published from time to time, are referred to as the principal regulations.
- Reg. 205A added.
2. The principal regulations are amended by adding after regulation 205 a regulation as follows—
- Public demonstration on wharves or jetties.
- 205A. A person shall not ring any bell or gong, play any musical instrument, walk or take part in any procession or demonstration of any kind, make or deliver any speech or address or sing any song or hymn likely to attract a crowd or assemblage of persons upon any wharf or jetty vested in the Port Authority without first having obtained permission therefor from the Wharf Manager, and any persons assembled, gathered or standing together on such a wharf or jetty shall immediately upon being required so to do by the Wharf Manager, disperse, quit and leave the wharf or jetty and its approaches.
- Regs. 219A and 219B added.
3. The principal regulations are amended by adding after regulation 219 regulations as follows—
- Persons in breach of regulations to give name and address and leave premises when required to do so.
- 219A. A person shall, if and when required so to do by a member of the Police Force who reasonably believes that the person is on any wharf or other premises vested in the Port Authority in breach of regulation 190, 204, 205, or 205A, give his name and address and if required by the member of the Police Force leave the wharf or such other premises or such part of the wharf or such other premises as may be specified by the member of the Police Force.

Persons in breach of regulations may be apprehended and removed from premises.

219B. A member of the Police Force may apprehend or remove or apprehend and remove from any wharf or other premises vested in the Port Authority a person who is committing a breach of regulation 190, 204, 205, 205A, or 219A.

REGULATIONS.

Principal regulations.

1. In these regulations the regulations made under the Albany Harbour Board Act, 1926, published in the *Government Gazette* on the 30th March, 1951 and amended from time to time thereafter by notices so published are referred to as the principal regulations.

Regs. 272A and 272B added.

2. The principal regulations are amended by adding immediately after regulation 272 the following regulations—

272A. Persons in breach of regulations to give name and address and leave premises when required to do so.—A person shall, if and when required so to do by a member of the Police Force who reasonably believes that the person is on any wharf or other premises vested in the Port Authority in breach of regulation 240, 254, 255, or 256 of these regulations, give his name and address and if required by the member of the Police Force leave the wharf or such other premises or such part of the wharf or such other premises as may be specified by the member of the Police Force.

272B. Persons in breach of regulations may be apprehended and removed from premises.—A member of the Police Force may apprehend or remove or apprehend and remove from any wharf or other premises vested in the Port Authority a person who is committing a breach of regulation 240, 254, 255, 256, or 272A of these regulations.

REGULATIONS.

- Principal regulations. 1. In these regulations the regulations made by the Esperance Port Authority under the Esperance Port Authority Act, 1968, published in the *Government Gazette* on the 11th March, 1969, and amended from time to time thereafter by notices so published are referred to as the principal regulations.
- Reg. 212A added. 2. The principal regulations are amended by adding immediately after regulation 212 a regulation as follows—
- Public demonstrations on wharves and jetties. 212A. A person shall not ring any bell or gong, play any musical instrument, walk or take part in any procession or demonstration, make or deliver any speech or address or sing any song or hymn likely to attract a crowd or assemblage of persons upon any wharf or jetty vested in the Port Authority, without first having obtained permission therefor from the Wharf Manager; and any persons assembled, gathered or standing together on such a wharf or jetty shall, immediately upon being required to do so by the Wharf Manager, disperse, quit and leave the wharf or jetty and its approaches.
- Regs. 226A and 226B added. 3. The principal regulations are amended by adding immediately after regulation 226 the following regulations—
- Persons in breach of regulations to give name and address and leave premises when required to do so. 226A. A person shall, if and when required so to do by a member of the Police Force who reasonably believes that the person is on any wharf or other premises vested in the Port Authority in breach of regulation 197, 211, 212, and 212A, give his name and address and if required by the member of the Police Force leave the wharf or such other premises or such part of the wharf or such other premises as may be specified by the member of the Police Force.
- Persons in breach of regulations may be apprehended and removed from premises. 226B. A member of the Police Force may apprehend or remove or apprehend and remove from any wharf or other premises vested in the Port Authority a person who is committing a breach of regulation 197, 211, 212, 212A, or 226A.
