WHEREAS it is enacted by section 64 O of the Prisons Act, 1903-1978, that the Governor may by proclamation set apart any suitable place, to be an institution for the reception of convicted inebriates and may vary or revoke any such proclamation by a subsequent proclamation; and whereas by proclamations under the Prisons Act, 1903, dated 7th March, 1963 and 25th July, 1973 the Governor set apart certain places described in those proclamations to be institutions for the reception of convicted inebriates: Now therefore, I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said section, do hereby revoke the proclamations dated 7th March, 1963 and 25th July, 1973 made under the Prisons Act, 1903 setting apart certain places to be institutions for the reception of convicted inebriates.

WHEREAS a proclamation was made by the Governor under the Plant Diseases Act, 1914 and published in the *Government Gazette* on the 16th September, 1921 under the heading "The Plant Diseases Act, 1914. Proclamation (No. 3)" and whereas section 6 of the Plant Diseases Act, 1914-1978 provides, *inter alia*, that the Governor may by proclamation vary any proclamation made under that Act: Now, therefore, I, the Governor, acting with the advice and consent of the Executive Council, and under section 6 of the Plant Diseases Act, 1914-1978 hereby vary the proclamation mentioned above—

- (a) by inserting after the words "Western Australia" in line 17 of the recitals the words "or so introduced";
- (b) as to paragraph (3)—
- (i) by deleting the passage "(except from South Australia)" in line two;
- (ii) by deleting the passage "(except South Australia)" in line four;
- (c) by deleting paragraph (4) and substituting a paragraph as follows—
- (4) Prohibit the bringing into the State from any other State or territory of the Commonwealth of any used grape harvesting machines or other machinery that has been used for viticulture. ;
- (d) as to paragraph (5), by deleting the passage "grapes (not being a vine or plant or cuttings or grapes grown and produced in South Australia.)" at the end of the paragraph and substituting the passage "grapes.";
- (e) as to paragraph (8), by deleting the passage "(subject to the exception in respect of grapes set out in paragraph 4 hereof)"; and
- (f) as to paragraph (9), by inserting immediately below the word "Nematodes" in the penultimate line the passage "Downy Mildew (*Plasmopara viticola*)".

WHEREAS in accordance with section 60 of the Health Act, 1911-1978, His Excellency the Governor has received details of a plan for the installation of a sewer to serve areas of the townsite of Carnarvon denoted as parts 1, 2 and 3 of area 4, and is satisfied that the scheme is formulated in accordance with the provisions of the Health Act, 1911-1978, and that the cost and provisions for repayment justify the undertaking and that the works, if carried out in the manner designed, will be of benefit to that portion of the district which the works are intended to serve. Now therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby order that the Shire of Carnarvon, being the Local Authority for the district, be empowered to undertake the construction of the said works.

Poisons Act, 1964-1970.

ORDER IN COUNCIL.

PHD. 398/74/6; Ex. Co. 2865.

WHEREAS by section 21 of the Poisons Act, 1964-1970, it is provided that the Governor may from time to time, by Order in Council, amend any of the Schedules referred to in section 20 of that Act by—

- (i) the addition thereto or the deletion therefrom of any substance;
- (ii) the deletion and substitution of all of the items in any Schedule;
- (iii) the transference of any substance from any Schedule to any other Schedule; or
- (iv) the alteration of any item in any Schedule;

And whereas by Order in Council published in the *Government Gazette* on the 14th June, 1979, the Governor deleted all the items set out in each of the Schedules referred to in section 20 of that Act and substituted the items set out in the Appendix to that Order in Council; and whereas it is deemed expedient to further amend the Schedules so referred to, in the manner hereinafter set forth: Now therefore, His Excellency the Governor, acting by and with the advice of the Executive Council, doth hereby amend the Schedules referred to in section 20 of the Poisons Act, 1964-1970, in the manner set out in the Appendix to this Order in Council.

- (a) in tablets or capsules each containing 325 mg or less of aspirin as the only therapeutically active constituent where the tablets or capsules are packed in blister or strip packaging or a container fitted with a child resistant closure, and the tablets or capsules are enclosed in a primary pack containing not more than 25 tablets or capsules;
- (b) in individually wrapped powders each containing 650 mg or less of aspirin as the only therapeutically active constituent where the powders are contained in a primary pack containing not more than 12 powders; or
- (c) when included in the Fourth Schedule. ;

- (c) by adding after the item beginning with the words "CANTHARIDES (CANTHARIDIN)" the item—

CARBARYL in preparations for external human therapeutic use containing 2 per cent or less of carbaryl. ;

- (d) by substituting for the item beginning with the word "CHLOROFORM" the item—

CHLOROFORM (excluding its derivatives) except—

- (a) in preparations containing 10 per cent or less of chloroform where the chloroform content is declared on the label; or
- (b) when included in the Fourth Schedule. ;
- (e) by substituting for the item beginning with the word "CODEINE" the item—

CODEINE in a proportion of 1 per cent or less—

- (a) when compounded with aspirin or paracetamol or salicylamide in tablets or capsules where the tablets or capsules are packed in blister or strip packaging or in a container fitted with a child resistant closure, and the tablets or capsules are enclosed in a primary pack containing not more than 25 tablets or capsules;
- (b) when compounded with aspirin or paracetamol or salicylamide in individually wrapped powders where the powders are enclosed in a primary pack containing not more than 12 individually wrapped powders; or
- (c) when compounded with one or more medicaments in any other preparation. ;

- (f) by substituting for the item beginning with the word "IODINE" the item—

IODINE, excluding its salts and derivatives, containing more than 2.5 per cent of available iodine except when included in the Sixth Schedule. ;

- (g) by deleting the item beginning with the word "IODOPHORS". ;

- (h) by adding after the item beginning with the word "NORCODEINE" the item—

PARACETAMOL, except—

- (a) in tablets or capsules each containing 500 mg or less of paracetamol as the only therapeutically active constituent where the tablets or capsules are packed in blister or strip packaging or in a container fitted with a child resistant closure, and the tablets or capsules are enclosed in a primary pack containing not more than 25 tablets or capsules;

- (b) in individually wrapped powders each containing 1 000 mg or less of paracetamol as the only therapeutically active constituent where the powders are enclosed in a primary pack containing not more than 12 individually wrapped powders; or
 - (c) when included in the Fourth Schedule. ;
- (i) by adding after the item beginning with the word "PHENOL" the item—

PHENYLPROPANOLAMINE in tablets or capsules containing not more than 30 mg of phenylpropanolamine per tablet or capsule when not in sustained release form, and not more than 50 mg in each tablet or capsule when in sustained release form. ; and
