Land Act, 1933-1977. ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1977, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any person or persons to be named in the order in trust for the like or other public purposes to be specified in such order: And whereas it is deemed expedient that Reserve No. 36786 should vest in and be held by the Minister for Works in trust for the purpose of "Water Supply".

Now, therefore, His Excellency the Administrator by and with the advice and consent of the Executive Council, does hereby direct that the beforementioned Reserve shall vest in and be held by the Minister for Works in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

AT a meeting of the Executive Council held in the Executive Council Chamber at Perth on the 1st day of October, 1980, the following Order in Council was authorised to be issued:—

### Workers' Compensation Act, 1912-1979. ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 13 of the Workers' Compensation Act, 1912-1979, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer or group of employers proves to the satisfaction of the Minister that such employer or group of employers has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer or group of employers from the operation of that section; and whereas Wynne Meat Industries Ltd., Wynne's Pty. Ltd., and Wynne Exports Pty. Ltd., companies having their registered office at 49 Albert Street, North Perth, being a group of employers within the meaning of the section has duly, in accordance with the Act, and the regulations made thereunder, made application for exemption from the operation of the section, and has satisfied the Minister that it has established a fund for insurance against the said liability, and has deposited at the Treasury a security, to wit, a bond for the value of fifty thousand dollars (\$50 000) charged with all payments to become due under the said liability: Now therefore His Excellency the Administrator acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt Wynne Meat Industries Ltd., Wynne's Pty. Ltd., and Wynne Exports Pty. Ltd., from the operation of section 13 of the Workers' Compensation Act, 1912-1979, for a period expiring on 30th June, 1982.

### BUSH FIRES ACT, 1954-1979. Shire of Manjimup.

Notice to Owners and/or Occupiers of Land.

PURSUANT to the powers contained in section 33 of the above Act all owners and occupiers of land in the Shire of Manjimup are hereby required on or before the 1st day of December, 1980 to clear firebreaks or remove all flammable materials from the land owned and/or occupied by them and thereafter to maintain such firebreaks clear of infiammable material until the 15th day of April, 1981, with the following requirements.

1. Rural Lands—Firebreaks of not less than two (2) metres wide in the following positions:—

- (i) Inside and along the boundaries of all pastures or grass lands.
- (ii) Inside and along the common boundaries of all land where this land abuts public roads on which there is a road formation.
- (iii) Within a minimum of twenty (20) metres and parallel to any boundary of a Railway Reserve and Timber Tramway Reserve.

2. Townsite Lands (includes residential, commercial and industrial land)—

 (i) Townsite lots having an area of not more than 2 024 square metres shall be completely cleared of material of a flammable nature and maintained free of such materials. (ii) On townsite lots having an area of more than 2 024 square metres, firebreaks no less than two (2) metres wide shall be provided and maintained inside and along the boundaries of the lots. Where several adjoining lots are held or used by the owner and/or occupier the firebreaks may be provided inside and along the external boundaries of the group or lot.

3. Rural and Townsite Lands-

(i) Firebreaks of not less than three (3) metres wide must be provided immediately surrounding all buildings, haystacks, fuel depots, drum ramps and drums, both full and empty.

4. Coarse Grain Crops—That prior to the harvesting of all coarse grain crops a three (3) metre firebreak must be constructed around the perimeter and such firebreaks must be kept free of flammable material until the crop has been harvested.

5. Pine Plantations-

- (i) Firebreaks not less than ten (10) metres in width around the perimeter of land on which pines are planted.
- (ii) Firebreaks not less than six (6) metres in width in such position that no part or compartment of a pine plantation shall exceed twenty eight (28) hectares in area.

If for any reason it is considered impracticable to comply with any provision of this notice, a written application for a variation may be made to the Shire Council and must reach the Shire Clerk before the 1st day of December, 1980.

Any such application must bear the signature of the Fire Control Officer of the area signifying his agreement to the variation. If permission for variation is not granted the terms of the notice must be complied with. Roadside positions will not be permitted.

The penalty for failure to comply with this notice is a fine of not less than \$10.00 nor more than \$200 in addition to which the Council may have the works carried out and may recover the costs of such works from the owner and/or occupier.

### Shire of Denmark.

Notice to Owners and Occupiers of Rural and Townsite Land Within the Shire of Denmark.

PURSUANT to the powers contained in section 33 of the above Act, owners or occupier of land within the Shire are hereby required to clear firebreaks on the land owned or occupied by you on or before the 1st day of January, 1981, in accordance with the following, and thereafter to maintain the fire breaks clear of inflammable material up to and including the 22nd May, 1981.

You shall clear of all inflammable material firebreaks at least 2 metres wide:----

- (a) immediately inside or outside all external boundaries of the land and also immediately surrounding all buildings and/or haystacks, or groups of buildings and/or haystacks situated on the land; and
- (b) not more than 100 m and not less than 20 m from the perimeter of all buildings and/or haystacks or groups of buildings and/or haystacks situated on the land; and
- (c) where the area of the land exceeds 120 ha, additional firebreaks so as to divide the land into areas of not more than 120 ha, which are completely surrounded with a firebreak at least 2 metres wide; and
- (d) you shall clear firebreaks at least 3 metres wide additional to those required in paragraphs (a), (b) and (c) above so as to completely surround the perimeter of land occupied by drums used for the storage of

infiammable liquid whether the drums contain infiammable liquid or not, including any land on which ramps for holding the drums are constructed. All land within the perimeter of the firebreak required by this paragraph is also to be cleared of infiammable material and maintained clear of infiammable material up to and including the 22nd May, 1981.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer not later than the 15th day of December, 1980, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine of not less than \$10 nor more than \$200, and a person in default is also liable, whether prosecuted or not, to pay the costs of performing the work directed in this order if this is not carried out by the owner or occupier by the date required by this notice.

Council will be prepared to accept well grazed kikuyu as an adequate firebreak.

#### SHIRE OF VICTORIA PLAINS TOWN PLANNING SCHEME No. 3 (DISTRICT SCHEME).

THE Victoria Plains Shire Council, under and by virtue of the powers conferred upon it in that behalf by the provisions of the Town Planning and Development Act, 1928 (as amended), hereby makes the following Town Planning Scheme for the purpose of promoting and controlling land use and development within the Shire.

### PART 1-PRELIMINARY.

1.1 This Town Planning Scheme may be cited as the Shire of Victoria Plains Town Planning Scheme No. 3 (District Scheme) hereinafter referred to as "The Scheme" and shall come into operation on the publication of notice of the Minister's final approval thereof in the *Government Gazette*.

1.2 The Scheme shall apply to the whole of the land included within the municipality of the Shire of Victoria Plains, hereinafter referred to as the "Scheme Area".

1.3 The responsible authority for carrying out the Scheme is the Council of the Shire of Victoria Plains, hereinafter referred to as "the Council". 1.4 In this Scheme the terms used will have the respective interpretations set out in Appendix 'D' of the Town Planning Regulations 1967 (as amended), unless otherwise specified in this Scheme.

1.5 The Scheme Text is divided into the following parts:—

Part 1—Preliminary.

Part 2—Aims and Objectives.

Part 3—Zones.

Part 4—Reserved Land. Part 5—Development Control.

Part 6—Appeals.

Part 7—Non-conforming use of land. Part 8—Subdivision of land.

Part 8—Subdivision of la Part 9—Administration.

1.6 The Calingiri Town Flanning Scheme No. 1 published in the *Government Gazette* on the 1st November, 1968 and the Bolgart Town Planning Scheme No. 1 published in the *Government Gazette* on the 10th April, 1970 are hereby revoked by this Scheme.

### PART 2-AIMS AND OBJECTIVES.

2.1 It will be the primary aim of the Council in administering the Scheme to protect and foster the agricultural industry.

2.2 In addition to this primary aim, the Council will through the provisions of the Scheme seek to—

- (a) ensure the orderly and proper development of the Shire;
- (b) preserve the amenity of the Shire;
- (c) ensure that any proposed use is appropriate to the area in which it is proposed;
- (d) prevent ribbon development particularly along the Great Northern Highway.

2.3 The Council will generally support the establishment of tourist facilities within the Shire and particularly at New Norcia and within the guidelines mentioned above.

#### PART 3-ZONES.

3.1 The Scheme area is divided into the following Zones:—

URBAN

RURAL

as shown on the Scheme Map appended to the Scheme.

3.2 The intention of the Urban Zone is to provide areas wherein uses such as houses, shops, banks schools, industry, fuel depots etc. and other uses which support the farming community or are more appropriate to this Zone than the Rural Zone, can be established.

3.3 The Rural Zone is intended to provide for the agricultural industry and it will be Council's policy to actively discourage uses which would be more appropriately sited in the Urban Zone or would conflict with the aims and objectives of Council mentioned in Clause 2.1.

#### PART 4-RESERVED LAND.

4.1 The Scheme does not reserve land for any purpose but no provision in the Scheme shall prevent the use and development of land reserved under the Land Act, 1933 (as amended) for any purpose that it may lawfully be used and developed.

#### PART 5-DEVELOPMENT CONTROL.

5.1 No person shall commence a use of land or buildings without first having received written approval from the Council for that use except that no such approval shall be required in respect of—

- (a) use of land for the erection of a single family dwelling house or duplex house;
- (b) the change of use from one use to another, if both uses are within the same use class as defined in Appendix 'D' of the Town Planning Regulations 1967 (as amended);
- (c) a proposed use which is incidental to the primary use of the land on which it is proposed; or
- (d) the use of land for agricultural or horticultural purposes.

5.2 Application for Council's approval required under Clause 5.1 shall be made in writing by the owner or his agent and shall comprise such plans, maps or information as is required to enable Council to fully consider the application including—

- (a) the use proposed;
- (b) the number and floor area of any buildings to be erected;
- (c) the number of storeys of any building to be erected;
- (d) a site plan indicating the position of any buildings to be erected, car parking spaces, access ways and landscaping.

Notwithstanding the above the Council may request such other maps, plans and material as it thinks necessary.

5.3 The Council may, on receipt of an application, grant its approval or refuse to grant its approval to the proposed use. In granting its approval the Council may impose such conditions as it deems necessary, including a condition restricting the period of time that the use may be carried out.

5.4 Council's decision on an application shall be conveyed to the applicant in writing.

5.5 Approval of a proposed use shall be valid for a period of two years from the date of the letter conveying that approval to the applicant and should the use not be commenced within that specified time the approval shall lapse.

5.6 In considering an application for a use of land or buildings the Council will have regard to the following—

- (a) the Zone in which the land is situated;
- (b) the aims and objectives of Council referred to in Part 2;
- (c) the orderly and proper planning of the locality including the preservation of amenity;
- (d) the compatibility of the proposed use with its immediate neighbours and the locality generally;
- (e) the prevention of ribbon development;
- (f) any other material consideration.

5.7 Where the Council fails to convey its decision within 60 days of receipt of an application, the application shall be deemed to be refused for the purpose of appeal.

5.8 A person who, after the Scheme has the force of law, commences a use without first having obtained the written approval of the Council, or fails to comply with any condition imposed on its grant of approval shall be guilty of an offence and be liable to the provisions and penalties of section 10 of the Town Planning and Development Act, 1928 (as amended).

#### PART 6—APPEALS.

6.1 Where the Council refuses to approve an application for the use of land or buildings or approves an application subject to conditions that are unacceptable to the applicant, the owner may appeal against that decision in accordance with the provisions of Part V of the Town Planning and Development Act, 1928 (as amended) and Regulations made thereunder.

PART 7-NON CONFORMING USE OF LAND.

- 7.1 No provision in this Scheme shall prevent-
  - (a) the continued use of any building or land for the purpose for which it was being lawfully used at the time of the coming into force of the Scheme; or
  - (b) the carrying out of any development thereon for which, immediately prior to that time, a permit or permits required under the Town Planning and Development Act, 1928 (as amended) and any other law authorising the development to be carried out have been duly obtained and was current.

#### PART 8-SUBDIVISION OF LAND.

8.1 In considering applications to subdivide or amalgamate land made pursuant to section 20 of the Town Planning and Development Act 1928 (as amended) and referred to it by the Town Planning Board, the Council in making its recommendation to the Board will have regard to—

- (a) the aims and objectives of the Scheme;
- (b) the purpose of the subdivision or amalgamation:
- (c) any other material consideration.

8.2 The Council will not favourably recommend the subdivision of land into what are commonly known as small holding or hobby farm lots unless the applicant can clearly show to the Council's satisfaction that the proposed subdivision, if approved, would not prejudice the aims and objectives of the Scheme.

8.3 The Council will not favourably recommend applications for the resubdivision of land unless Council is satisfied that—

- (a) the resubdivision would not prejudice the aims and objectives of the Scheme;
- (b) the resubdivision would result in an improved lot pattern;
- (c) the resubdivision would not decrease the land use potential for agriculture of that land suitable for the purpose;
- (d) the number of lots to be created is significantly less than the number of existing lots.

#### PART 9-ADMINISTRATION.

9.1 The Council may by an authorised officer, enter at all reasonable times any building or land for the purpose of ascertaining whether the provisions of the Scheme are being observed or for any other purpose necessary in the administration of the Scheme.

9.2 The Council may enter into an agreement with any owner of land for the purpose of promoting the aims and objectives of the Scheme.





(b) The Director reserves the right to refuse to make any particular examination on the ground of (i) the laboratories being already too fully occupied; (ii) the sample being unsuitable for the purpose; or (iii) any other good and sufficient reason. This information should also be enclosed with the sample(s) and each sample should be distinctly and separately marked. A letter must be sent separately at the same time stating the reasons why the sample is submitted and enclosing the fee, and, if applicable, stating the exact locality from which each mineral specimen was taken (paragraph 5c).

#### (3) Normal Fees.

The normal fee is charged for each test or determination on each sample. This fee varies with the material being examined and the time taken as below.
