AT a meeting of the Executive Council held in the Executive Council Chamber at Perth this 29th day of October, 1980, the following Order in Council was authorised to be issued:—

Employment Agents' Act, 1976.

ORDER IN COUNCIL.

WHEREAS, pursuant to section 8 of the Employment Agents Act, 1976, the Governor may by Order in Council grant to any person an exemption from any provision of that Act on such terms and conditions as the Governor thinks fit: Now, therefore, His Excellency the Administrator, acting with the advice and consent of the Executive Council hereby grants to Willow Babysitting Service, of 112 Blackwood Avenue, Hamilton Hill, and Mother Hen Babysitters, of 220 St. George's Terrace, Perth, an exemption from those provisions of subsection (2) of section 42 of the Employment Agents' Act, 1976, which require an employment agent who refers persons seeking employment to other persons with a view to engagement to give or forward to the prospective employee a form of "Notice of Employment Offered", upon the condition—

- (a) that the information as to any prospective employment which might be offered to a person seeking employment and which would, but for the exemption, have had to be given in writing to that person shall be given verbally;
- (b) that upon an engagement being made as to a prospective employment in relation to the person seeking that employment, the "Notice of Employment Offered", duly signed, shall be given or forwarded to the prospective employee as required by that section; and
- (c) that an accurate office record be maintained of all information furnished to a person seeking employment, whether verbally or by a Notice, specifying the details required under the Act.

6. Failure to carry out the work specified in this notice may result in the work being carried out by the Council or its authorised agent at the expense of the owner and/or occupier.

7. Incinerators for the burning of waste material must be of an approved type and in good condition. An open drum is not an approved type of incinerator.

Citation.

1. This Town Planning Scheme may be cited as Town of Albany Town Planning Scheme No. 6—Campbell Road Scheme (hereinafter called “the Scheme”).

Responsible Authority.

2. The Authority responsible for enforcing the observance of this Scheme is the TOWN OF ALBANY (hereinafter called “the Council”).

Maps.

3. The following maps are attached to and form part of the Scheme:—

Land Use Map.
Ownership Map.
Area Map.
Scheme Map.

Scheme Area.

4. The Scheme applies to the whole of the land contained within the inner edge of a broken black line on the Land Use Map and the Scheme Map (hereinafter referred to as “the Scheme Area”).

Sub-Areas.

5. The Scheme Area is divided into four sub-areas shown as “Area A”, “Area B”, “Area D” and “Area E” on the Area Map (each of which is herein referred to as a sub-area).

General Objects.

6. The general objects of the Scheme are:—

- (a) To facilitate and encourage the progressive subdivision and development of the land within the Scheme Area for residential industrial and recreational purposes.
- (b) To co-ordinate and control development in the Scheme Area.
- (c) To plan and make provision for suitable roads and pedestrian access ways and improvement of existing roads within the Scheme Area.
- (d) To make provision for proper drainage of those parts of the Scheme Area which require drainage.
- (e) To make provision for the creation of drainage reserves and easements.
- (f) To require the provision of sewerage facilities within the Scheme Area.
- (g) To make provision for the reticulation of water throughout the Scheme Area.
- (h) To make provision for land to be used for public open space and recreation.
- (i) To make provision for other matters which are necessary or incidental to town planning or housing.
- (j) To improve and secure the amenity health and convenience of the Scheme Area.
- (k) To make provision for the apportionment of Scheme Costs amongst owners in an equitable manner.

Method of Carrying Out Objects.

7. As and when owners of land within the Scheme Area subdivide or develop their land such subdivision or development shall be according to a plan which will be capable of forming part of an overall plan of subdivision and development for the Scheme Area.

8. (1) The Scheme Map indicates an acceptable method of subdivision and development of the Scheme Area but is not a detailed plan of survey.

(2) The Council may cause a plan of survey or precalculated plan of survey showing in detail the acceptable method of subdivision and development of the Scheme Area to be prepared.

(3) The Council may with the consent of the Town Planning Board permit departures from the design shown on the Scheme Map or plan of survey if it considers the proposed subdivisional design or proposed development to be of a similar standard to that shown but no departure from

the design shown on the Scheme Map or plan of survey shall be permitted if in the opinion of the Council it would impede the subdivision or development of the Scheme Area as a whole or of the sub-area in which the land is situated.

Subdivision and Development.

9. An owner of land within the Scheme Area who desires to subdivide or develop his land either alone or in conjunction with other owners shall submit a plan of the proposed subdivision or development to the Council and if the proposal involves subdivision he shall submit to the Town Planning Board a plan of subdivision in conformity with the Scheme Map or plan of survey referred to in clause 8(2) with such modifications as are permitted by the Council under Clause 8(3) hereof.

New Roads.

10. Subject to the following clauses all new roads shall be constructed and drained at the expense of the owners of the land in which such roads are situated and each owner shall when subdividing his land make the land available for the said roads and also for any pedestrian access ways which are required and pay the costs of the construction and drainage of the roads within the land owned by him. The costs of the construction and drainage of pedestrian access ways shall be paid by the Council.

11. In cases where the situation of a new road or of a new pedestrian access way is such that in the opinion of the Council it would be fair and equitable that the owners of adjoining land should each contribute to the cost of the construction or drainage of that road and apportion the value of the land made available for such roads and pedestrian access ways and such owners are unable to agree upon the proportion payable by each of them the amount (if any) payable by each such owner shall be determined by arbitration in manner hereinafter provided.

12. The Council shall pay one half of the cost of construction and drainage of the section of any road which abuts public open space in the Scheme Area and the owner's liability in respect thereof shall be reduced accordingly provided that:

- (a) This provision does not apply to the end alignment of a cul-de-sac road if that is the only part of the road which abuts the public open space.
- (b) Should the location of the public open space be changed or should the sites thereof be cancelled the Council's liability under this clause shall be transferred to the new site or cancelled as the case may be.
- (c) Where a road to which this clause applies has been constructed by or on behalf of an owner the Council's contribution shall be one half of the amount the Council considers to be a fair and reasonable cost of the construction of the road.

13. The Council may construct and drain any new roads and pedestrian access ways and acquire the land necessary for that purpose. If the Council does so prior to the subdivision of the lands adjoining such road or pedestrian access way the costs of the construction and drainage of the said road (but not the said pedestrian access way) and all compensation and other costs consequent upon the acquisition of the land shall be paid to the Council by each respective owner of land in accordance with the foregoing provisions prior to the final approval of the Town Planning Board to the subdivision of his land.

14. If an owner subdivides his land and if he or his predecessors in title have claimed or have been paid compensation by reason of the resumption by the Council of the land for a new road or a pedestrian access way he shall before the final approval by the Town Planning Board to his plan of subdivision release the Council from the compensation claimed or repay to the Council the amount of compensation paid by it to him or his predecessors in title as the case may be.

Construction or Improvement of
Existing Roads.

15. The construction, improvement, widening or drainage of or other works relating to Cockburn Road and Bathurst Street (with the exception of the works to be carried out at the junction of Cockburn Road and Bluff Street) shall be carried out by the Council unless in any particular case it decides otherwise.

16. Subject to Clause 29 an owner of land which abuts a road referred to in the preceding clause shall when subdividing his land pay to the Council prior to the final approval of the Town Planning Board to the subdivision such proportion of the costs or estimated costs of the construction, improvement, widening, drainage or other works thereof or relating thereto (not exceeding one half thereof) as the Council determines.

Closure of Roads.

17. (1) The roads shown on the Scheme Map as roads to be closed shall be closed as the development of the land proceeds and as such roads are no longer required.

(2) When the roads referred to in subclause (1) hereof have been closed the land shall be used for the purposes shown on the Scheme Map and if land is to be used for residential or other development by the owners the land shall vest in the adjoining owners subject to the payment to the Council of the value of such land.

Sewerage Drainage and Water Supply Works.

18. Such sewerage works drainage works and water supply works as are necessary for the proper drainage of the Scheme Area and the connection of the land therein to drains, to a sewer and to water mains shall at the appropriate times be carried out and subject to this clause and to Clauses 28 to 32 (inclusive) by or at the cost of the owner of the land served by such works. Each owner shall pay the cost of the connection within his lot to the sewerage service.

19. The Council may acquire such land as it considers necessary for sewerage water supply or drainage services and may set aside land for drainage sumps and compensating basins and other works.

Connection to the Sewer.

20. Subject to the next succeeding clause no land shall be subdivided unless there is a sewer to which all new lots in the proposed subdivision may be connected and no building shall be occupied unless the building is connected to the sewer.

21. If the Council is of the opinion that the nature of the soil in any part of the Scheme Area is sufficiently absorptive to permit the efficient operation of an apparatus for the bacteriolytic treatment of sewage it may permit the subdivision or development of that area and the occupation of buildings thereon before the sewer is available. Permission to subdivide or develop given pursuant to this clause does not unless otherwise determined by the Council absolve an owner from his liability to pay for the connection of his land to the sewer when the sewer becomes available.

Levelling and Filling.

22. If any land requires levelling or filling before it can be subdivided or built upon the cost of such works shall be borne by the owner of the land.

Public Open Space.

23. It is intended that the land coloured green on the Scheme Map shall be reserved for public open space.

24. The land coloured green on the Scheme Map shall be valued as at the date of coming into operation of the Scheme on the basis that the works to be carried out under the Scheme had

not been carried out. A valuation may be revised from time to time but not earlier than twelve (12) months after the valuation or the last preceding revision thereof. The amount of the valuation or the latest revision thereof is herein referred to as "the current value of the public open space".

25. (1) In this clause—

(a) "owner's proportion of P.O.S." means the proportion of the total area of the land coloured green on the Scheme Map calculated in accordance with the following formula—

$$p \times \frac{o}{a}$$

where—

"p" is the total area of the land coloured green on the Scheme Map;

"o" is the area of the owner's land being or capable of being subdivided; and

"a" is the total area of land in the Scheme Area including the area of the land coloured green on the Scheme Map.

(b) "owner's proportion of current value of P.O.S." means the proportion of the current value of the public open space calculated in accordance with the following formula—

$$v \times \frac{o}{a}$$

where—

"v" is the current value of the public open space;

"o" is the area of the owner's land being or capable of being subdivided; and

"a" is the total area of land in the Scheme Area including the area of the land coloured green on the Scheme Map.

(2) Each owner when subdividing or developing his land shall contribute towards public open space in the following manner:—

(a) the owner shall transfer to the Council so much of his land as is coloured green on the Scheme Map;

(b) if no part of the owner's land is coloured green on the Scheme Map he shall pay to the Council the owner's proportion of the current value of P.O.S.;

(c) if the area of the owner's land coloured green on the Scheme Map is greater or less than the owner's proportion of P.O.S. the owner shall receive from or pay to the Council a sum of money representing that proportion of the current value of the public open space as the area of the excess or deficiency bears to the total area of the land coloured green on the Scheme Map as the case requires.

(3) If the Council and the owner so agree a payment to be made by or to the Council in accordance with paragraph (c) of subclause (2) hereof may be satisfied or partially satisfied by the transfer of land not coloured green on the Scheme Map by the Council to the owner or by the owner to the Council as the case requires.

(4) It is intended that payments made to the Council pursuant to subclause (2) hereof and land transferred to the Council pursuant to subclause (3) will be available to make payments to owners and if an owner to whom a payment is to be made desires to subdivide his land before sufficient funds are available for that purpose the transfer by the owner pursuant to paragraph (a) of subclause (2) and the payment by the Council under paragraph (c) of subclause (2) shall, unless the

Council and the owner otherwise agree, be postponed until the Council has sufficient funds to make the payment.

26. Where in the Scheme the term "public open space trust fund" is used it refers to a special public open space trust fund established solely for the purposes of the Scheme. All moneys received by the Council pursuant to clause 25 shall be paid into the public open space trust fund.

27. (1) The Council shall apply moneys standing to the credit of the public open space trust fund in repaying any loan moneys or finance made available by it and interest thereon expended on the acquisition of public open space.

(2) If there is a surplus standing to the credit of the P.O.S. trust fund after the loan finance and interest referred to in subclause (1) hereof have been repaid the surplus or portion thereof may be applied in or towards payment of the costs incurred by the Council in carrying out landscaping and planting of trees shrubs and plants on any land in Area A or Area E pursuant to an agreement entered into in accordance with clause 38(g) hereof.

(3) Public open space shall be developed by the Council at its own expense and such costs will not be scheme costs.

Scheme Costs.

28. (1) The costs or estimated costs of the following items are hereinafter referred to as the Scheme Costs:—

- (a) The administration costs of the Scheme including an amount to reimburse the Council for such overhead and management costs as may be incurred in the implementation of the Scheme. The term "administration costs" includes in addition all legal costs, planning costs, payments to planning consultants and other professional consultants and valuation costs.
- (b) The cost of any surveys and preparation of pre-calculated survey plans carried out by or on behalf of the Council within the Scheme Area.
- (c) Subject to subclause (2), the costs (if any) to the Council of any drainage works necessary for the proper drainage of the Scheme Area and the acquisition of lands for that purpose.
- (d) The cost (if any) to the Council of the sewerage works necessary for the connection of the land in the Scheme Area to a sewer and of the acquisition of lands for that purpose.
- (e) The cost of the construction improvement widening and drainage of new roads and the acquisition of land for new roads or for the widening of new roads and one half of the cost of the construction, improvement widening and drainage of the roads referred to in clause 15 and the acquisition of land for the widening thereof within the Scheme Area.
- (f) All compensation payable and all costs and expenses of determining and settling compensation.
- (g) All interest accruing from time to time on moneys borrowed by the Council for the purposes of the Scheme.
- (h) All other costs and expenses which the Council is required to meet in order to implement and complete the Scheme.

(2) If the Council is of the opinion that the works referred to in paragraph (c) of subclause (1) hereof are of benefit to or serve land outside the Scheme Area, it shall apportion the costs or estimated costs of those works between land within the Scheme Area and land outside the Scheme Area in a manner it considers fair and reasonable and the amount apportioned to land outside the Scheme Area shall not be included in the Scheme Costs.

Apportionment of Scheme Costs between sub-areas.

29. The Council shall from time to time apportion—

- (a) one half of the cost of construction, widening, improvement and drainage of the roads referred to in Clause 15; and
- (b) all other Scheme Costs which the Council considers apply to the Scheme Area as a whole and not to any one sub-area

between the sub-areas in the proportion that the area of the land in each sub-area bears to the total area of land in the Scheme Area.

30. The Scheme Costs applicable to each sub-area are the sum of:—

- (a) those Scheme Costs which the Council determines relate exclusively to that sub-area; and
- (b) the proportion of all other Scheme Costs for that sub-area calculated pursuant to Clause 29 hereof.

Payment of Scheme Costs.

31. (1) Each owner of land within a sub-area shall prior to the final approval of the Town Planning Board of the subdivision of the land or prior to commencing to carry out development of the land whichever first happens pay to the Council an amount which bears the same proportion to the total Scheme Costs applicable to that sub-area as the area of the owner's land being subdivided or capable of being subdivided bears to the total area of land that is privately owned within that sub-area, but the Council shall not demand or seek to enforce payment before the date upon which the owner makes application to the Board for that final approval unless the owner has agreed to pay his proportion of scheme costs before that date or has commenced to carry out development of the land.

(2) For the purposes of this clause "privately owned land" means privately owned land within the sub-area excluding land for public open space and sewerage and drainage reserves shown on the Scheme Map.

Estimate of Scheme Costs.

32. If any of the items of Scheme Costs have not been paid or ascertained at the time of subdivision of a parcel of land they may be estimated by the Council. An estimate may be revised from time to time.

Works carried out by the Council.

33. If the Council itself carries out any of the Scheme Works it shall prepare details of costings based on current costs in the Albany region and submit them for verification to an independent engineer nominated by the President for the time being of the Western Australian branch of the Association of Consulting Engineers of Australia. The amount of the costs approved by the independent engineer as being fair and reasonable forms part of the Scheme Costs.

Land Owned by the Council.

34. All or any of the land now owned or subsequently acquired by the Council within or near the Scheme Area may be used by the Council for any purpose appropriate to the Scheme (and the Council has all the powers of an owner in respect thereof) and if such purpose is one for which an owner is required to make land available or for which land may be acquired by the Council hereunder the Council shall be compensated for the value of the land so used.

Valuations.

35. Where it is necessary to ascertain the value of any land for the purpose of the Scheme the value shall be determined by the Valuer-General of Western Australia or such other valuer being a Fellow or Associate member of the Australian Institute of Valuers as is approved by the Council.

36. When it becomes necessary to make a valuation by reason of an application for consent to a subdivision the costs of the valuation shall be paid by the person making the application.

Arbitration.

37. Any dispute or difference which by the terms of this Scheme may be determined by arbitration may be referred to the arbitration of a single arbitrator in manner provided by the Arbitration Act 1895 or any statutory modification thereof for the time being in force and if the parties fail to agree upon a single arbitrator he may be nominated by the President for the time being of the Law Society of Western Australia.

Powers and Authorities of Council.

38. In carrying out the provisions of the Scheme the Council has the following powers and authorities:—

- (a) To enter and inspect any land within the Scheme Area.
- (b) To make arrangements with the owners or occupiers of any land within the Scheme Area.
- (c) To enter into agreements with purchasers or prospective purchasers or prospective occupiers of land within the Scheme Area.
- (d) To enter into agreements with the Crown and any department of the State with reference to the carrying out of any of the objects or works of the Scheme.
- (e) To extend the time within which payments are to be made to the Council and agree to the securing of such payments.
- (f) To transfer any land owned by it or acquired by it pursuant to the Scheme as compensation and to enter into agreements relative to the determination and settling of compensation.
- (g) Without prejudice to paragraphs (b) and (c) hereof to enter into agreements with owners or occupiers or prospective occupiers or purchasers or prospective purchasers of any land within Area A or Area E used or zoned for use for the purposes of light industry permitting the Council to enter upon the land and carry out landscaping and planting of trees shrubs and plants thereon in order to protect the amenity of the Scheme Area in general and of other land in the vicinity in particular.

39. Twenty-eight (28) days written notice is hereby prescribed as the notice to be given pursuant to section 10 of the Act. Any expenses incurred by the Council under that section may be recovered from the person in default as a simple contract debt in a Court of Civil Jurisdiction competent to deal with the amount of the claim.

40. The Council may at any time exercise the powers conferred by section 13 of the Act.

Claims for Compensation.

41. The time within which a person may make a claim for compensation pursuant to Section 11 of the Town Planning and Development Act 1928 is six (6) months after the date when notice of the approval of this Scheme is published in the manner prescribed in the regulations made under that Act.
