South East Corridor Stage "A" Phase 1.

- 1. It is hereby notified for public information that the Amendment to the Metropolitan Region Scheme referred to in the First Schedule hereto, has been approved by His Excellency the Lieutenant Governor and Administrator, in accordance with the provisions of section 33 of the Metropolitan Region Town Planning Scheme Act, 1959-1979.
- 2. The Amendment as presented to the Lieutenant Governor and Administrator under the provisions of the said section of the aforesaid Act was modified by the Lieutenant Governor and Administrator, to the extent by:
 - (i) deleting the proposed reserve for an important regional road located along Chapman Road from adjacent to Manning Road through to Nicholson Road;
 - (ii) including portion of the reserve for an important regional road, so deleted, between Wharf Street and Nicholson Road in the reserve for parks and recreation area; and
 - (iii) approving amendment map sheet No. 16/65-1 which incorporates the modification.
- 3. The Minister for Urban Development and Town Planning has determined that copies of the maps, plans or diagrams that form part of the Amendment to the Metropolitan Region Scheme, be made available for public inspection as from the 8th day of December, 1980, during normal office hours, at the places mentioned in the Second Schedule hereto.
