Rules of Trotting.

NOTICE is hereby given that at a meeting of the Committee of the Western Australian Trotting Association held at Gloucester Park, East Perth, on the Eleventh day of March, 1981 it was resolved by a majority of the Committee that the Rules of Trotting be amended as follows:—

1. By the inclusion after the definition of security officer in Rule 1 of the further definition as follows:—

" "Special Lease" means a lease under which the legal owners of a horse or horses grants to the lessee named therein a lease of the horse for a fixed term and under which the lessee named therein is obliged to pay by way of rental fixed sums periodically and which are unrelated to stake won by the horse or horses named therein and to pay to such legal owner on the expiration of the term of the lease a sum fixed therein. "

2. By the inclusion after Rule 527B of the following 527C special leases.

- (i) This rule shall apply to special leases.
- (ii) In this rule the subrules hereof:—
 - (a) "horse" includes horses whether kept for racing or for stud purposes,
 - (b) "lease" unless inconsistent with the context means special leases,
 - (c) "lessee" means the lessee named in the special lease,
 - (d) "owner" means the legal owner named in the special lease.

- (iii) A horse the subject of a special lease shall be registered and otherwise treated and dealt with under these Rules of Trotting as if the lessee named in the special lease were the owner of the horse save and except that a further sub-lease shall not be registered without the written consent of the owner of the horse the subject thereof.
- (iv) For the purpose of these Rules of Trotting the lessee of a horse named in a special lease shall be deemed the owner of the horse the subject thereof.
- (v) The owner of a horse the subject of a special lease shall not be required to be registered as the owner thereof but the Association may if such owner so requires record the legal ownership of such horse.
- (vi) The owner of a horse the subject of a special lease shall not suffer incur or be liable for any penalty imposed upon the lessee thereof unless the Stewards or the Controlling Board is satisfied that such owner was a party to the offence in respect of which the penalty is imposed.
- (vii) The owner of a horse named in a special lease shall have no claim whether for loss damage or otherwise suffered or alleged to have been suffered by such owner by reason of any penalty imposed or against the Controlling Board or any Club or the Stewards or by reason of the disqualification of the horse from a race or races or by reason of the disqualification or suspension from racing for any period of time or in respect of any action of any kind whatsoever taken against the lessee or the horse by the Controlling Board or by the Stewards thereof or by any Club or its Stewards in any way whatsoever.
