Child Welfare Act 1947-1979. ORDER IN COUNCIL.

WHEREAS it is enacted by section 19 of the Child Welfare Act 1947-1979, that the Governor may by Order in Council, (inter alia) appoint a Special Magistrate or Special Magistrates for any Court or Courts established under that Section and may, in like manner, amend, vary or revoke any appointment made under that section; and whereas it is now expedient that those powers should be exercised in the manner hereinafter appearing: Now therefore His Excellency the Governor acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid, doth revoke the appointments of the persons named in the Schedule hereto as Special Magistrates under the Child Welfare Act 1947-1979 with effect from the dates mentioned.


