WHEREAS it is enacted by subsection (2) of section 15 and subsections (2) and (3) of section 152 of the Petroleum Act 1967 that notwithstanding the Land Act 1933 or any other Act the Governor, by proclamation, may declare that any land of the Crown or part thereof reserved for or dedicated to any public purpose under any Act and howsoever classified that:—

- (a) is not Crown land within the meaning of that expression in Section 5 of the Act; and
- (b) is specified in the proclamation,

is Crown land for the purposes of the Petroleum Act 1967 and is land to which that Act applies, so long as the proclamation remains in force: Now, therefore, I the Governor acting with the advice and consent of the Executive Council and in the exercise of the powers under subsection (2) of section 15 of the Petroleum Act 1967, do hereby declare that the land of the Crown comprising Reserve No. 12475 classified as Class "C" and set apart for the purpose of Stock Route and outside the boundaries of Exploration Permit No. 129, Reserve No. 23897 classified as Class "C" and set apart for the purpose of Stock Route, Reserve No. 13120 classified as Class "C" and set apart for the purpose of Water, Reserve No. 14124 classified as Class "C" and set apart for the purpose of Public Utility pursuant to the provisions of the Land Act 1933, are Crown land for the purposes of the Petroleum Act 1967 and is land to which the Petroleum Act 1967 applies so long as this proclamation remains in force, subject to:—

- (i) Survey lines within the Reserve being delineated with minimum interference to and disturbance of vegetation and timber, any traverse lines through timber stands being cut by hand.
- (ii) The clearing and construction of tracks being limited to a superficial blading and filling in of soil irregularities only, so that as far as is practicable root-stock and topsoil is left in place with its contained seed load. Any shot holes drilled being filled in and left in a safe and level condition.
- (iii) On completion or abandonment of any operational area such measures as are reasonably practical being taken to restore the

area to its original condition, and in regard to Water Reserve No. 13120 also subject to:—

- (iv) No activities being carried out that will pollute or restrict the supply of water in or to any facility situated on the reserve or in the drainage system thereto and no damage being caused to any of the improvements the property of the Shire of West Kimberley.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 16 September 1981, the following Order in Council was authorised to be issued:—

ORDER IN COUNCIL.

File No. 1625/981.

WHEREAS by section 33 of the Land Act 1933, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any person or persons to be named in the Order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such Order and with power of leasing; and whereas it is deemed expedient that Class "A" Reserve No. 37426 should vest in and be held by the City of Cockburn in trust for the purpose of "Recreation": Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, does hereby direct that the beforementioned Reserve shall vest in and be held by the City of Cockburn in trust for "Recreation" with power to the said City of Cockburn, subject to the approval in writing of the Minister for Lands to each and every lease or assignment of lease being first obtained, to lease the whole or any portion thereof for any term not exceeding twenty-one (21) years from the date of the lease, subject nevertheless to the powers reserved to me by section 37 of the said Act; provided that no such lease or assignment of lease shall be valid or operative until the approval of the Minister for Lands, or an officer authorised in that behalf by the Minister, has been endorsed on the Lease Instrument, or Deed of Assignment, as the case may be.

PUBLIC SERVICE ARBITRATION ACT 1966-1978.

IN the matter of the Public Service Overtime Award 118 the matter of the Public Service Overtime Award 1978 No. 10 of 1978 and in the matter of an application made by the Civil Service Association of Western Australia Incorporated to vary the award pursuant to secion 27 (2) (c) of the Public Service Arbitration Act 1966-1978. PUBLIC SERVICE OVERTIME AWARD 1978.

No. 10 of 1978.

Amendment No. 9 of 1981.

The Public Service Overtime Award 1978, No. 10 of 1978 be, and the same is amended in accordance with the following schedule, with effect from 11 September 1981.

Schedule.

Clause 6—Delete the existing clause and insert in lieu thereof the following:-

6.—Meal Allowances.

(a) A break of 30 minutes shall be made for meals between 12.00 Noon and 2.00 p.m. and between 4.30 p.m. and 6.30 p.m. when overtime duty is being performed.

Except in the case of emergency, an officer shall not be compelled to work more than five hours overtime duty without a meal break. At the conclusion of a meal break the calculation of the five hour limit recommences.

An officer required to work overtime who purchases a meal shall be reimbursed for each meal purchased at the rate of \$2.70 for a morning meal, \$3.30 for a midday meal, and \$4.00 for an evening meal.

Provided that the overtime worked when such a meal is purchased totals not less than two hours, such reimbursement shall be in addition to any payment for overtime to which he is entitled.

- (c) If an officer, having received prior notification of a requirement to work overtime, is no longer required, then the officer shall be entitled, in addition to any other penalty, to reimbursement for a meal previously purchased.
- Clause 7.—Delete the existing clause and insert in lieu thereof the following:-

7.—On Call.

(a) An officer who is authorised by the Permanent Head, or by a duly authorised Senior Officer, to hold himself on call during his period off duty, shall be paid an allowance in accordance with the following formula for each hour or part thereof they are on call.

Provided that payment in accordance with this paragraph shall not be made with respect to any period for which payment is made in accordance with the provisions of "Clause 5.—Overtime", of this award when the worker is recalled to work.

- (b) For the purpose of this clause "on call" shall mean an instruction to an officer to remain at his place of residence or otherwise to hold himself available for immediate contact in case of an emergency call-out requiring the performance of duties either at that residence or away from such place of residence.
- Where an officer is required to be on call the Department shall supply a telephone and pay all connection and disconnection charges and annual rental charges. If the officer so required to be on call already has a telephone connected, the Department shall pay all rental charges.
- (d) Where an officer rostered for "on call" duty which he is on call, then he shall receive payment for hours worked in accordance with subclause (b) of Clause 5.

The "On Call" Allowance is paid in addition to any overtime paid in these circumstances.

(e) Time spent in travelling to and from the place of duty, where the officer rostered on call is actually recalled to duty, shall be included with actual duty performed for the purpose of overtime payment.

- (f) The limitations of subclause (5) (j) shall not apply to officers rostered "on call". Officers rostered "on call" shall receive payment calculated on the basis of the officer's classification and salary.
- (g) An officer in receipt of "On Call" Allowance and who is recalled to duty shall not be regarded as having performed emergency duty in accordance with Clause 8.

BUSH FIRES ACT 1954-1979. Town of Geraldton.

Notice to all Owners and/or Occupiers of Land in the Town of Geraldton.

PURSUANT to the powers contained in section 33 of the above Act, you are hereby required on or before 13 December 1981 or within fourteen days of the date of your becoming owner or occupier should this be after 13 December 1981, to remove from the land owned or occupied by you, all inflammable materials or to clear firebreaks in accordance with the following and thereafter to maintain the land or the firebreaks clear of inflammable material up to and including 14 February 1982.
