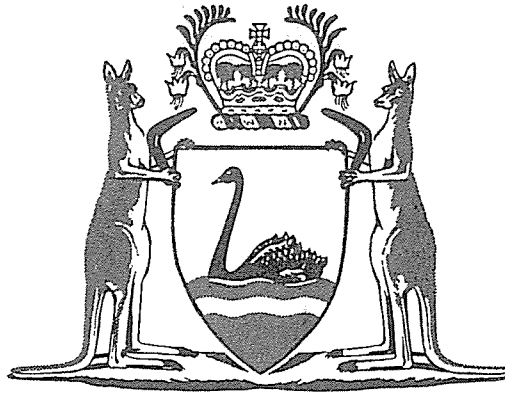

## PROCLAMATION

(MOTOR VEHICLE DEALERS (SALES) REGULATIONS 1974, REG. 10)  
NOTICE PROHIBITING SALE OF SECOND-HAND VEHICLE.

At the time of inspection by a member of the Police Force or Traffic Inspector examining or testing second-hand vehicles, this vehicle required attention to comply with the law relating to the equipment, servability or roadworthiness of vehicles.

The sale of this vehicle is prohibited, except for the purposes of breaking up, unless and until this label has been removed by a member of the Police Force or Traffic Inspector.

Reverse Side (Form 9).

This vehicle must not be sold, except for the purposes of breaking up, unless and until this notice has been removed by a member of the Police Force or Traffic Inspector.
