APPLICATIONS are invited under section 116 of the Land Act 1933 for the leasing of King Location 586 containing an area of 114.827 8 hectares for the purpose of "Pisciculture and Irrigated Pasture" for a term of 21 years at a rental of \$570.00 per annum.

Applicants will be required to submit with their applications detailed proposals, satisfactory to the Hon. Minister, for the development of the land for its designated purpose, including reference to such aspects as—

- (i) their experience in pisciculture;
- (ii) scientific and technological support for their proposed venture;
- (iii) funding available for their venture and its source:
- (iv) a timetable for proposed development, complete with strategy of culture and sale of product; such analysis to demonstrate the project's viability;
- (v) provisions for disposal of liquid effluent and solid wastes from the proposed process plant;
- (vi) stabilisation of erosion gully heads against damage from increased runoff consequent to the proposed venture's operations.

The Minister for Lands reserves the right to refuse any application on the grounds that the proposed utilisation, development and/or development programme is inadequate or unsuitable or that the applicant has failed to show adequate capacity to fund the development.

Consistent and unexplained readings of dieldren have been detected in the waters of Lake Kununurra adjacent to the Packsaddle Pump Station. Applicants should satisfy themselves that the quality of the water is suitable for a prawn farming venture.

Subject to agreement between the lessee and the Minister, the foregoing development obligations and other conditions set out therein may be varied or added to from time to time.

At any time during the term of the lease, subject to completion of development over not less than two thirds of the area in compliance with lease conditions and to the satisfaction of the Minister for Works and the Minister for Lands, and to the construction of a residence and other buildings which comply with Council by-laws, the lessee may surrender his lease for the purpose of obtaining freehold title to the land. Subject to successful application being made within three years of commencement of the lease, the price for conversion to freehold during that period is fixed at \$14 250.

- (1) The land shall not be used for any purpose other than "Pisciculture and Irrigated Pasture" without the prior approval in writing of the Minister for Lands.
- (2) The rent shall be subject to reappraisement at the end of the third year and each successive three year period thereafter.

 - (ii) ensure that no material likely, in the opinion of the Department of Agriculture and Fisheries and Wildlife, to cause pollution to the Ord River, escapes from the ponds into Lake Kununurra, and that any water which does return to the river is along drainage routes approved by the Public Works Department;

- (iii) negotiate with the Public Works Department for rights to obtain water from Lake Kununurra and shall construct ponds and drainage to the satisfaction of that Department.
- (6) The species to be farmed shall be restricted to Machrobrachium species and the introduction of any species not native to the area shall be subject to the approval of the Department of Fisheries and Wildlife.
- (7) The lessee shall be responsible for erosion control measures deemed by the Public Works Department to be necessary and shall effect such works to the satisfaction of the Minister for Works.
- (8) The land shall be occupied and used by the lessee for the purpose specified within nine (9) months of the commencement of the lease and thereafter will be continuously so used to the satisfaction of the Minister for Lands in accordance with the programme and timetable approved at the time of land allocation, or as amended from time to time with the approval of the Minister.
- (9) All buildings, erections, paving, drainage and other works shall be to the approval of the Local Authority and the lessee shall perform, discharge and execute all requisitions and works unto the demised land as are or may be required by any local or public authority operating under any statute by-law or regulation.
- (10) The lessee shall, within twelve months from commencement of the lease, fence the external boundaries to the satisfaction of the Minister for Lands.
- (11) The lessee shall maintain existing and future improvements to the satisfaction of the Minister for Lands.
- (12) The only residence permitted will be that of the Lessee or a Manager or Manager/Caretaker.
- (13) The lessee shall indemnify the Minister for Lands against all claims for damage to property or persons arising from the use of the land.
- (14) The Minister for Lands or his representative may enter the land for inspection at any reasonable time.
- (15) Compensation will not be payable for damage by flooding of the demised land.
- (16) Compensation shall not be payable to the lessee in respect of any improvements effected by him on the demised land and remaining thereon at the expiration or earlier determination of the lease.
- (17) It shall be lawful for the lessee at any time within the three calendar months immediately following the expiration of the term or earlier determination of the lease, to take down, remove and carry away any buildings, structures, improvements and plant the property of the lessee.
- (18) On determination of the lease, the lessee shall fill in, consolidate and level off any unevenness, excavation or hole caused by him during the term of the lease or by removal of his improvements and shall leave the demised land in a clean, neat and tidy condition to the satisfaction of the Minister for Lands and shall remove any or all waste matter as required by the Minister.
- (19) Neither the Government nor the Local Authority shall be responsible for providing services to the site.
- (20) A clearance of 150 metres is provided between the river bank and the proposed lease boundary. The lessee will be responsible for providing his own access.


