Declaration Under and Pursuant to Section Seven F of the Housing Loan Guarantee Act 1957-1973.

RAYMOND HONOURABLE O'CONNOR, The Treasurer, have been requested under the provisions of section seven F of the Housing Loan Guarantee Act 1957-1973 (in this notice called "the Act") to do so, do by this notice declare the following matters, that is to say-

## CONSTITUTION (ALLOCATION OF NEW METROPOLITAN ELECTORAL PROVINCES) ORDER 1982.

MADE by His Excellency the Governor in Executive Council.

Citation.

1. This Order may be cited as the Constitution (Allocation of New Metropolitan Electoral Provinces) Order 1982.

Interpretation. 2. In this Order-

"member" means a member of the Legislative Council of Western Australia; and

"new Metropolitan Electoral Province" has the same meaning as that expression has in section 8B of the Constitution Acts Amendment Act 1899-1981.

Allocation of Provinces.

3. Under section 8B of the Constitution Acts Amendment Act 1899-1981, it is hereby declared that a member named in the first column of the Schedule to this Order, shall sit and vote for the new Metropolitan Electoral Province set out opposite his name in the second column of that Schedule on and from 21 May 1983 until 21 May 1986.

    - "Take-Away Foods Outlet" means premises in which food in a form ready to be eaten without further preparation is prepared and served to customers for consumption off those premises."
- 2. Zoning Tables which follow Clause 18—Delete the Use Class "Fish Shop" and the symbols against it.
  - 3. Clause 68-Off Street Parking Provisions.
    - (A) Under the heading "Shops", delete paragraphs(c) and (d).
    - (B) After the item headed "Shops", insert the following:—

Take-Away Foods Outlets: Twenty paved parking spaces, but the Council may if it considers the circumstances justify it so doing, reduce that number in any particular case. If the Council reduces the number it may stipulate that the reduced number applies only to the particular case and if it does so additional paved parking spaces must be provided so that the total number is 20 or a lesser number if the type of Take-Away Foods Outlet is changed.

Cafes, Dining Rooms, Restaurants and Reception Lodges: One paved parking space for every 2.5 m² or part thereof of the usable area as determined by the Council, but the Council may reduce that number by not more than 50% in any case where the reduction will be balanced by the use of parking facilities on an adjoining property or the same lot pursuant to an agreement between the respective owners or occupiers, as the case may be, if the Council is satisfied that the arrangement will provide adequate overall parking facilities. In this item, the expression "usable area" means the area of that portion of the building which in the opinion of the Council is capable of being used for the seating or accommodation of patrons or guests, but does not include kitchens, lavatories, change rooms, cupboards, passages and other areas which are not normally used for the seating or accommod or guests.
