Land Act 1933.

ORDERS IN COUNCIL.

WHEREAS by section 33 of the Land Act 1933, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any person or persons to be named in the order in trust for the like or other public purposes to be specified in such order: And whereas it is deemed expedient as follows:—

File No. 2665/32.—That Reserve No. 22138 should vest in and be held by the Minister for Water Resources in trust for the purpose of "Public Buildings—Water Supply Office".

File No. 4444/48.—That Reserve No. 24351 should vest in and be held by the Minister for Water Resources in trust for the purpose of "Water Supply".

File No. 563/981.—That Reserve No. 37743 should vest in and be held by the Honourable Richard Charles Old M.L.A. Minister for Agriculture for the time being and his successors in Office in trust for the purpose of "Agricultural Research Station".

File No. 483/981.—That Reserve No. 37747 should vest in and be held by the Minister for Water Resources in trust for the purpose of "Water Supply".

File No. 3650/981—That Reserve No. 37750 should vest in and be held by the Honourable Raymond Laurence Young M.L.A. Minister for Public Health for the time being and his successors in Office in trust for the purpose of "Staff Accommodation Site (Community and Child Health Services)".

File No. 2359/79.—That Reserve No. 37759 should vest in and be held by the Metropolitan Water Supply, Sewerage and Drainage Board in trust for the purpose of "Water Supply".

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, does hereby direct that the beforementioned Reserves shall vest in and be held by the beforementioned bodies in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

Land Act 1933. ORDER IN COUNCIL.

Corres. No. 662/78.

WHEREAS by section 33 of the Land Act 1933 it is inter alia, made lawful for the Governor to direct that any land reserved pursuant to the provisions of the Act shall be leased for the purpose of which the land is reserved as aforesaid, by Instrument of Lease, to any person (as defined in the said section); and whereas it is deemed expedient that Reserve No. 37780 (De Witt Location 133) shall be leased for a term of one (1) year and thereafter from year to year to the Commonwealth of Australia to be held in trust for the purpose of a "Rifle Range".

Now therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby direct that the abovementioned reserve shall be leased for a term of one (1) year and thereafter from year to year to the Commonwealth of Australia to be held in trust for the purpose of a "Rifle Range" at a rental of two dollars (\$2.00).

ORDER IN COUNCIL.

L. & S. Corres. 3468/980 (R.6674).

WHEREAS by section 288 of the Local Government Act 1960-1981, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the Government Gazette to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than ten years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street.

Citation.

These regulations may be cited as the Road Traffic (Fees for Vehicle Licences) Regulations 1982.

Interpreta-

In these regulations—
"the Act" means the Road Traffic Act 1974-1981;
"the Second Schedule" means the Second Schedule to the Act as amended by regulations published in the Government Gazette on 29 May 1981.

Specified day.

For the purposes of section 28A of the Act, the specified day in relation to the amendments effected by these regulations shall be 1 July 1982.




