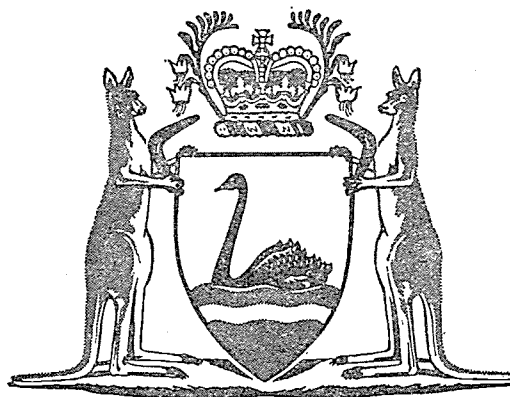

### PROCLAMATION

## FIRE BRIGADES AMENDMENT REGULATIONS 1982.

MADE by His Excellency the Lieutenant Governor and Administrator in Executive Council.

- Citation. 1. These regulations may be cited as the Fire Brigades Amendment Regulations 1982.
- Commence-  
ment. 2. These regulations shall come into operation on the day on which the Fire Brigades Amendment Act 1982 comes into operation.
- Principal  
regulations. 3. In these regulations, the Fire Brigades Act Regulations\*, as amended, are referred to as the principal regulations.
