#### PROHIBITED BURNING PERIODS.

I, IAN JAMES LAURANCE, the Minister administering the Bush Fires Act 1954-1981, hereby declare under section 17 of that Act that it shall be unlawful to set fire to the bush in the Municipalities during the periods in each year as set out in the Schedules Nos. 1 and 2 hereto under the following headings:—

- 1. PROHIBITED BURNING PERIODS.
- 2. DETAILS APPLYING TO EACH MUNICIPALITY AS SET OUT UNDER COLUMNS (1) TO (4).

I have approved the boundaries of the areas described in the Schedules Nos.  $3\ to$   $31\ hereunder$ .

#### RESTRICTED BURNING PERIODS.

It is hereby notified that the Bush Fires Board has revoked the declaration of "Restricted Burning Periods" published in the *Government Gazette* (No. 70) of 22 September 1978, and amendments to that declaration published in the *Government Gazettes* of 24 August 1979 and 2 May 1980, for the purpose of substituting another declaration as set out in the Schedule hereunder for the declaration so revoked.

#### Schedule No. 1.

#### PROHIBITED BURNING PERIODS.

(All dates inclusive.)

- ZONE 1—From the 15th day of December in each year to the next following 31st day of March.
- ZONE 2—From the 1st day of November in each year to the next following 31st day of January.
- ZONE 3—From the 1st day of November in each year to the next following 7th day of February.
- ZONE 4—From the 1st day of November in each year to the next following 14th day of February.
- ZONE 5—From the 1st day of November in each year to the next following 21st day of February.
- ZONE 6—From the 1st day of November in each year to the next following 28th day of February.
- ZONE 7—From the 22nd day of December in each year to the next following 7th day of March.
- ZONE 7A—From the 22nd day of December in each year to the next following 31st day of January.
- ZONE 8—From the 15th day of December in each year to the next following 14th day of March.
- ZONE 9—From the 1st day of August in each year to the next following 30th day of April.
- ZONE 10—From the 15th day of December in each year to the next following 14th day of April.
- ZONE 11-From the 1st day of April to the 31st day of October in each year.
- ZONE 12-From the 1st day of May to the 30th day of November in each year.
- ZONE 13-From the 1st day of April to the 1st day of December in each year.
- ZONE 13A-From the 1st day of August to the 15th day of November in each year.
