PURSUANT to sections 5 and 6 of the Plant Diseases Act 1914-1981, I, the Lieutenant-Governor and Administrator, acting with the advice and consent of the Executive Council, do hereby-
(a) revoke the proclamation dated 7 September 1962 published in the Government Gazette on 21 September 1962 at pages 2551-2552; and
(b) because of the likelihood of the introduction of disease into the State, prohibit the bringing or sending into the State from any other State or Territory of the Commonwealth, of potatoes, except in accordance with the Plant Diseases (Potato) Regulations 1984.
Given under my hand and the Public Seal of the said State, at Perth, this 7th day of February, nineteen hundred and eighty-four.

AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth on Tuesday, 24 January 1984 the following Order in Council was authorised to be issued.

## Forests Act 1918-1976.

ORDER IN COUNCIL.
F.D. 357/77; L. \& S. 2977/25.

WHEREAS by the Forests Act 1918-1976 it is provided that a dedication under the said Act of Crown Land as a State forest may be revoked in whole or in part in the following manner-
(a) the Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
(b) after such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication.
And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament, his proposal dated 28 September 1982, for the revocation in part of the dedication of Crown Lands as State forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Lieutenant-Governor and Administrator with the advice and consent of the Executive Council doth hereby revoke in part the dedication of Crown Land as State forest No. 28 described in the Schedule hereto.
