THE WESTERN AUSTRALIAN TURF CLUB.

Amendment of By-laws.

 - (c) The senior member of the Committee at that date.
- 42B. In the election of Chairman or Vice-Chairman under By-law 42.
 - (a) Any member of the Committee who shall be unable to attend shall be entitled to lodge with the Secretary at any time up to the commencement of the election; his written nomination for the position of Chairman and/or Vice-Chairman and such nomination shall be taken into account in the election.
 - (b) In the event of there being an equal number of votes cast for any two or more members of the Committee for the position of Chairman or Vice-Chairman, then of those members of the Committee the senior member shall be elected. "

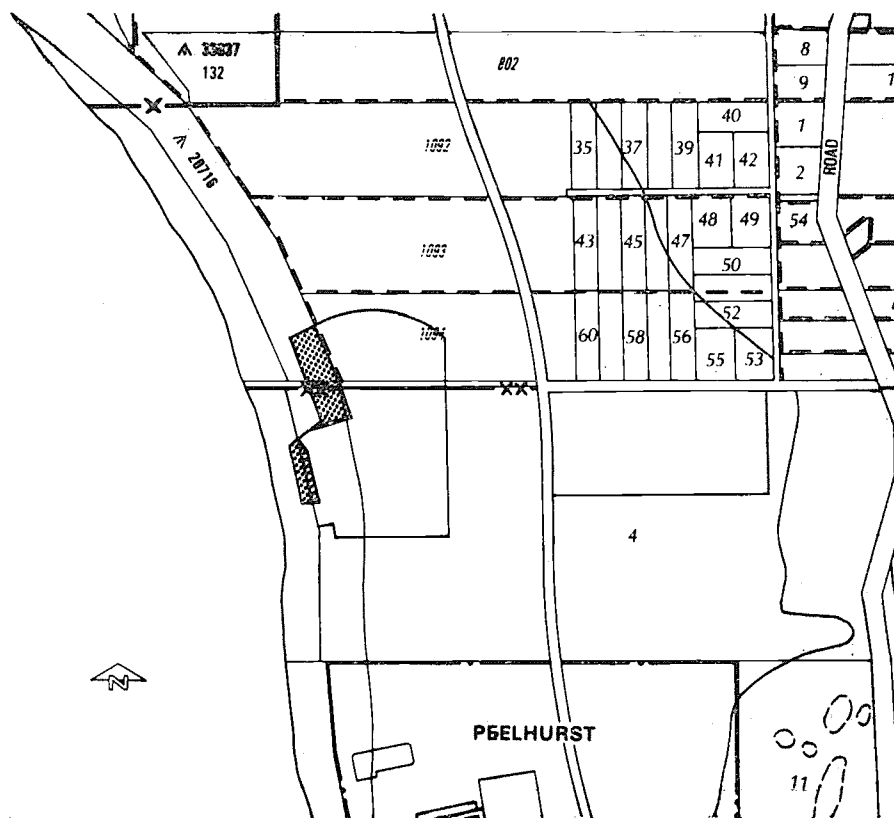
