Berthage dues are payable for a period of 12 months ending 31 December in each year. Where the use of vessels commences after 30 June in any year, one half of the prescribed dues are payable.





At the date of this report insufficient information was available for us to determine what proportion of the above amount is irrecoverable on the basis of the Court decision. We are therefore unable to express an opinion on the recoverability of the amount of \$39 542 stated above. The Shire Clerk's Advance Account had been overdrawn on a number of occasions during the year. This contravenes the borrowing provisions of the Local Government Act.
