| Citation. | 1. This Order may be cited as the "Shire of West Pilbara (Ward Representation) Order 1985". |
| Increase in the number of Councillors. | 2. On and from 4 May 1985 the number of Offices of Councillor for the Shire shall be increased from 9 to 10. |
| Reduction in membership of the East Ward. | 3. The number of Offices of Councillor of the South Ashburton Ward of the Shire of West Pilbara shall be reduced from 2 to 1 with effect from immediately before 4 May 1985. |
| Sitting members to go out of office. | 4. Both Councillors of the Shire holding Office for the South Ashburton Ward shall go out of office immediately before 4 May 1985. |
| Increase in membership of West Ward. | 5. On and from 4 May 1985 the number of Offices of Councillor for each of the Paraburdoo and Tom Price Wards of the Shire shall be increased from 1 to 2. |
| Elections to be held. | 6. Elections to fill the Office of Councillor for the South Ashburton Ward and the additional Offices of Councillor for the Paraburdoo and Tom Price Wards shall be held on 4 May 1985. |

- Citation. 1. This order may be cited as the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 3) 1985.

tion. 3. In this order—
“the principal order” means the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984*.
