PETROLEUM PRODUCTS PRICING ACT 1983.

PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 5) 1985.

MADE by the Prices Commissioner under section 12.

- Citation. 1. This order may be cited as the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 5) 1985.
- Commencement. 2. This order shall take effect on 4 May 1985.
- Interpretation. 3. In this order—
“the principal order” means the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984*.
- Clause 4 amended. 5. Clause 4 of the principal order is amended—
(a) in subclause (2) by deleting—
(i) “50.8c” in paragraph (a) and substituting the following—
“ 55.00 ”;
(ii) “51.8c” in paragraph (b) and substituting the following—
“ 56.00 ”;
and
(iii) “51.8c” in paragraph (c) and substituting the following—
“ 56.00 ”;
and
(b) in subclause (4) by deleting “second column or” in paragraph (c) and substituting the following—
“ second column of ”.
