## Extension of Mandurah Regional Country Water Area.

## ORDER IN COUNCIL.

WHEREAS it is enacted by section 8 of the Country Areas Water Supply Act 1947, that the Governor may by Order in Council alter or extend a Country Water Area; now therefore His Excellency the Governor by and with the advice and consent of the Executive Council does hereby extend the boundaries of the Mandurah Regional Country Water Area as presently constituted so as to include in that Country Water area the portion of the State defined in the Schedule herewith.

## Schedule.

## Extension to Mandurah Regional Country Water Area.

All that portion of land bounded by lines starting from the south western corner of Lot 105 of Cockburn Sound Location 16, as shown on Lands Titles Office Plan 741 (1), a present north western corner of Mandurah Regional Country Water Area and extending generally north easterly along the High Water Mark of the Indian Ocean to the north western corner of Lot 3, as shown on Lands Titles Office Plan 3064; thence easterly along the northern boundary of that lot and onwards to a south eastern side of Mandurah Road; thence south westerly along that side to the south western corner of Lot 1, as shown on Lands Titles Office Plan 12382; thence easterly along the southern boundary of that lot to the prolongation northerly of the eastern boundary of Lot 100, as shown on Lands Titles Office Plan 741 (2); thence southerly along that prolongation to the northeastern corner of Lot 100; thence westerly 259.91 metres along the northern boundary of that lot; thence 226 degrees 35 minutes 42 seconds, 435.67 metres to the north western boundary of Lot 100; thence southerly along that boundary to its south western corner, a point on a present northern boundary of Mandurah Regional Country Water Area and thence westerly along that boundary to the starting point, as bordered green on Plan P.W.D., W.A. 56167-1-1.

## Workers' Compensation and Assistance Act 1981-1984.

## ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by section 160 of the Workers' Compensation and Assistance Act 1981-1984, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer or group of employers proves to the satisfaction of the Minister that such employer or group of employers has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer or group of employers from the operation of that section; and whereas Wynne Meat Industries Group of 49 Albert Street, North Perth being an employer within the meaning of the section has duly, in accordance with the Act, made application for exemption from operation of the section and has satisfied the Minister that it has established a fund for insurance against the said liability, and has deposited at the Treasury a security, to wit, a bond of Six Hundred Thousand Dollars (\$600 000) charged with all payments to become due under the said liability: Now, therefore, His Excellency the Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt Wynne Meat Industries Group of 49 Albert Street, North Perth, from the operation of section 160 of the Workers' Compensation and Assistance Act 1981-1984.

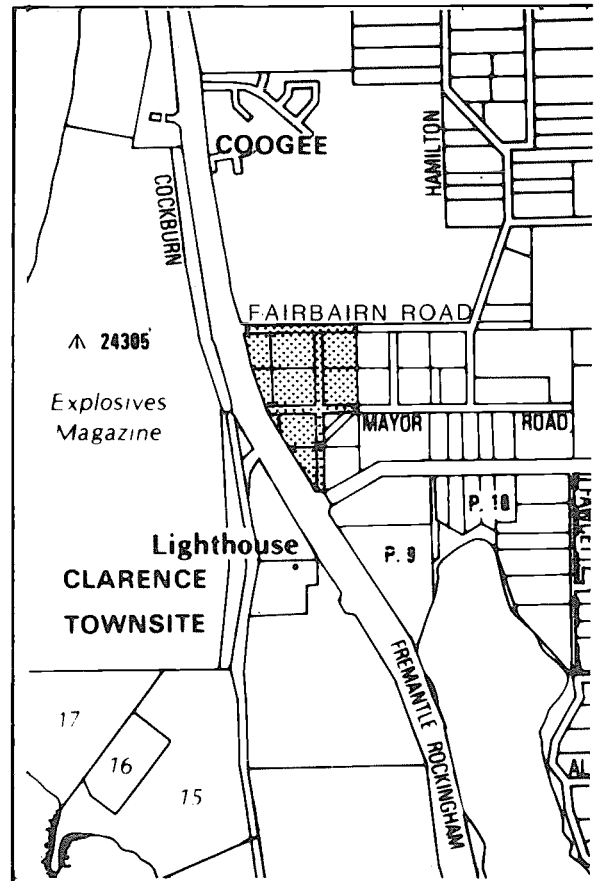

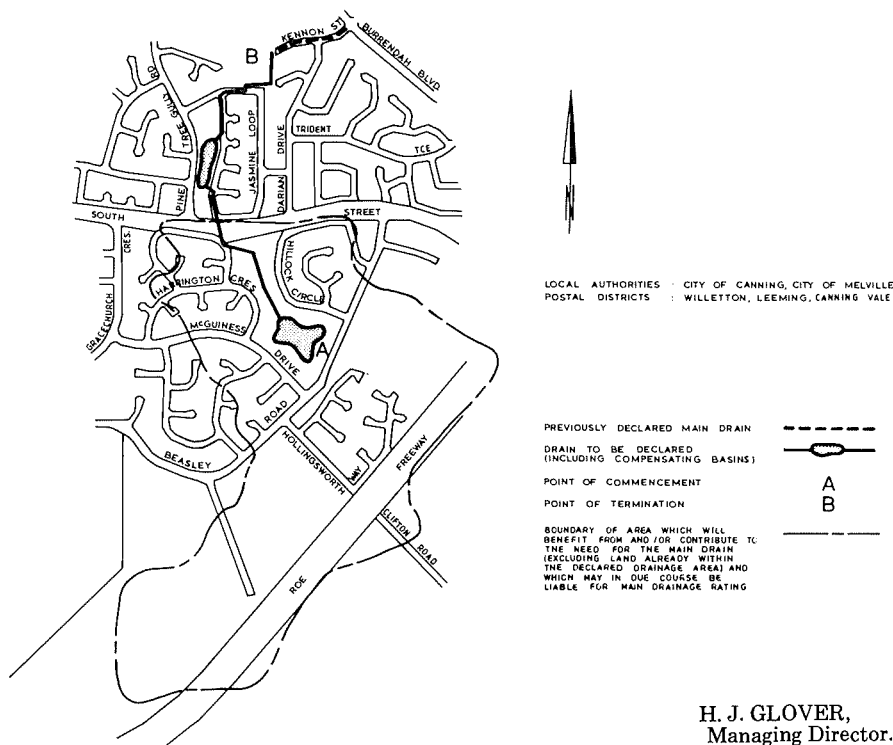

Auditors' Report

We have audited the attached accounts of the Town of Claremont for the year ended 30 June 1984, being the Statement of Receipts and Payments, Balance Sheet, Adjustment Account and Municipal Accumulation Account, in accordance with Australian Auditing Standards.

- The register of fixed assets had not been maintained during the year and we were unable to reconcile the values of Land and Buildings, Furniture and Fittings, Motor Vehicles and Plant as shown in the attached accounts with the values stated in the Register of Fixed Assets. The total value of Fixed Assets shown in the accounts exceeds the total of the Fixed Assets Register by \$194 737 in respect of cost and \$153 585 in respect of net book value.
- As stated in the note to the accounts, provision is no longer made for depreciation of buildings valued at \$1 663 805 in the Balance Sheet. This constitutes a departure from the Australian Accounting Standard in respect of depreciation of non current assets. In our opinion, a provision for depreciation should have been created in respect of buildings with a corresponding charge to the Adjustment Account so as to absorb the cost of the buildings over their useful economic lives. We are unable to determine the amount of depreciation that should have been provided.

3. The Town Clerk's Advance Account had been overdrawn frequently during the year. This contravenes the borrowing provisions of the local Government Act.

Subject to the above, in our opinion—

(a) The accompanying accounts, being the Statement of Receipts and Payments, Balance Sheet, Adjustment Account and Municipal Accumulation Account, are in accordance with the books of the Council and have been prepared in accordance with the provisions of the Local Government Act, Local Government Accounting Directions and the accounting policies stated in Note 1 to the Accounts, so as to give a true and fair view of—

(i) the cash receipts and payments of the Council for the year ended 30 June 1984; and

(ii) the financial position of the Council as at 30 June 1984.

(b) The accounting records required by the Local Government Act to be kept by the Council have been properly kept in accordance with the provisions of that Act.
