Workers' Compensation and Assistance Act 1981-1985.

ORDER IN COUNCIL

WHEREAS it is enacted, *inter alia*, by section 160 of the Workers' Compensation and Assistance Act 1981-1985, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer or group of employers proves to the satisfaction of the Minister that such employer or group of employers has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer or group of employers from the operation of that Section.

And whereas CSBP and Farmers Limited of 105 St. George's Terrace, Perth, being an employer within the meaning of the section has duly, in accordance with the Act, made application for exemption from operation of the Section and has satisfied the Minister that it has established a fund for insurance against the said liability, and has deposited at the Treasury a security, to wit, a bond of Seven Hundred and Fifty Thousand Dollars (\$750 000) charged with all payments to become due under the said liability:

Now, therefore, the Lieutenant-Governor and Deputy of the Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt CSBP and Farmers Limited of 105 St. George's Terrace, Perth, from the operation of section 160 of the Workers' Compensation and Assistance Act 1981-1985.

Resolution to Amend and Submit By-law for Confirmation by the Governor.

The City of Perth Health By-law.

IN pursuance of the powers conferred upon it by the abovenmentioned Act and of all other powers enabling it the Council of the abovementioned Municipality hereby records having resolved on 19 November 1984 to make and submit for confirmation by the Governor the following amendments to the City of Perth Health By-law:

1. That Division 1 of Part 2 be deleted and the following new Division substituted therefor:

DIVISION 1 — SANITARY CONVENIENCES

Definitions

1. In this Division of this By-law, unless the context otherwise requires, the expression "dwelling house" shall have the same meaning as is given to it in the Sewerage (Lighting, Ventilation and Construction) Regulations 1971.

Dwelling House.

2. Every dwelling house shall be provided with at least one water closet.

Premises.

3. All premises other than a dwelling house shall be provided with sanitary conveniences in accordance with the following tables for the sole use of male persons employed or engaged on the premises in connection with any business or operation conducted therein.

Construction.

- 5. Every sanitary convenience on any premises shall be constructed in accordance with the following requirements:
 - (a) A water closet for use by males shall not adjoin any water closet for use by females unless such closets are separated by a wall of brick, stone or concrete extending from floor to ceiling and being not less than 100 mm in thickness.
 - (b) The entrance to each sanitary convenience shall bear a sign to indicate for which sex its use is intended.

Building with Two or More Floors.

6. Every building having two or more floors shall be provided with toilet accommodation on at least alternate floors.

Temporary Works.

7. When any persons are temporarily engaged on works at any place, the occupier of such place and the employer of such persons shall provide one temporary privy for every 20 such persons.

Cleanliness

8. The occupier of every premises shall at all times keep or cause to be kept clean and in good condition and repair all sanitary conveniences and sanitary fittings.

General

- 9. No person shall prevent or attempt to prevent any person who is resident or employed in a house from using any sanitary convenience provided for the use of such resident or employee.
- 10. Every person using a public sanitary convenience provided by the Council shall pay such charge as may from time to time be imposed by the Council for the use thereof.
- 11. The occupier of premises where a public sanitary convenience is provided shall provide therein electric lighting constantly from sunset for so long as the convenience remains open to the public."

2. That Part 4 be deleted and the following new Part substituted therefor:

PART 4 — EATING-HOUSES.

Definitions

1. In this Part of this By-law, unless the context otherwise requires:

"licence" means a licence to conduct an eating house issued by the Council pursuant to this Part of this By-law.

"restaurant" means any eating-house wherein meals are consumed by the public but does not include a tea room or take-away food premises.

"Schedule" means a Schedule to this Part of this By-law.

"take-away food premises" means any eating-house where meals are only served or prepared for service in a state in which they may be taken away from the eating-house and consumed in the state in which they are served or prepared for service but does not include the following:

- (a) any eating-house in which meals are served at tables;
- (b) any tea room; or
- (c) any eating-house where the only meals served are confectionary.

"tea room" means any eating-house where the only meals served or prepared for service are tea, coffee and similar beverages, all products of whole sale pastry cooks, sandwiches, buns and bread rolls containing filling which do not require cooking on the premises, toast, salads, cold meats, boiled, scrambled and poached eggs, omelettes, saveloys boiled in water, beef tea, and other extracts or soups, and food supplied in tins or similar containers which need only to be heated to be prepared for service.

The terms "eating-house", "meals", "prescribed date" and "proprietor" shall have the same meanings as are given to them in Section 160 of Division 3 of Part V of the Act.

Classification.

- 2. For the purposes of this By-law eating-houses are classified as:
 - (1) restaurants;
 - (2) take-away food premises; and
 - (3) tea rooms.

Prescribed Date.

- 3. (1) For the purpose of Section 162 of the Act the prescribed date is hereby fixed as the 30th day of June 1985.
- (2) For the purpose of Section 163 of the Act the 30th day of June in each year is hereby prescribed as the date on or before which the registration of an eating-house and a licence for the proprietor of an eating-house shall be applied for annually.

Registration of an Eating House.

- 4. (1) Any person seeking the registration of an eating-house shall make application in the form prescribed in the First Schedule and shall forward the application to the Town Clerk together with:
 - (a) the fee prescribed in the Sixth Schedule;
 - (b) a floor plan and specifications of the eating-house which plan and specifications shall include the following details:
 - (i) the use of every room:
 - (ii) the structural finishes of every wall, floor and ceiling;
 - (iii) the position and type of every fitting and fixture;
 - (iv) all sanitary conveniences, changerooms, ventilating systems, drains, grease traps and provisions for waste disposal; and
 - (v) the number and sex of every person, including the proprietor or proprietors, engaged in the preparation, manufacture, processing, cooking or serving of meals
- (2) Where a person makes application for the registration of an eating-house in respect of which a certificate of registration is extant at the date of the application, the person shall not be required to forward the plan and specifications referred to in paragraph (b) of Sub-clause (1) of this Clause.
- (3) A certificate of registration granted by the Council under this Part of the By-law shall be in the form of the Second Schedule.

Licence to Conduct an Eating-House.

- 5. (1) The proprietor of an eating-house seeking the issue of a licence shall make application in the form prescribed in the Third Schedule and shall forward the application to the Town Clerk together with the fee prescribed in the Sixth Schedule.
 - (2) Where there are two of more proprietors of an eating-house:
 - (a) each proprietor shall make application for a licence in the form prescribed in the Third Schedule; and
 - (b) the licence shall issue in the joint names of the applicants.
 - (3) A licence shall be in the form of the Fourth Schedule.
- (4) Any person seeking the transfer of a licence shall make application in the form prescribed in the Fifth Schedule and shall forward the application to the Town Clerk together with the fee prescribed in the Sixth Schedule. The application shall be signed by the proposed transferee of the licence and the holder of the licence.

Licence Conditions.

- 6. (1) A licence shall be issued upon and subject to the following conditions:
 - (a) The holder of the licence shall display the licence and the certificate of registration and the certificate of registration of the eating-house in a conspicuous place in the eating-house and shall, upon the request of a Health Surveyor to do so, produce to him the licence and the certificate of registration.

- If the holder of the licence changes his place of residence he shall within 14 days thereafter give notice in writing to the Town Clerk specifying in such notice his new place of residence.
- The holder of the licence shall notify the Council in writing of any alteration, addition or other work relating to the construction, drainage of ventilation of the eating-house forthwith upon the commencement of such alteration, addition or other work.
- The holder of the licence shall notify the Council of any circumstances existing on the eating-house which gives rise to the possibility that food may be, or has been contaminated on any part of the eating-house used for the storage, manufacture, preparation, processing, inspection, handling, packaging or sale of food, forthwith upon such circumstances arising.
- (2) The holder of the licence shall comply with and observe the conditions of the licence imposed under this Clause.

7. Subject to Clause 26 hereof: the proprietor of an eating-house shall ensure that the kichen or room where food is prepared, manufactured, processed or cooked has a floor area of not less than 16 square metres or not less than 25 per centum of the floor area of the room or rooms and any outside area where meals are served to or consumed by the public, whichever floor area is the greater.

Sanitary Conveniences — Public.

Subject to Clause 26 hereof: (1) the proprietor of a restaurant shall provide for use by the public, sanitary conveniences in accordance with the following table:

Sanitary Conveniences — General.

- 11. The proprietor of an eating-house shall:(1) Provide and maintain at all times an adequate supply of hot and cold water, soap and nail brushes for the use of persons using sanitary conveniences.
 - (2) Provide a clean and sanitary towel for the use of every person using sanitary
 - Cleanse daily and at all times keep and maintain all sanitary conveniences and sanitary fittings in a clean and sanitary condition.
 - Not permit, suffer or cause any kitchen or room where meals are prepared, manufactured, processed or cooked to communicate directly by means of a door, window or other opening with a sanitary convenience.
 - Provide and maintain at all times at the entrance to each sanitary convenience a sign to indicate for which sex its use is intended.

Wash Hand Basins,

- The proprietor of an eating-house shall provide a wash hand basin in every kitchen and room where food is manufactured, processed, cooked or prepared for service.

 - 13. (1) In this Clause:
 "wash hand basin" means a wash hand basin provided under Clause 12 hereof.
 (2) The proprietor of an eating-house shall:
 (a) Provide and maintain at all times an adequate supply of:

 - - (i) hot and cold water to every wash hand basin; and
 - (ii) soap and nail brushes at every wash hand basin.
 - Provide a clean and sanitary towel for the use of every person using a wash hand basin.
 - Not cause, suffer or permit any wash hand basin to be used for any purpose other than personal ablutions.
 - Not install any wash hand basin under a counter, table, cabinet, console or console

Change Rooms.

- The proprietor of a restaurant shall:
 - (1) Provide a separate change room for the use of each sex of persons engaged in the preparation, manufacture, processing, cooking or serving of meals.
 - Ensure that every change room provided under this Clause has a floor area of at least 3 square metres with an additional 0.75 square metres for each male or female such persons, as the case may be, in excess of 4.

Garbage Room and Receptacles.

- 15. (1) In this Clause: "receptacle" means a receptacle for the temporary deposit of waste food, garbage or refuse.
- (2) The proprietor of an eating-house shall:
 - (a) Subject to Clause 26 hereof provide a room for the storage and cleaning of receptacles and ensure that such room:
 - is of sufficient size to store all receptacles used in connection with the eatinghouse; and
 - has a floor area of not less than 3 square metres or not less than 10 per centum of the floor area of the room or rooms where food is prepared, manufactured, processed or cooked, whichever area is the greater.
 - (b) Ensure that all receptacles have close fitting lids and are constructed of galvanised iron or other non-absorbent and non-corrosive material.
 - Provide receptacles of sufficient number to contain all waste food, garbage and refuse which accumulates or may accumulate on the eating-house.
 - Not deposit any waste food, garbage or refuse in any place other than a receptacle.
 - Subject to Clause 26 hereof store and cleanse all receptacles only in a room provided in accordance with this Clause.
 - Thoroughly cleanse and deodorise all receptacles at least once every day.
 - Keep or cause to be kept all receptacles thoroughly clean and in good condition and (g) repair.
 - Ensure that every receptacle is kept free of flies, maggots, cockroaches, rodents and vermin at all times.
 - Not cause, suffer or permit any receptacle to be uncovered at any time except when the lid of the receptacle is removed for depositing any waste food, garbage or refuse and cause every such lid to be replaced immediately following the deposit of such waste food, garbage or refuse.

16. The proprietor of an eating-house shall not cause, suffer or permit any food contained in a package, tin or container or any cooking, eating or drinking utensil to be stored in any place other than a cabinet, cupboard or shelf

Exhaust Ventilation.

The proprietor of an eating-house shall provide, maintain and clean a hood for the exhaust ventilation of every stove, oven, cooking fire, cooking apparatus and similar appliance in accordance with the provisions of the Act and any regulations and by-laws made thereunder.

Outside Area — Paving.

- The proprietor of an eating-house shall not use any outside area for serving meals to the public unless the following requirements are complied with:
 - The whole of the area used for such purpose and a space of 2.4 metres beyond it in all directions shall be paved with impervious material which shall have a fall of not less than 1 in 120 to an impervious channel discharging over a trapped gully and properly connected to a drain.
 - The surface of any paved outside area shall be finished smoothly and evenly so as to afford no lodgment for liquids.

Cleanliness.

- 19. The proprietor of an eating-house shall:(1) At all times keep or cause to be kept clean and in good condition and repair the floors, walls, ceilings and all other portions of the eating-house and all fixtures and fittings, stoves, ranges, cooking, eating and drinking utensils, implements, shelves, counters, tables, benches, bins, cabinets, sinks, drain-boards, drains, grease-traps, tubs, vessels and other things used on the eating-house or in connection with the preparation or storage of food therein.
 - (2) Keep all portions of the eating-house free from any unwholesome or offensive odour arising from the eating-house or the operations carried on therein.
 - Maintain in a clean and tidy condition all yards, footpaths, passage ways, paved areas, stores or outbuilidngs used in connection with the eating-house.
 - Cleanse daily and at all times keep and maintain all sanitary conveniences and all sanitary fittings and grease traps on the premises in a clean and sanitary condition.

Rats and Vermin.

- 20. The proprietor of an eating-house shall:
 - (1) ensure that the eating-house and every room and part thereof is kept free at all times from rodents, cockroaches, flies, spiders, insects, ants, moths and vermin.
 - Provide at all times all effective means and methods for the eradication and prevention of rodents, cockroaches, flies, spiders, insects, ants, moths and vermin.

Contamination.

- 21. The proprietor of an eating-house shall:
 - Not cause, suffer or permit:
 - (a) any person to sleep; and
 - any bed or bedding to be kept, housed, stored or accommodated, (b) in any kitchen or room where food is prepared, manufactured, processed, cooked
 - Not cause, suffer or permit any food, which is unsound, unwholesome, contaminated, putrescent or weeviled to be used for or in the preparation of any meal.
 - Cause any food which is unsound, unwholesome, contaminated, putrescent or weeviled to be immediately withdrawn from sale, stock or use and to be disposed of in a garbage receptacle.
 - Not cause, suffer or permit any spittoon or any article or thing for like use to be placed on the premises.
 - Cause all drinking straws to be protected from contamination by flies, dust or other sources
 - Cause all food to be at all times protected from the direct rays of the sun.
 - Cause any brine or pickle used for the pickling of meat to be removed as often as is necessary to prevent it from becoming offensive.
 - Ensure that no person shall have his or her torso bare whilst engaged in the manufacture, preparation, processing, cooking or serving of meals.
 - Not cause, suffer or permit any food to be prepared, manufactured, processed, cooked or stored in any room wherein any water closet or urinal or any wash hand basin for use in connection with the same is situated.
- 22. No person shall prepare, manufacture, process, cook, store, pack or serve any food in any eating-house in which any work is carried on that may or is likely to contaminate such food or affect its wholesomeness or cleanliness.

Tableware.

- 23. The proprietor of an eating-house shall:
 - (1) Cause all table linen, place-mats and other table coverings to be kept in a clean and sanitary condition.
 - Not place or suffer or permit to be placed upon a table or before a person, any table napkin or serviette which is unclean or which has been used by another person unless it has been washed and laundered since the last such occasion of use.

Fuel Storage

- 24. The proprietor of an eating-house shall:
 - (1) Store and keep all wood, coal and coke used as fuel, in a store separated from the eating-house and constructed of brick walls and concrete floor.
 - Not use, keep or store or permit to be used, kept or stored any petrol, bottles or containers of liquified petroleum gas, kerosene, benzine, naphtha, alcohol, mineralised or methylated spirit or any volatile liquid (not being an article of food) in any kitchen or room where food is prepared, manufactured, processed, cooked or stored.

Accommodation of Public.

25. The proprietor of any eating-house shall not cause, suffer or permit a greater number of persons to be accommodated in any room or rooms wherein meals are consumed by the public than will allow of a ratio of one person to every 1 square metre of the floor area of such room or rooms.

Exemptions.

- 26. (1) The proprietor of an eating-house which was registered as a dining room or tea room under this By-law immediately prior to the prescribed date, may apply in writing to the Council for an exemption from compliance with the whole or any part of the requirements of Clauses 7, 8(1), 8(2), 15(2)(a) or 15(2)(e) of this Part of this By-law.
 - (2) The Council may in its discretion grant or refuse an exemption under this Clause.
 - (3) An exemption granted under this Clause shall be signed by the Town Clerk and shall state:
 - (a) the eating-house to which the exemption applies;
 - (b) the requirements of Clauses 7, 8(1), 8(2), 15(2)(a) or 15(2)(e), compliance with which is exempted; and
 - (c) the period during which the exemption shall apply.

Penalties.

27. A person committing any breach of this Part of this By-law or failing to comply with any of the requirements of this By-law commits an offence and shall be liable to a penalty not exceeding \$100.00 and where such breach is of a continuing nature to an additional daily penalty not exceeding \$4.00 for every day during which the breach is continued.

Sanitary Conveniences — General

- 4. The occupier of food handling premises shall:
 (1) Provide and maintain at all times an adequate supply of hot and cold water, soap and nail brushes for the use of persons using a sanitary convenience.
 - (2) Provide a clean and sanitary towel for the use of every person using a sanitary convenience.
 - (3) Cleanse daily and at all times keep and maintain all sanitary conveniences and sanitary fittings in a clean and sanitary condition.
 - Not permit, suffer or cause any kitchen or room where food is distributed, manufactured, inspected, prepared, sold or exposed for sale to communicate directly by means of a door, window or other opening with a sanitary convenience.

Wash Hand Basins.

- 5. The occupier of food handling premises shall provide a wash hand basin in every kitchen and room where food is distributed, manufactured, inspected and prepared.

6. (1) In this Clause:
"wash hand basin" means a wash hand basin provided under Clause 5 hereof.

- The occupier of food handling premises shall:
 (a) Provide and maintain at all times an adequate supply of:
 - (i) hot and cold water to every wash hand basin; and
 - (ii) soap and nail brushes at every wash hand basin.
- (b) Provide a clean and sanitary towel for the use of every person using a wash hand basin.
- (c) Not cause, suffer or permit any wash hand basin to be used for any purpose other than personal ablutions.
- Not install any wash hand basin under a counter, table, cabinet, console or consoletable.

Garbage Room and Receptacles.

- 7. (1) In this Clause:
 - "receptacle" means a receptacle for the temporary deposit of waste food, garbage or
- (2) The occupier of food handling premises shall:
 - (a) Subject to Clause 17 hereof provide a room for the storage and cleaning of receptacles and ensure that such room:
 - is of sufficient size to store all receptacles used in connection with the food handling premises; and
 - has a floor area of not less than 3 square metres or not less than 10 per centum of the floor area of the room or rooms where food is manufactured, inspected, prepared, sold or exposed for sale, whichever area is the greater.
 - Ensure that all receptacles have close fitting lids and are constructed of galvanised iron or other non-absorbent and non-corrosive material.
 - Provide receptacles of sufficient number to contain all waste food, garbage and refuse which accumulates or may accumulate on the food handling premises.
 - Not deposit any waste food, garbage or refuse in any place other than a receptacle.
 - Subject to Clause 17 hereof store and cleanse all receptacles only in a room provided in accordance with this Clause.
 - Thoroughly cleanse and deodorise all receptacles at least once every day.
 - Keep or cause to be kept all receptacles thoroughly clean and in good condition and (g) repair.
 - Ensure that every receptacle is kept free of flies, maggots, cockroaches, rodents and vermin at all times.
 - Not cause, suffer or permit any receptacle to be uncovered at any time except when the lid of the receptacle is removed for depositing any waste food, garbage or refuse and cause every such lid to be replaced immediately following the deposit of such waste food, garbage or refuse.

Storage Facilities.

8. The occupier of food handling premises shall not cause, suffer or permit any food contained in a package, tin or container or any cooking, eating or drinking utensil to be stored in any place other than a cabinet, cupboard or shelf.

Exhaust Ventilation.

9. The occupier of food handling premises shall provide, maintain and clean a hood for the exhaust ventilation of every stove, oven, cooking fire, cooking apparatus and similar appliance in accordance with the provisions of the Act and any regulations and by-laws made thereunder.

Cleanliness.

10. The occupier of food handling premises shall:

- At all times keep or cause to be kept clean and in good condition and repair the floors, walls, ceilings, and all other portions of the food handling premises and all fixtures and fittings, stoves, ranges, cooking, eating and drinking utensils, implements, shelves, counters, tables, benches, bins, cabinets, sinks, drain-boards, drains, grease-traps, tubs, vessels and other things used on the food handling premises or in connection with the carriage, storage, distribution, manufacture, inspection, preparation, sale or property for sale of food therein. exposure for sale of food, therein.
- (2) Keep all portions of the food handling premises free from any unwholesome or offensive odour arising from the food handling premises or the operations carried on therein.
- Maintain in a clean and tidy condition all yards, footpaths, passage ways, paved areas, stores or outbuildings used in connection with the food handling premises.

Rats and Vermin

- 11. The occupier of food handling premises shall:
 - (1) Ensure that the food handling premises and every room and part thereof is kept free at all times from rodents, cockroaches, flies, spiders, insects, ants, moths and vermin.
 - Provide at all times all effective means and methods for the eradication and prevention of rodents, cockroaches, flies, spiders, insects, ants, moths and vermin.

Contamination

- The occupier of food handling premises shall:
- (1) Not cause, suffer or permit:
 - any person to sleep, and (a)
 - (b) any bed or bedding to be kept, housed, stored or accommodated, in any kitchen or room where food is stored, distributed, prepared, manufactured, inspected, prepared, sold or exposed for sale.
- Cause any food which is unsound, unwholesome, contaminated, putrescent or weeviled to be immediately withdrawn from sale, stock or use and to be disposed of in a garbage
- Not cause, suffer or permit any spittoon or any article or thing for like use to be placed on the premises
- Not cause, suffer or permit any food to be prepared, manufactured, processed, cooked or stored in any room wherein any water closet or urinal or any wash hand basin for use in connection with the same is situated.
- No person shall store, distribute, manufacture, inspect, prepare, sell or expose for sale any food in any food handling premises in which any work is carried on that may or is likely to contaminate such food or affect its wholesomeness or cleanliness.
 - 14. The occupier of food handling premises:
 - (a) shall cause all drinking straws to be protected from contamination by flies, dust or other sources
 - shall cause all food to be at all times protected from the direct rays of the sun.
 - shall cause any brine or pickle used for the pickling of meat to be removed as often as is necessary to prevent it from becoming offensive.
 - shall ensure that no person shall have his or her torso bare whilst engaged in the manufacture, preparation, processing, cooking or serving of food or drink.

Fuel Storage.

- 15. The occupier of food handling premises shall:
- Store and keep all wood, coal and coke used as fuel, in a store separated from the food handling premises and constructed of brick walls and concrete floor
- Not use, keep or store or permit to be used, kept or stored any petrol, bottled liquified petroleum gas, kerosene, benzine, naphtha, alcohol, mineralised or methylated spirit or any volatile liquid (not being an article of food) in any kitchen or room where food is prepared, manufactured, processed, cooked or stored.

Food Vending Machines.

- 16. No person shall install, operate or maintain any food vending machine for use by the public otherwise than in compliance with the following requirements:
 - All food, cups, containers, bags and wrappers shall be stored in the machine so as to be protected from the possibility of contamination by dust, insects, vermin and
 - every portion of the machine used for the storage of food, cups, containers, bags and wrappers shall be constructed of smooth, impervious material and free of open joints, cracks and crevices;
 - the machine shall be of such construction as to be easily cleaned internally and externally:
 - the machine shall be:
 - mounted on wheels or castors or on metal legs not of less than 150 millimetres in height;
 - sealed on to the surface of the floor;
 - a receptacle for the temporary deposit of waste food, garbage or refuse shall at all times be kept adjacent to the machine.

Exemptions

- 17. (1) The occupier of any premises which were established, used or conducted as food handling premises under this By-law immediately prior to the 1st day of July 1985, may apply in writing to the Council for an exemption from compliance with the whole or any part of the requirements of Clauses 2, 7(2)(a) or 7(2)(e) of this Part of this By-law.
 - (2) The Council may in its discretion grant or refuse an exemption under this Clause.
 - (3) An exemption granted under this Clause shall be signed by the Town Clerk and shall state:
 - (a) the premises to which the exemption applies;
 - the requirements of Clauses 2, 7(2)(a) or 7(2)(e), compliance with which is exempted; and

- (5) In addition to any firebreaks required in paragraphs (1), (2), (3) and (4) herein, you shall clear off all inflammable material from the whole of the land occupied by drums used for the storage of inflammable liquid, whether the drums contain inflammable liquid or not, including any land on which ramps for holding the drums are constructed, and an area outside the land so occupied to a distance of not less than three metres.

cartons, paper and like inflammable materials, rubbish and also any combustible matters, but does not include green standing trees, or growing bushes and plants in gardens or lawns.

The penalty for failing to comply with this Notice is a fine not exceeding \$400, and a person in default is liable, whether prosecuted or not, to pay the cost of performing the work directed in this Notice if it is not carried out by the owner or occupier by the date required by this Notice. By-Laws relating to the establishment, maintenance and equipment of Bush Fire Brigades.

Establishment of Brigade

- (a) By resolution, the Council may establish, maintain and equip a bush fire brigade under the provisions of the Bush Fires Act 1954 and regulations thereunder, the brigade shall be formed in accordance with these by-laws; and a name shall be given to the brigade. Details of the brigade and its officers shall be entered in the register of Bush Fire Brigades held by the Council.
 - (b) A bush fire brigade may be established for the whole of the Shire or for any specified area thereof.

Appointment of Officers

- 2. The Council shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants as it shall deem necessary to act as officers of the brigade.
- Members of the Brigade shall elect a person to act as Secretary to the Brigade and shall inform the Council accordingly.
- 4. The Council may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Council for the purposes of the brigade. Such officer may station such equipment at a depot approved by the captain.

Powers and Duties of Officers

5. The powers and duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act, 1954 and each officer so appointed shall be supplied with a copy of the Act and regulations.

Membership of Brigade

- 6. (1) The membership of a bush fire brigade may consist of the following:
 - (a) subscribing members; and
 - (b) firefighting members;
 - (2) Subscribing members shall be those persons, who being interested in forwarding the objects of the brigade, pay an annual subscription to the funds of the brigade at the following rates:
 - owner or occupier of land within the brigade area — minimum subscription of \$10.00
 - (ii) other persons minimum subscription of \$10.00.
 - (3) Fire fighting members shall be those persons, being able bodied persons over 16 years who are willing to render service at any bush fire when called upon; and who sign an undertaking in the form contained in the First Schedule to these By-laws.
 - (4) No fees or subscriptions shall be payable by firefighting members and the enrolment of persons as such members shall in every case be subject to the approval of the Council.
 - (5) A subscribing member shall be eligible for enrolment as a firefighting member.

Finance

7. The expenditure incurred by the Council in the purchase of equipment payment for services and generally for the purpose of this Act, shall be a charge on the ordinary revenue of the Council and records of such expenditure shall be maintained in accordance with Municipal audit requirements.

Meetings of Brigades

8. Meetings will be held as necessary.
