PETROLEUM PRODUCTS PRICING ACT 1983.

PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 10) 1985.

MADE by the Prices Commissioner under section 12.

- Citation. 1. This order may be cited as the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 10) 1985.
- Commencement. 2. This order shall take effect on the day on which it is published in the *Gazette*.
- Interpretation. 3. In this order—
“the principal order” means the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984*.
- Clause 4 amended. 4. Clause 4 of the principal order is amended in subclause (2) by deleting—
(a) “55c” in paragraph (a) and substituting the following—
“ 53.4c ”;
(b) “56c” in paragraph (b) and substituting the following—
“ 54.4c ”; and
(c) “56c” in paragraph (c) and substituting the following—
“ 54.4c ”.
- Schedule repealed and substituted. 5. The Schedule to the principal order is repealed and the following Schedule is substituted—
