West Coast Rock Lobster Fishery.

1. In this notice the notice relating to the West Coast Rock Lobster Fishery given pursuant to section 32 of the Fisheries Act 1905, and published in the *Government Gazette* on 22 October 1975, and amended by notices published from time to time thereafter is referred to as the principal notice.

(2a) The number of pots that a boat is currently licensed to operate shall be displayed in figures on each side of the wheelhouse of that boat. In the event that a boat does not have a wheelhouse then the number of pots that it is currently licensed to operate shall be displayed on either side of the hull immediately before the boat registration prefix. The figures required to be indicated on the boat shall be black on a white background and be not less than 150 millimetres in height and not less than 60 millimetres in width.

5. Shall not be used for the processing of marron (*Cherax tenuimanus*) unless a license is held under section 39C of the Fisheries Act 1905.

6. Shall not be used for the processing of fish or crustacea caught by any other vessel.

In accordance with the provisions of section 35K any person aggrieved by this decision, may within fourteen days after publication of this notice, appeal against the decision or order by serving on the Minister for Fisheries a statement in writing on the grounds of their appeal.

BUSH FIRES ACT 1954.

City of Bunbury

Important Information Relating to Your Responsibility as a Landholder in the City of Bunbury.

PURSUANT to the powers contained in section 33 of the Bush Fires Act 1954 you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 14 December 1985 and kept maintained throughout the summer months until 31 March 1986.

An inspection of firebreaks and hazard removal will be carried out in all areas of the City by an authorised Officer.

Persons who fail to comply with the requirements of this order, may be issued with an infringement notice (penalty \$40) or prosecuted with an increased penalty, and additionally, council may carry out the required work at cost to the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks as required by this notice or if natural features render firebreaks unnecessary, you may apply to the council or its duly authorised officer not later than 25 November 1985 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the council or its duly authorised officer, you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

Requirements.

1. Rural and Townsite Land (includes residential, commercial and industrial).

- (a) Where the area of the land is 2 024m² (approximately ½ acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land, and
- (b) Where the area of land exceeds 2 024m² provide firebreaks at least 3 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings and haystacks situated on the land. Where several adjoining lots are held or used by the owner-occupier, the firebreaks may be provided inside and along the external boundaries of the group or lot.

2. Special Rural Land: The owners of all small rural holdings zoned as Special Rural under Town Planning Schemes must maintain clear of all flammable material, a firebreak not less than three (3) metres wide immediately inside all external boundaries of the land.

3. Fuel and/or Gas Depots: In respect of land owned and/or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall have the land clear of all flammable material.

Notice to all Owners and/or Occupiers of Land in the Shire of Albany.

PURSUANT to the powers contained in section 33 of the Bush Fires Act 1954, you are hereby required to have all firebreaks clear of inflammable material, such firebreaks to be not less than 3 metres in width within that portion of the Shire lying generally north of the dividing line defined hereunder and 2 metres in width within that portion of the Shire lying generally south west of the dividing line defined hereunder, and constructed by one or more of the following methods—ploughing, cultivation, scarifying, burning or chemical spraying. In addition you may be required to carry out further works which may be deemed necessary and specified by way of separate written notice forwarded to the address of the owner/occupier as shown on the rate records maintained by the Shire of Albany for the land.

1. Land having an area of 2 100 square metres or less: For all land having an area of 2 100 square metres of less—

- (a) A firebreak is not required—however.
- (b) The land will be inspected by the Fire Control Officer appointed by the Shire of Albany and notice may then be served if action is deemed to be necessary to prevent the outbreak or spread of a bushfire on the land.
- (c) Such land is required to be made safe from fire by the reduction of fire hazards.

Compliance with such requirements need not require the removal of all inflammable materials.

2. All other land:

- (a) You are required to have constructed firebreaks, as specified in this notice.
 - (i) Immediately inside all external boundaries of all land exceeding 2 100 square metres in area whether the land be cleared, partly cleared, bulldozed, chained, used for pasture or be undeveloped.
 - (ii) Immediately surrounding all buildings erected on any land having an area in excess of 2 100 square metres.
- (b) You are required on all land used for and being under crop in the period from 15 November 1985 to 31 March 1986 to:—
 - (i) Have constructed firebreaks, as specified in this notice immediately inside the external boundary of the land being used for crop and around the standing crop, and

All firebreaks as designated above must be prepared on or before 15 November 1985 within that portion of the Shire lying generally north of the dividing line defined hereunder and on or before 15 December 1985 within that portion of the Shire lying generally south-west of the dividing line defined hereunder or within 14 days of the date of your becoming owner or occupier should this be after those dates.

The firebreaks required by this notice are to be maintained clear of inflammable material to and including 30 March, 1986.

Take notice that pursuant to Clause 33 (4) of the Bush Fires Act, where the owner or occupier of land who has received notice fails or neglects to comply with the requirements of the notice within the time specified, the Shire of Albany, may by its officers and with such servants, workmen and contractors vehicles and machinery as the officers deem fit, enter upon the land and carry out the requisitions of the notice which have not been complied with and pursuant to Clause 33 (5) of the Bush Fires Act the amount of any costs and expenses incurred may be recovered from you as the owner or occupier of the land.

Applications to vary the above requirements: If it is considered to be impractical for any reason whatever to carry out works as required by this notice, you may apply to the Council of the Shire of Albany or its duly authorised officer no later than 14 days prior to the date by which the firebreaks are required by this notice for permission to provide firebreaks in an alternative position, to take alternative action to abate the fire hazards on the land or to alter or vary this notice in any other way.

Note: Council, or its duly authorised officer will consider approval of other than firebreaks immediately inside the external boundaries where a more suitable alternative can be provided. Approval of such alternatives will only be considered if submitted with the endorsement of the Bush Fire Brigade for the area concerned and will be on a yearly basis. If permission to vary this order is not granted by the Council or its duly authorised officer, you must comply with the requirements of this notice.

The penalty for failing to comply with this notice is a fine not exceeding \$400 and a person in default is also liable, whether prosecuted or not, to pay the costs of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

Lower Kalgan brigade area—optional perimeter firebreaks.

Council has resolved that owners and/or occupiers of land in the Lower Kalgan brigade area only have the option of installing perimeter firebreaks on their land for a 2 year trial period commencing 1 July 1985.

This approval is for perimeter firebreaks only and removal of fire hazards around buildings etc. and all other requirements of this notice remain in force.

Failure to comply with this or other notice served may result in legal action being taken.

The Dividing Line.

The dividing line in the Shire of Albany shall be a line starting from a point on the north western boundary of Plantagenet Location 5973 situated east of the easternmost south eastern corner of location 5971, a point on a western boundary of the Shire of Albany and extending south westerly and generally easterly along boundaries of the first mentioned location to the south western corner of Location 7117; thence generally easterly along southern boundaries of that location and locations 5973, 4963 and 5975 to the prolongation westerly of the southern boundary of location 5949; thence easterly to, and along that boundary to the westernmost southwestern corner of location 6689; thence northerly along the western boundary of that location and onwards to the southern boundary of location 5950, then easterly along that boundary and the southern boundaries of location 5951 and 6688 to the southeastern corner of the last mentioned location; thence northerly along the eastern boundary of that location to the prolongation westerly of the easternmost northern boundary of location 6475; thence easterly to and generally easterly along the northern boundaries of that location to the northern corner of location 6487; thence generally southeasterly along northeastern boundaries of that location to the prolongation southwestwardly of the northwestern boundary of location 6812; thence north-easterly to and along that boundary to the south-western boundary of location 6463; thence southeasterly along that side to the southern corner of that location; thence easterly to and generally easterly along northern boundaries of location 6491, 6505, 6506 and 6507 to the western boundary of location 6811; thence northerly along that boundary and easterly along the northern boundaries of that location and location 1073 to the westernmost south-western corner of location 6472; thence easterly, southerly, again easterly, northerly and again easterly along boundaries of that location and onwards to the western boundary of the southern severance of location 7013; thence southerly, easterly and again southerly along boundaries of that severance and onwards to the northern boundary of the southern severance of location 3835, and thence easterly and southerly along boundaries of that severance and onwards to the Low Water Mark of the Southern Ocean a point on a southeastern boundary of the Shire of Albany.

BUSH FIRES ACT 1954.

Shire of Augusta-Margaret River.

Notice to all Owners and/or Occupiers of Land in the Shire of Augusta-Margaret River.

WITH reference to section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

Rural Areas: This work must be carried out by 22 December 1985, and kept maintained throughout the summer months until 12 April 1986.

Townsites: This work must be carried out by 1 December 1985, and kept maintained throughout the summer months until 12 April 1986.

An inspection of firebreaks and hazard removal will be carried out in all areas of the Shire by an authorised officer (Townships, after 1 December 1985, rural, after 22 December 1985).

Persons who fail to comply with the requirements of this order may be issued with an Infringement Notice (penalty \$40) or prosecuted with an increased penalty, and additionally, council may carry out the required work at cost to the owner or occupier.

A. Rural Land:

1. A firebreak not less than 2 metres wide must be constructed inside and within 100 metres of the boundary of each property where the boundary is

adjacent to or adjoins a constructed or used surveyed road. (Firebreaks constructed on road verges do not constitute a legal firebreak under the Bush Fires Act and Council approval is required prior to construction of additional firebreaks on roadside verges.)

2. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.
3. Where uncleared land abuts a boundary, a firebreak not less than 2 metres wide must be constructed inside and within 100 metres of such boundaries.

B. Special Rural Land:

1. The owners of all existing small rural holdings zoned as Special Rural in town planning schemes must construct a firebreak not less than 2 metres wide, adjacent to and inside all boundaries.
2. A firebreak not less than 2 metres wide must be constructed within a perimeter of 20 metres of all homesteads, buildings, haystacks and fuel storage areas on the land.
3. Ungrazed pastured land can constitute a fire hazard and orders will be issued under section 33 of the Bush Fires Act, if the hazard is not abated.

C. Pine Plantations: Firebreaks not less than 10 metres wide around the perimeter of land on which pines are planted. Not less than 10 metres in width along those portions of pine plantations which enjoy a common boundary with road reserve and not less than 10 metres in width in such positions that no part or compartment of pine plantation shall exceed 28 hectares in area.

All Other Townsites (Including Molloy Island): In respect of land owned or occupied by you within any townsite or any area subdivided for other purposes, you shall:

1. Where the area of land is 2 024 m² (approximately ½ acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land; and
2. Where the area of land exceeds 2 024 m² (approximately ½ acre) clear of flammable materials, firebreaks of at least 2 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.

Townsites—Gracetown and Prevelly Park: In respect of land owned or occupied within these townships or any area subdivided for other purposes, you shall:—

1. Remove all flammable material (including ground fuel build up) on the whole of the land except living standing trees; or
2. Construct a firebreak of not less than 1.5 metres wide adjacent to and inside both side and rear boundaries together with a firebreak not less than 3 metres in width around all buildings on the land. All fuel residue material from firebreaks that are constructed to be removed from the block.

F. Fuel and/or Gas Depots: In respect of land owned or occupied by you on which is situated any container normally used to contain liquids or gas fuel, including the land on which any ramp or support is constructed, you shall have the land clear of all flammable materials.

If it is considered impractical for any reason to clear firebreaks or remove flammable materials from the land as required by this Notice, you may make written application to the Council not later than 15 November 1985 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. This application must be countersigned by the Bush Fire Control Officer for the area in which the land is situated to signify his agreement to the variation. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

Special Notice to Land Owners and Occupiers: The Council forwards a copy of this Firebreak Order each year. The Notice is also published in the *Busselton-Margaret Times* and copies are available at the office counter.

The aim of the Council is to eliminate destructive bush fires and to this end all areas of the Shire are subject to an overall District Fire Protection Plan, where large scale hazard removal is carried out by the Shire's Bush Fire Brigades. The requirements of the Order are considered to be the minimum standard of fire prevention work required to protect not only individual properties, but the district generally.

In addition to the requirements of this Order, Council may issue separate "special" orders on owners or occupiers if hazard removal is considered necessary in some specific areas.

BUSH FIRE PRECAUTIONS.

Prohibited Burning Times.

The prohibited burning times applying within the Shire are:

22 December 1985 to 28 February 1986.

Restricted Burning Times.

The restricted burning times are:

9 November 1985 to 21 December 1985 and 1 March 1986 to 12 April 1986.

Shire of Boddington.

Firebreak Order.

Important information relating to your responsibility as a landholder in the Boddington Shire.

WITH reference to section 33 of the Bushfires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 15 November 1985 and kept maintained throughout the summer months until 15 April 1986.

An inspection of firebreaks will be carried out in all areas of the Shire by an authorised Officer.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice (penalty \$40) or prosecuted and additionally, Council may carry out the required work at cost of the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials as required by this notice, or if natural features render firebreaks unnecessary, you may apply to the Council in writing not later than 1 November 1985, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council, you shall comply with the requirements of this notice.

Rural Lands.

(a) A firebreak not less than 2.5 metres wide must be constructed along and within 100 metres of the boundary of each property, i.e. cleared or part cleared land, where the boundary is adjacent to or adjoins a constructed or used surveyed gazetted road.

(b) Firebreaks at least 2.5 metres wide must be installed immediately around the perimeter of any crop.

(c) An area 10 metres wide cleared of all flammable material shall be established immediately around the perimeter of all homesteads, buildings, haystacks and fuel storage areas.

(d) Where there is agreement between adjoining land owners for one or the other to provide a firebreak on their boundary this firebreak will be deemed the boundary firebreak of the adjoining property, subject to insurance company approval. Please contact your fire control Officer if any uncertainty arises.

Pine Plantations.

Any pines planted for commercial purposes constitutes a pine plantation and you are hereby required to clear of all flammable materials, firebreaks not less than 10 metres wide around the perimeter of each plantation, and any plantation exceeding 29 hectares will also require a subdivisional firebreak 6 metres in width for each 28 hectares, and bush surrounding planted areas is to be kept in a low fuel condition.

Townsites of Boddington and Ranford.

On or before 15 November 1985, all town lots under 4 000 square metres in area and all fuel depots within the Shire are required to be cleared of all debris and flammable material. Lots 4 000 square metres and over are to have a minimum 2.5 metre firebreak installed immediately inside all external boundaries.

Special Note to Land Owners and Occupiers.

The Council forwards a copy of this firebreak order each year. The notice is also published in the Narrogin newspaper and additional copies are obtainable at the Shire office.

The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally. In addition to the requirements of this order Council may issue separate special orders on owners or occupiers if hazard removal is considered necessary in specific areas.

Shire of Boulder/Town of Kalgoorlie.

Notice to all Owners and/or Occupiers of Land in the Shire of Boulder/Town of Kalgoorlie.

PURSUANT to the powers contained in section 33 of the Bush Fires Act 1954, you are hereby required on or before 31 October 1985 or within fourteen days of your becoming owner or occupier of land should this be after 31 October 1985, to clear firebreaks and remove flammable material from the land owned or occupied by you as specified hereunder and to have the specified land and firebreaks clear of all flammable material from 31 October 1985 up to and including 14 April 1986.

(1) Land Outside Townsites:

1:1 All buildings on land which are outside townsites shall be surrounded by two firebreaks not less than two metres wide cleared of all flammable material, the inner firebreak to be not more than twenty metres from the perimeter of the building or group of buildings and the outer firebreak not less than 200 metres from the inner firebreak.

1:2 to remove flammable material from the whole of the land between the firebreaks required in paragraph 1:1 above.

(2) Land in Townsites:

2:1 Where the area of land is 2 000 square metres (approximately 1/2 acre) or less, all flammable material shall be removed from the whole of the land.

2:2 Where the area of land exceeds 2 000 square metres, firebreaks at least three metres in width shall be cleared of all flammable material immediately inside and along the boundaries of the land. Where there are buildings on the land, additional firebreaks three metres in width shall be cleared immediately surrounding each building.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable material as required by this notice, you may apply to the Council or its duly authorised Officer not later than 15 October 1985, for permission to provide firebreaks in alternative positions or take alternative action to remove or abate fire hazards. If permission is not granted by the Council or its duly authorised Officer, you shall comply with the requirements of this notice. "Flammable material" does not include green growing trees or green growing plants in gardens.

If the requirements of this notice are carried out by burning, such burning shall comply with the relevant provisions of the Bush Fires Act.

The penalty for failing to comply with this notice is a fine of \$400 and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice, if it is not carried out by the owner or occupier by the date required by this notice.

The prohibited burning period will be from 15 December 1985 to 14 April 1986 inclusive.

Firebreak Order.

Notice to all Owners and/or Occupiers of Land
in the Shire of Gnowangerup.

PURSUANT to powers contained in section 33 of the above Act, you are hereby required on or before 1 November 1985 to clear of all inflammable material, firebreaks as stated hereunder and thereafter to maintain the firebreaks clear of inflammable material up to and including 15 April 1986.

1. Prepare firebreaks not less than 3 metres wide within 200 metres of all neighbours boundaries whether such land is cleared, part cleared or uncleared, except where neighbours jointly agree to maintain a single firebreak.

Where this variation is sought a permit is required from the Local Fire Control Officer.

1a. Breaks alongside constructed roads optional, except where the land is sown to crop for harvesting. In such cases where crop is sown, prepare a 3 metre wide break immediately inside the boundary adjoining the crop, or mow for hay, and bale a 6 metre wide strip immediately inside the boundary.

2. Embark on a policy of strategic firebreaks in lieu of property breakdown.

The use of farm roads cleared of inflammable material, graded contours, graded dam catchments all not less than 3 metres wide are acceptable.

Further use of salt creeks, lakes and naturally bare ground will be allowed so that a ratio of 1 kilometre of break per 250 hectares exists.

3. Prepare firebreaks not less than 3 metres wide within 100 metres of, and surrounding all buildings, haystacks and fuel dumps.

4. Prepare fire breaks not less than 10 metres wide immediately around the perimeter of any scrub or timber which has been logged, chained or otherwise prepared for burning, within 7 days of such work being completed.

No area to exceed 400 hectares.

5. In respect of land within any Townsite within the Shire you shall:

- (a) Where the area is 2 000 square metres or less, remove all inflammable material on the land from the whole area of the land.
- (b) Where the area exceeds 2 000 square metres firebreaks not less than two metres wide, shall be prepared immediately inside and along all external boundaries of the land.

Penalty for Non Compliance: \$400.00.

If it is considered to be impracticable for any reason to clear firebreaks as required by this Notice, the approval of the Council must be obtained to clear such breaks in an alternative position. Approval to any such variation will only be granted following inspection and approval by an authorized Bush Fire Control Officer.

It is an offence to provide firebreaks on a road reserve without the approval in writing of the Council or the Main Roads Department in respect to declared main roads.

4. Parallel to and within 100 metres of the perimeter of all buildings, haystacks and fuel ramps situated on the land; and

5. Immediately surrounding any drum or drums or other receptacles situated on the land which are normally used for the storage of fuel whether they contain fuel or not, provided that the firebreak required to comply with this paragraph only shall be not less than 5 metres wide; and

6. Immediately inside land on which bush has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether you intend to burn the bush or not); provided that the firebreak required to comply with this paragraph only, shall be not less than 7 metres wide. Where the land is prepared for clearing by burning after 15 October 1985 you shall provide the firebreak immediately.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to Council or its duly authorised Officer for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council, or its duly authorised Officer, you shall comply with the requirements of this notice. The penalty for failing to comply with this notice is a fine of \$400 and a person in default is also liable, whether prosecuted or not, to pay cost of performing the work directed in this Notice if it is not carried out by the owner or occupier by the date required by this Notice.

If the requirements of this Notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

Firebreak Order—1985-1986

Important information relating to your responsibility as a
landholder in the Murray Shire.

WITH reference to section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order.

This work must be carried out by 30 November 1985 and kept maintained throughout the summer months until the expiration of the restricted burning period, ie: Zone 6 (12/4/1986) Zone 8 (26/4/1986).

An inspection of firebreaks will be carried out in all areas of the Shire by an authorised Officer.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice (penalty \$40) or prosecuted, and additionally, council may carry out the required work at cost to the owner or occupier.

If for any reason it is considered impracticable to comply with the provisions of this order, you may make a written application for variation to the Shire Clerk which must reach him not less than two weeks prior to the date by which the firebreak is required to be established.

No such application will be considered unless it bears the signature of the Fire Control Officer of the area, signifying his agreement to the variation. If the application is not approved by the Shire Clerk, you shall comply with the requirements of this notice.

1. Rural Land (all land other than that listed as Urban): Except where an exemption is granted, a firebreak not less than 2 metres wide must be constructed inside all boundaries where practicable; or

1.1 within 50 metres of the boundaries of all land including that which is uncleared so as to form a continuous break around the holding,

1.2 inside and along the common boundaries of land which abuts a used public road or railway reserve (Note: firebreaks constructed on road reserves do not constitute a legal firebreak),

1.3 not less than 20 metres and not more than 100 metres from the perimeter of all homesteads, buildings, haystacks and fuel storage areas. The area between the firebreaks and the building or haystack must be cleared of all flammable material by 1 December 1985.

2. Notation: Road and Railway Reserves—In addition to Clause 1.1 and 1.2 where land owned or occupied by you is bisected by a road or railway reserve, firebreaks shall be constructed internally and parallel to said road or railway reserve.

3. Urban Land (Residential, Commercial and Industrial land within a townsite or within any area subdivided for residential purposes): In respect of land owned or occupied by you within any townsite or any area subdivided for other purposes, you shall:

3.1 Where the area of land is 2 024 sq m (approximately ½ acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land, and

3.2 Where the area of land exceeds 2 024 sq m (½ acre), provide firebreaks of at least 2 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside and along the external boundaries of the group or lot and the requirements of Items 3.1 and 3.2 shall be maintained throughout the summer months until the expiration of the restricted burning period, ie: Zone 6 (12/4/1986), Zone 8 (26/4/1986).

Note: The following are Townsites within the Shire: Pinjarra, Dwellingup, Coolup, North Dandalup, Yunderup, Furnissdale, Ravenswood (which includes Murray Bend.)

Islands in River Systems.

3.3 Owners and/or occupiers of Island Locations are required on or before 30 November 1985 and thereafter up to and including 12 April 1986, to have a firebreak clear of all flammable material at least 1.8 m (6 ft) wide immediately inside all boundaries of land.

Canal System Locations.

3.4 The requirements of section 3.1 (Townsites) apply where the area of land is 2 024 sq m or less and is subject to owners and/or occupiers complying with the undermentioned conditions—

(i) undeveloped (vacant) lots shall not be ploughed, rotary hoed or cultivated in order that land remains stabilised and not become subject to erosion by wind and water.

4. Fuel and/or Gas Depots: In respect of land owned or occupied by you on which is situated any container normally used to contain liquid, or gas fuel, including the land on which any ramp or supports are constructed, you shall maintain the land clear of all flammable materials.

5. Pine Plantations: Pine plantations established since 30 November 1984 are required to provide firebreaks:—

5.1 Not less than 20 metres wide around the perimeter of each plantation;

5.2 Not less than 20 metres wide along those portions of the plantations which abut a used public road;

5.3 Not less than 20 metres in width in such position that no part or compartment of the plantation exceeds twenty-eight (28) hectares in area.

Special Notice to Land Owners and Occupiers: The Council forwards a copy of this Firebreak Order with rate assessments each year, the notice is also published in the *Coastal District Times*. The aim of the Council is to eliminate destructive bush fires and to this aim, some areas of the Shire are subject to a District Fire Protection Plan where large-scale hazard removal and roadside burning is carried out by the Shire's Bush Fire Brigades and Council workforce.

Special Orders—section 33: The requirements of this order are considered to be the minimum standard of fire prevention work required to protect not only individual properties but the district generally. In addition to the requirements of this order, Council may issue separate special orders on owners or occupiers if hazard removal is considered necessary.

PURSUANT to the powers contained in section 33 of the above Act, you are hereby required on or before 15 October 1985, to remove from the land owned or occupied by you, all inflammable material or to clear firebreaks in accordance with the following, and thereafter to maintain the land of the firebreaks clear of inflammable material up to and including 31 March 1986:

(1) Townsite Land: In respect of the land owned or occupied by you within the townsite of Perenjori, Bowgada, Caron, Latham, Bunjil, or Maya you shall:—

(a) where the area of the land is 0.2 hectares (½ acre) or less, remove all inflammable material on the land from the whole of the land; and

(b) where the area of the land exceeds 0.2 hectares (½ acre), clear of all inflammable material, firebreaks at least 3 metres wide immediately inside all external surrounding boundaries of the land and also immediately surrounding all buildings situated on the land.

(2) Rural Land: In respect of land owned or occupied by you other than within the townsites referred to in paragraph (1) above, you shall clear of all inflammable materials, firebreaks at least 3 metres wide.

(a) Immediately inside all external boundaries of the land and also immediately surrounding any building or groups of buildings and/or haystack situated on the land; and

(b) not less than one chain and not more than five chains from the perimeter of all buildings and/or haystacks or groups of buildings and/or haystacks situated on the land; and

(c) where the area of cropped land exceeds 300 hectares you shall construct additional firebreaks not less than 3 metres wide in such positions as will divide the land into areas of not more than 300 hectares completely surrounded by a firebreak not less than 3 metres wide.

(3) Fuel Dumps: In addition to the firebreaks required by paragraph (1) and (2) above you shall remove all inflammable material from all the land occupied by drums used for the storage of inflammable liquid, whether the drums contain inflammable material or not, including the land on which ramps for the holding of the drums are constructed and to a distance of at least 3 metres outside the perimeter of any drums, stacks of drums, or drum ramp.

If it is considered to be impracticable for any reason to clear firebreaks or to remove inflammable material from the land as required by this notice you shall apply in writing to the Council or its duly authorised officer not later than 15 October 1985, for permission if considered necessary to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. Notice to Owners and Occupiers of Land.

Firebreak Order.

PURSUANT to the powers contained in section 33 of the Bush Fires Act 1954, owners and occupiers of land within the Shire of Victoria Plains are required to, on or before 15 October 1985, remove from the land owned by or occupied by them all inflammable material or to have firebreaks in accordance with the following, and thereafter keep the land or the firebreak clear of all inflammable material up to and including 19 March 1986.

Where adjoining land is in common ownership or occupancy, firebreaks may be constructed so as to encompass such lots collectively. Firebreaks not less than 2.5 metres wide shall be constructed around all buildings and haystacks situated on the land.

3. Fuel Dumps/Tanks/Depots.

Where there are flammable liquid or gas containers on the land, whether such containers are full or empty, owners and occupiers shall:—

- (a) Townsite Land—clear the whole of the land of inflammable material.
- (b) Rural Land—locate such dumps/tanks/ramps not less than 15 metres from any public thoroughfare or improvement upon the land, and construct firebreaks not less than 6 metres in width around and immediately adjacent to all such installations.

4. General.

(a) The term "Inflammable Material" for the purpose of this notice includes bush (as defined in the Bush Fires Act 1954), timber, boxes, cartons, paper and the like, inflammable materials, rubbish and any combustible matter, but does not include buildings, green standing trees, or growing bushes or plants in gardens or lawns.

(b) The penalty for failing to comply with this Notice is a fine of not more than four hundred dollars (\$400) and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this Notice.

(c) If the requirements of this Notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

(d) If it is considered impractical for any reason to clear firebreaks as required by this Notice, you may apply to the Council or its duly authorised officer not later than 5 October 1985, for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this Notice.

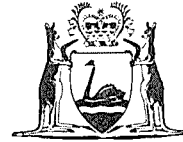
