CONSTRUCTION SAFETY AMENDMENT REGULATIONS (No. 4) 1985.

MADE by His Excellency the Governor in Executive Council.

Citation and principal regulations. 1.

Regulations (No. 4) 1985.
(2) In these regulations the Construction Safety Regulations 1973* are referred to as the principal regulations.

(1) These regulations may be cited as the Construction Safety Amendment

Commencement. Regulation 12 amended.

3. Regulation 12 of the principal regulations is amended by deleting the definition of "ship yard" and substituting the following definition—

2. These regulations shall come into operation on 1 January 1986.

"duplex" means a single storey building or structure that consists of 2 units each of which is used or is intended to be used exclusively as a self-contained private dwelling; ".

Regulation 13 amended.

4. Regulation 13 of the principal regulations is amended-

(a) in subregulation (1) by deleting the definition of "other work" and substituting the following definition—

" "other work" means the alteration, repair, cleaning, painting, renewal, removal or dismantling of a building or structure, but does not include window cleaning or sign repairing. "; and

(b) in subregulation (2)—

- (i) by deleting paragraph (a) and substituting the following paragraph---
 - (a) construction of a building or structure other than—
 - (i) a single storey dwelling;
 - (ii) a duplex; or
 - (iii) a ship; ";
 - (ii) by deleting paragraph (aa) and substituting the following paragraph—

(aa) additions to a building or structure other than—

- (i) a single storey dwelling;
- (ii) a duplex; or
- (iii) a ship or other floating structure; ";
- (iii) by deleting paragraph (d) and substituting the following paragraph— $\!\!\!\!$

(d) other work carried out on a platform at a height exceeding 3 m or in a confined space on a building or structure other than—

- (i) a single storey dwelling;
- (i) a single storey dwennig
- (ii) a duplex; or
- (iii) a ship or other floating structure; ";

and

(iv) by deleting paragraph (k).

Regulation 14 amended.

5. Regulation14 of the principal regulations is amended-

- (a) in subregulation (1)—
 - (i) by deleting paragraph (a) of the table and substituting the following paragraph—
 - (a) Where the value of the contract exceeds \$20 000, construction of, or additions to—
 - (i) a 2-storey dwelling; \$12.50
 - (ii) a single storey building that consists of more than 2 units each of which is used or is intended to be used exclusively as a self-contained private dwelling, for each unit to which the contract relates\$12.50. ";
 - (ii) by deleting paragraphs (b) and (c); and

(iii) by deleting paragraph (ca) and substituting the following paragraph-

(ca) Additions to a building or structure other than those mentioned in paragraph (a) of this table, where the value of the contract— (i) exceeds 20c for each

(b) in subregulation (2) by deleting paragraph (c).

Regulation 16 amended. 6. Regulation 16 of the principal regulations is amended in subregulation (1) by deleting paragraph (a). Regulation 17 amended.

7. Regulation 17 of the principal regulations is amended by deleting "Form 3" and substituting the following—

" Form 24 ".

Form 3 deleted.

8. Form 3 of the principal regulations is deleted.
