Model By-laws Series "A".

General Sanitary Provisions—Part I.

Mobile Rubbish Carts—By-laws.

WHEREAS under the provision of the Health Act 1911 (as amended) a Local Authority may make or adopt by-laws, and may later, amend or repeal any by-laws, so made or adopted: Now therefore, the City of Nedlands being a Local Authority within the meaning of the Act and having adopted the model by-laws described as Series "A" as reprinted pursuant to the Reprinting of Regulations Act 1954, in the *Government Gazette* on 17 July 1963, doth hereby resolve and determine that the said adopted by-laws shall be amended as follows:—

PART 1—GENERAL SANITARY PROVISIONS.

1. The Model By-laws Series "A" as gazetted on 8 April 1927 and amended on 17 July 1963 and adopted by the City of Nedlands on 5 September 1968 are hereinafter referred to as "the by-laws"

2. The by-laws are amended by repealing By-laws 12, 13, 14 and 15a inclusive (Note—The above by-laws deal with the provision of receptacles, covering of refuse, carrying of refuse and placement of bins) and substituting new by-laws, as follows:—

12. Interpretation:—

"Council" means the Council of the Municipality of the City of Nedlands.

"Approved enclosure" means an enclosure for the storage of mobile rubbish carts unless specified otherwise.

"Building line" has the meaning given to it in and for the purposes of the Local Government Act 1960.

"Senior Health Surveyor" means the Senior Health Surveyor of the local authority.

"Collection day" means the day of the week on which rubbish and refuse is collected and removed by the local authority or its contractor.

"Commercial waste" means refuse and other rubbish generated by or emanating from other premises and includes trade waste.

"Domestic waste" means refuse and other rubbish generated by or emanating from residential premises and includes house refuse.

"Premises other" means premises used for other than residential purposes.

"Receptacle" means:—

(a) in the case of residential premises, a polyethylene cart fitted with wheels, a handle and a lid, a capacity of either 120 litres or 240 litres, supplied by the local authority or its contractor, or other type of receptacle specified or approved by the local authority;

(b) in the case of premises other than residential a rubbish receptacle approved by the Senior Health Surveyor.

"Residential premises" means premises used for residential purposes.

"Street alignment" has the meaning given to it in and for the purposes of the Local Government Act 1960.

13. Provision of Receptacles and Use of Receptacles:—

(a) Receptacles shall be provided to all residential premises and premises other, by either the Council or Council's contractor. A premise may have more than one receptacle, subject to approval by the Senior Health Surveyor.

(b) The occupier of such premises shall cause all commercial and domestic waste to be deposited in the receptacle or receptacles.

(c) The occupier of such premises shall not deposit or permit to be deposited in a receptacle:—

(i) any refuse exceeding seventy (70) kilograms in weight at any one time;

(ii) any refuse being or consisting of:—

(a) burning or hot ashes;

(b) oil, paints or solvents;

(c) liquid or liquid waste;

(d) bricks, concrete, earth or heavy metal objects;

(e) an object which is greater in length, width or breadth than the corresponding dimensions of the receptacle or which with or without other objects or waste already deposited in the receptacle, will not allow the lid of the receptacle to be tightly closed;

(f) any refuse which is likely to be injurious to either the receptacle or compaction unit;

(g) any refuse which is or is likely to become offensive or a nuisance or to give off an offensive or obnoxious odour or to attract flies or to cause fly breeding, unless it is first wrapped in absorbent or impervious material or placed in a sealed impervious container;

(d) The occupier of such premises shall at all times keep each receptacle used for the premises clean and whenever directed by the Health Surveyor to do so thoroughly cleanse and disinfect each receptacle and place and keep in it a deodorant material.

14. Collection of refuse shall be once per week on advised days at which on each collection day at or prior to 6.00 a.m. the occupier shall:—

(a) place the receptacle on the street verge forward of the front boundary line, but in a position that will not cause obstruction to cycleways, footpaths or any other carriageway.

(b) where the collection vehicle travels along a right-of-way or lane at the rear of premises, then the receptacle is to be placed adjacent to the rear boundary of the premises in such a manner as to be visible from the right-of-way or lane;

- (c) where the receptacle is of larger capacity than the 240 litre receptacle then the receptacle is to be located as directed by the Senior Health Surveyor;
 - (d) where waste emanating from a premises is of a putrescible nature then the Senior Health Surveyor may direct that the receptacle be emptied more than once per week.
15. Elderly, handicapped, infirm persons and persons who pay the prescribed fee as published annually in the *Government Gazette* may be exempted from Clause 14 (a).
16. The receptacle shall remain the property of the local authority or contractor as the case may be, and:—
- (a) the occupier of premises in the district shall notify Council within seventy two (72) hours after the event if a receptacle is lost, stolen, damaged or becomes defective;
 - (b) a person shall not damage or destroy a receptacle, or remove a receptacle from the premises to which it was delivered by the Council or its contractor unless authorised by the Health Surveyor;
 - (c) it shall be lawful for a person to identify the receptacle by placing the street number of the premises on the front of the receptacle in a form approved by the Senior Health Surveyor;
 - (d) shall not use the receptacle for any purpose other than the collection of refuse.
17. Where a receptacle is stolen, wilfully damaged or misused, the person or persons responsible for such theft or damage shall be liable to Council or its contractor for the replacement costs of the receptacle.
18. The Council or its contractor or a contractor shall cause all waste collected and removed to be taken to and disposed of at a site gazetted by the Executive Director, Health Department of Western Australia, for that purpose.

WHEREAS under the provisions of the Health Act 1911 (as amended) a Local Authority may make by-laws with respect to the matters specified in section 172 of the said Act: Now, therefore, the Shire of Serpentine-Jarrahdale, being the Local Authority for the Serpentine-Jarrahdale Shire Health district, doth hereby make the following by-laws.

Eating House By-Laws.

1. These by-laws will have effect after 31 December 1985.
2. On and after that day, no person shall establish or carry on the business of an eating house within the Shire of Serpentine-Jarrahdale unless:—
 - (a) the eating house is registered with the Local Authority, and
 - (b) the proprietor holds a licence from the Local Authority, authorising him to conduct the business of an eating house.
3. All registrations and licences shall expire on 31 December next ensuing after the date of issue.
4. The fees to be paid under these by-laws shall be as follows:—

Registration of premises	\$10.00
Proprietor's Licence	\$ 2.00.
5. The proprietor of every eating house shall apply for renewal of registration of the premises, and of his licence, within one month prior to the expiry of that registration and licence.
6. (a) Before any eating house is registered the proprietor shall make application to the Local Authority in the form prescribed in the First Schedule.
 (b) If the application is approved, the Local Authority shall, on payment of the prescribed fee, issue to the applicant a certificate of registration in the form prescribed in the Second Schedule.
7. (a) Before any licence to conduct the business of an eating house is issued the proprietor shall make application to the Local Authority in the form prescribed in the Third Schedule.
 (b) If the application is approved, the Local Authority shall, on payment of the prescribed fee, issue to the applicant a licence in the form prescribed in the Fourth Schedule.
8. If there are two or more joint proprietors:—
 - (a) each proprietor shall lodge a separate application form;
 - (b) the issue of a licence or registration shall be in the joint names of the applicants but no licence shall be issued unless the Local Authority approves all the applicants;
 - (c) each proprietor named in the licence or registration shall be severally responsible for compliance with all the obligations of the proprietor.
9. If the proprietor of any registered premises sells or transfers or parts with possession of the said premises then the new proprietor shall within 14 days of such sale, transfer or taking possession apply in the appropriate form prescribed in the Fifth Schedule for a transfer of the existing licence and if such transfer is approved, the Shire Clerk shall endorse on the existing licence the transfer of the licence.
10. Every person failing to do any act directed to be done, or doing any act forbidden to be done by these by-laws shall be guilty of an offence and shall be liable to a penalty of \$100 plus a daily penalty of \$4 for every day or part of a day which the breach is continued after the complaint of such breach has been made.

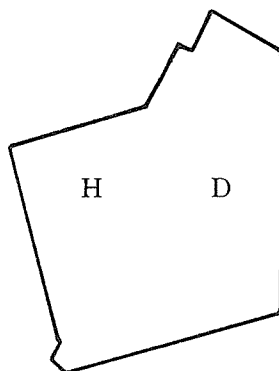

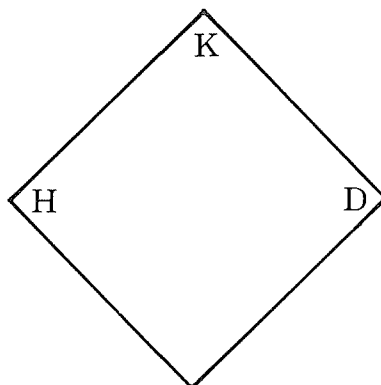

I have audited the municipality's accounts set out on pages 1 to 9 in accordance with the Local Government Act 1960 and Australian Auditing Standards.

I make the following reservations in expressing my opinion—

1. The application of the accounting policy set out in note 1 (a) results in an overstatement of assets and liabilities of \$10 437 (1984—\$138 335).
2. As set out in note 1 (b) the cash basis of accounting has been adopted. This is not in accordance with generally accepted accounting standards.

Except for the above matters, in my opinion the accounts represent fairly the financial position of the Shire of Chittering at 30 June 1985 and the statement of accounts for the year then ended, and have been prepared in accordance with the Local Government Act 1960, Accounting Directions and Australian Accounting Standards.

1. Significant Accounting Policies

The accounts are prepared in accordance with the historical cost convention. The accounting policies adopted are consistent with those of the previous years.

(a) Reserve Accounting

To comply with the Local Government Act 1960 and Accounting Directions, the Council raises reserve fund accounts and a reserve fund contra account when Council funds are set aside into separate bank accounts for specific purposes.

At 30 June 1985 these funds amounted to \$10 437 (1984—\$138 335).

(b) Basis of Cost and Income Recognition

Income and expenditure are brought to account on a cash basis. Therefore no liability has been established for annual leave, long service leave and accruals.

Part of the long service leave liability is provided for by creating cash reserve under Accounting policy note (a) however the resulting cost is not charged to the Municipal Accumulation Account.

(c) Depreciation

Depreciation is calculated on a straight line basis so as to write off the cost of each fixed asset during its expected useful life.

(b) Place signs on the proposed site of excavation notifying of the proposed application to excavate in bold clear lettering such signs being visible from all roadways passing by the site and from the properties surrounding the site and such signs to remain on the site until the licence application has been determined by the Council. Such signs shall indicate that objections in respect of the application to excavate may be made to the Council in writing within 21 days.

(c) Advertise in a newspaper circulating the neighbourhood of the proposed site the proposed application for excavation, such advertisement to indicate that objections in respect of the application to excavate may be made to the Council in writing within 21 days."

4. By-law 635 of the principal by-laws be amended by the deletion of "\$10.00" and the substitution of "\$50.00."

5. By-law 636 is revoked and the following by-law substituted:

"636. It shall be a condition of the granting of a licence that the applicant shall supply to the Council a rehabilitation bond or bank guarantee whichever the Council in its discretion shall require in accordance with the following:—

"644A: All licences shall incorporate as a condition of the granting of the licence that the licensee will strictly comply with the Mines Regulation Act 1946 (as amended) and all regulations made pursuant thereto."

"645: When an excavation has been completed in accordance with the application and plans or when the licence has expired and no renewal thereof granted the excavation area shall be restored by the licensee in accordance with the restoration works and plans outlined in the application and approved by the Council prior to the issuing of the licence."

8. By-law 646 is revoked and the following by-laws substituted:

"646: The licensee shall strictly adhere to and comply with all terms, covenants and conditions of the licence and all terms, covenants and conditions of any agreement made between the Council and the licensee at any time in relation to the excavation area. Any person who shall commit a breach of any of the terms, covenants or conditions of the licence or commit a breach of any of the terms, covenants or conditions of any agreement between the Council and the licensee shall be guilty of an offence."

EQUAL OPPORTUNITY REGULATIONS 1986.

MADE by His Excellency the Governor in Executive Council under section 169.

Part 1—Preliminary.

1. These regulations may be cited as the Equal Opportunity Regulations 1986.
2. The forms to be used in relation to matters arising under the Act shall be those set out in Schedule 1, but where no form is prescribed then a form shall be adapted or prepared so as to deal with the matter in question.

Part 2—Complaints.

3. A complaint lodged with the Commissioner under section 83 of the Act shall be in writing and, if the Commissioner requires, shall be in the form set out in Form 1 in Schedule 1.

Part 3—Notification of Inquiry.

4. (1) When a complaint has been referred to the Tribunal in accordance with section 90 (2), 93 (1) or 107 (1) of the Act, the registrar shall serve upon all parties named by the Commissioner or the Minister, as the case may be, as parties to the complaint a Notice of Preliminary Hearing.
- (2) A Notice of Preliminary Hearing shall give notice to the parties of the time and place at which the preliminary hearing shall be heard.
- (3) A Notice of Preliminary Hearing shall be in the form set out in Form 2 in Schedule 1.
- (4) The registrar shall serve upon each party a Notice of Preliminary Hearing by either of the following means—
 - (a) by delivering it personally to the person required to be served; or
 - (b) by registered post addressed to the usual or last known place of abode or business of such person.
- (5) It shall be sufficient service if the Notice of Preliminary Hearing is served not less than 7 days before the day set for the preliminary hearing.
- (6) If any party fails to attend a preliminary hearing, the President may direct the registrar to produce to the Tribunal an affidavit of service setting out the time at which and the manner by which service was effected upon that party.

Part 4—Preliminary Hearing.

5. (1) Prior to or at the preliminary hearing, each party served with a Notice of Preliminary Hearing shall file with the registrar a Notice of Address for Service and the address for service given in that notice shall be the place at which all documents in the proceedings shall be served on that party.
- (2) A Notice of Address for Service may be in the form of a letter to the registrar setting out an address in Western Australia to which documents may be delivered or posted.
- (3) The registrar shall cause a copy of each Notice of Address for Service filed with him to be served upon every other party to the inquiry.
6. (1) At the preliminary hearing the Tribunal shall determine whether any complaint shall be dealt with as a representative complaint.
- (2) At the preliminary hearing the Tribunal shall consider any application that it exercise its powers under section 109 to join further parties to the inquiry.
- (3) Any person joined as a party to an inquiry shall file within such time as may be directed by the Tribunal a Notice of Address for Service and the registrar shall deal with that Notice in accordance with regulation 5 (3).
7. (1) At the preliminary hearing or at any other time, the Tribunal may direct the complainant to file with the registrar and serve upon every other party to the inquiry Points of Claim which set out in numbered paragraphs as briefly as possible the material facts upon which the complainant relies and the relief (if any) which the complainant seeks.

(2) Where the Tribunal directs that Points of Claim shall be filed and served, they shall be filed and served not later than 14 days after the direction of the Tribunal unless, in a particular inquiry, the Tribunal directs otherwise.

8. (1) At the preliminary hearing or at any other time, the Tribunal may direct the respondent to file with the registrar and serve upon every other party to the inquiry Points of Defence which respond to the allegations set out in the Points of Claim and which set out any affirmative defence upon which the respondent relies.

(2) Where the Tribunal directs that Points of Defence shall be filed and served, they shall be filed and served not later than 14 days after the day on which the respondent is served with the Points of Claim unless, in a particular inquiry, the Tribunal directs otherwise.

9. (1) At the preliminary hearing or at any other time, the Tribunal may on the application of any party (the applicant) order any other party (the other party) to provide for the inspection of the applicant the documents set out in a Request for Discovery.

(2) Where an order is made under subregulation (1), a Request for Discovery may be made by way of letter and shall be served on the other party.

(3) A party who is ordered to provide documents for inspection and who receives a Request for Discovery shall notify the applicant within 14 days after the service of that Request of a time and place at which the documents set out in that Request will be made available for inspection and whether there is any objection to the applicant inspecting any of the documents set out in that request.

(4) A party inspecting documents in accordance with a Request for Discovery may at his own expense take copies of those documents.

(5) Unless the Tribunal in a particular inquiry orders otherwise, a Request for Discovery shall not be served until Points of Claim and Points of Defence have been filed and served.

10. (1) At the preliminary hearing or at any other time, the Tribunal may on the application of any party (the applicant) order any other party (the other party) to provide answers on oath to questions set out in a Request for Information.

(2) Where an order is made under subregulation (1), a Request for Information may be made by way of letter and shall be served on the other party.

(3) A party who is ordered to provide answers on oath to questions set out in a Request for Information and who receives a Request for Information shall within 14 days after the service of that Request serve upon the applicant an affidavit in which the questions set out in the Request for Information are answered and in which any objections to answering any question are detailed.

(4) Unless the Tribunal in a particular inquiry orders otherwise, a Request for Information shall not be served until Points of Claim and Points of Defence have been filed and served.

Part 5—Evidence and Procedure Generally.

11. Without limiting the generality of section 120 of the Act, the regulations in this Part apply to the manner in which the Tribunal may receive evidence and submissions at any inquiry.

12. (1) Any party to an inquiry may lodge with the registrar and serve upon every other party to the inquiry, an affidavit from any person and, subject to subregulation (5), the Tribunal may accept that affidavit as evidence for the purposes of the inquiry.

(2) An affidavit shall be in the form required by Order 37 of the Supreme Court Rules.

(3) An affidavit may contain statements of information or belief with the sources and grounds of that information.

(4) Any party to an inquiry served with an affidavit may within 7 days after the service of that affidavit serve upon the party seeking to rely upon the affidavit a notice by letter requiring the maker of the affidavit to attend at the Tribunal for cross-examination.

(5) Unless the Tribunal in a particular inquiry otherwise directs, the Tribunal shall not accept an affidavit as evidence for the purposes of that inquiry if a notice has been given in accordance with subregulation (4) and the maker of the affidavit does not attend at the Tribunal for cross-examination.

13. (1) A preliminary hearing may be conducted by telephone or by any other means of communication which does not require the physical presence of the parties.

(2) At any inquiry the Tribunal may direct that any evidence may be given by telephone or by any other means of communication which does not require the physical presence of a person.

(3) Where the Tribunal hears evidence or otherwise conducts proceedings in a manner authorized by this regulation, the Tribunal shall ensure that the evidence is heard or proceedings conducted in such a manner that all parties present or represented before the Tribunal, whether personally present or present by means of a telephone or other means of communication, are able to hear that evidence and participate in those proceedings.

14. At any inquiry the Tribunal may direct that any submissions on any question of fact or law shall be made in writing.

15. At any inquiry a party may tender as evidence all or some of the answers given in response to a Request for Information. The President may look at the whole of the answers if part only is sought to be tendered and if of the view that it is misleading to tender only part of the answers the President may reject the tender unless any further answers are tendered as directed.

16. In the exercise of its powers and functions under the Act, the Royal Commissions Act 1968 and these regulations, the Tribunal may inspect any books, papers or documents produced before it, retain them for such reasonable period as it thinks fit and make copies of any of them, or of any of their contents.

17. (1) A Summons to a Witness shall be in the form set out in Form 3 in Schedule 1.

(2) A Summons to a Witness to Produce Documents shall be in the form set out in Form 4 in Schedule 1.

18. (1) Any party to an inquiry may request the President of the Tribunal to issue a Summons to a Witness or a Summons to a Witness to Produce Documents.

(2) The party who causes a Summons to Witness or a Summons to Witness to Produce Documents to be issued shall arrange for such Summons to be served personally upon the person named in the Summons.

(3) A Summons to Witness or a Summons to Witness to Produce Documents shall be served not less than 3 days before the day appointed in the Summons for attendance.

19. At any inquiry the Tribunal may—

- (a) require any person to make oath or affirmation that he or she will truly answer all questions put to him or her by the Tribunal and by any party to the inquiry relating to any matter being inquired into by the Tribunal (which oath or affirmation may be administered by a member of the Tribunal); and
- (b) require any person appearing before the Tribunal, including any person whose conduct is subject to an inquiry, (whether he or she has been summoned to appear or not) to answer any relevant questions put to him or her by any member of the Tribunal or by any other person appearing before the Tribunal.

Part 6—Applications for Interim Orders.

20. (1) An application for an interim order shall be in the form set out in Form 5 of Schedule 1 and shall be lodged with the registrar.

(2) Unless the President directs otherwise an application for an interim order shall be accompanied by an affidavit and shall include a precise statement of the order or orders sought.

(3) In cases of urgency an application for an interim order may be made *ex parte*.

(4) Where an application is made *ex parte*, the President may order that the hearing of the application be delayed until any other interested parties are informed of the application and served with copies of any documents which have been filed.

(5) Where an order is made *ex parte*, the President may direct the registrar to serve in any manner which the President considers appropriate, a copy of the order on any person affected by the terms of the order and upon any other person.

Part 7—Application for Exemption or Variation.

21. An application for an exemption under section 135 (1) shall be in the form set out in Form 6 Schedule 1.

22. An application for a further exemption under section 135 (2) or for a variation of an exemption or further exemption shall be in the form set out in Form 7 in Schedule 1.

23. Unless the President directs otherwise in a particular case every application for an exemption of a further exemption or the variation of an exemption or further exemption shall be accompanied by an affidavit which contains particulars of the evidence in support of the application.

24. The Registrar shall cause a copy of every application for an exemption or a further exemption or the variation of an exemption or further exemption and every affidavit filed in support of such applications to be served upon the Commissioner who shall be a party to every such application unless the Commissioner lodges an affidavit with the registrar setting out the reasons why the Commissioner does not wish to be a party to the application.

25. (1) Where an application for exemption or an application for further exemption or variation of an exemption or further exemption has been filed in accordance with these regulations, the registrar shall serve upon the person making the application and the Commissioner a Notice of Preliminary Hearing.

(2) The provisions of regulation 4, in so far as they are relevant, apply to the Notice of Preliminary Hearing.

(3) Parts 4, 5 and 9 of these regulations, subject to necessary modifications, apply to an application for an exemption or for a further exemption or for a variation of an exemption or further exemption.

26. At the preliminary hearing or at any other time, the Tribunal may direct the applicant to serve upon any person a copy of the application for exemption or further exemption or application for variation of an exemption or further exemption and any affidavit filed in support of that application.

27. At the preliminary hearing or at any other time, any person may apply to be joined as a party to an application under this Part. Unless the President directs otherwise in a particular case every person who seeks to be joined as a party to an application shall file an affidavit setting out that person's interest in the application.

Part 8—Enforcement of Orders.

28. (1) When enforcement of any order made by the Tribunal is sought, the registrar shall upon request issue an order signed by the President.

(2) An order shall be in such form as the President may determine.

Part 9—General.

29. (1) Every inquiry conducted by the Tribunal shall be held in Perth except that on the application of any party the President may direct that an inquiry shall be held elsewhere.

(2) An inquiry may, if it appears to the President to be in the best interests of the parties, be adjourned to such other place as may appear to the President to be necessary or expedient.

30. (1) The President may issue practice directions relating to any matters of procedure not specifically provided for under the Act of these regulations.

(2) Where any matter or thing is not specifically provided for under the Act or these regulations, or in practice directions, application may be made to the President for directions appropriate to the case.

31. If any party to an inquiry does not, without reasonable excuse, proof of which is on the party, comply with the terms of these regulations or any procedural direction given by the President, the Tribunal may on the application of any other party to the inquiry make any order which it considers proper including an order dismissing the complaint or striking out a defaulting party's Points of Defence, as the case may be.

32. (1) Any document, letter or notice, required to be served pursuant to these regulations or a direction of the Tribunal and for which no specific provision for service has been made, may be served—

- (a) by delivering it personally to the address for service given in the Notice of Address for Service of the person so required to be served; or

WESTERN AUSTRALIAN COLLEGE OF ADVANCED EDUCATION ACT 1984.

Western Australian College of Advanced Education By-laws.

BY-LAWS made under section 29 (3) of the Act.

Part I—General Provisions.

1. (1) These By-laws may be cited as the Western Australian College of Advanced Education By-laws and shall come into force when approved by the Governor and published in the *Government Gazette*.

(2) In these By-laws unless the context otherwise requires—

“authorised” means authorised by the Director or an authorised officer, or the Council, and “without authority” means without the authority of the Director, an authorised officer, or the Council;

“authorised officer” means a member of the staff of the College authorised by the Director to act under and for the purposes of these by-laws or, where the case expressly requires, a member of the staff of the College authorised by the Council;

“College” means the Western Australian College of Advanced Education as constituted by the Act;

“College lands” means those lands vested in, or under the management and control of the College and declared to be college lands by the Governor pursuant to section 29 (2) of the Act;

“park” or “parking” includes leaving a vehicle standing or waiting whether it is occupied or not;

“parking permit” means a permit to park a vehicle issued in accordance with these by-laws;

“permit” means a permit in accordance with these by-laws;

“roadway” means any part of the College lands designed and established for the carriage or parking of vehicles;

“traffic sign” means an authorised marking, notice or sign to regulate or guide traffic or the parking of vehicles or to prescribe maximum speed limits;

“vehicle” includes car, truck, bus, motor cycle, motor scooter, bicycle, semi-trailer or caravan and any other form of conveyance, or trailer however ridden, driven or propelled.

The Interpretations Statute of the College, as from time to time in force, shall apply and shall be deemed to be incorporated in these by-laws.

2. These by-laws shall apply—

(a) within the boundaries of the College lands, and to every part of the College lands; and

(b) to every person who is at any time on the College lands.

3. The Council may delegate any function, power or duty conferred or imposed on it by these by-laws in accordance with the Act and the Council or its delegate may by writing authorise any person to act under and for the purposes of these by-laws.

4. The Director may from time to time declare that a particular area or areas within the College lands—

(a) shall be open to members of the public or any specified section of the public subject to such conditions as may be specified in the declaration;

(b) may be used for specified activities by members of named clubs or organisations or other persons referred to in the declaration subject to compliance with such conditions as may be specified in the declaration; and no person shall use any such area unless he is a member of the named club or organisation or is one of the persons or class of persons to which the declaration refers, and the use is for the specified activity, and in accordance with the specified conditions (if any).

Any declaration by the Director under this by-law may be notified or revoked by him at any time and without notice.

5. (1) Every application for a permit under these by-laws shall be made to the Director or an authorised officer.

(2) The Director may prescribe such categories of parking permit as he thinks fit. A parking permit shall have effect as described in By-law 37.

(3) The Director or an authorised officer to whom an application for a permit or parking permit is made may either issue the permit or parking permit to the applicant or refuse the application or issue the permit or parking permit subject to such conditions (including the payment of a fee) in each case as he shall in his discretion decide.

(4) The Director or an authorised officer may vary, suspend or revoke any permit issued to any person who has committed a breach of these by-laws.

(5) It shall be deemed to be a condition of every permit issued (whether gratuitous or otherwise) that the holder of the permit or any person or category of persons specified in the permit does the act authorised by the permit at his own risk and a condition of every parking permit issued that the College is not and shall not be liable or responsible in any way for the safe custody of a vehicle or its contents.

Part II—Land By-laws.

6. (1) Any of the following persons may enter and remain on College lands—

(a) A person who is a member of the Council, a member of the staff of the College other than a person employed on a casual basis, a graduate of the College or an enrolled student, a member of the staff of the Student Council, or an employee of a business lawfully conducted on the College lands;

(b) a member of the Western Australian Post-Secondary Education Commission or staff of the Commission;

(c) a person, other than a student, attending a course of study at the College or other authorised activities at the College, during such times and in respect of such areas within the College lands as are appropriate for the purposes of such activities;

- (d) a person who holds a permit or in relation to whom a permit has been issued authorising him to enter or remain on the College lands and who observes all conditions of the permit;
- (e) a person who enters or remains on the College lands in good faith for the purpose of transacting lawful business or having lawful dealings with the College or with a person lawfully on the College lands unless the business or other dealing has been prohibited by the Director; or
- (f) a person to whom a declaration of the Director under By-law 4 applies, in relation only to that area that is the subject of the declaration and during the hours specified in the declaration.

No other person may enter or remain in the College lands without authority.

(2) A person described in By-law 6 (1) shall not, without authority, enter or remain on any part of the College lands which is not customarily open to entry by him or to which the Director has forbidden entry.

7. No person shall throw or leave rubbish, refuse, paper, bottles, glass (broken or otherwise) or litter of any kind except in receptacles provided for the purpose.

8. No person shall—

- (a) assault or attempt to threaten to assault any other person;
- (b) use abusive or insulting language or do or engage in any offensive, indecent, or improper act, conduct or behaviour; or
- (c) otherwise act in such a way as to cause or be likely to cause a nuisance or annoyance to other persons on or in the vicinity of the College lands.

9. No person shall write, draw, print, publish, record, broadcast, distribute, or otherwise disseminate any indecent or obscene matter of any kind or perform any indecent or obscene act of any kind.

10. No person shall, without authority—

- (a) bring or keep or cause to be brought or kept or consume food or drink in any location in buildings on the College lands declared from time to time by the Director to be a location where food or drink are not to be kept or consumed;
- (b) post, paint or otherwise affix to any building, structure or tree on the College lands or publish or distribute within the College lands any placard, paper, notice or advertisement or other written, printed or graphic matter; or
- (c) write, draw or paint on or deface any building, structure or tree on the College lands.

11. No person shall without authority bring or keep or cause to be brought or kept or consume intoxicating liquor on any part of the College lands.

12. No person shall without authority bring on or keep or cause to be brought or kept or consume any deleterious, addictive, noxious or hallucinatory drug or substance or any implement or devices designed or used to administer such drugs or substances on any part of the College lands.

13. No person shall without authority—

- (a) cut, break, deface, pick, injure, destroy or remove any tree, shrub, plant, flower, garden or lawns;
- (b) damage, remove or interfere with any stake or label on or near any tree, shrub, plant, flower, garden or lawns;
- (c) walk on or cause damage to any bed containing or being prepared for shrubs or flowers;
- (d) enter or remain in any pond, lake or ornamental water;
- (e) enter an area which is temporarily enclosed and on or by which is a notice prohibiting entry; or
- (f) damage, interfere with or move any part of the College lands or any fixed or movable article on the College lands.

14. No person shall without authority—

- (a) carry or discharge a firearm or other offensive weapon;
- (b) light a fire except where fireplaces are provided;
- (c) throw or release a stone or other missile or any dangerous material of any kind;
- (d) create or discharge any offensive or dangerous gas, smoke, smell or noise;
- (e) bring on to or allow to be brought on to the College lands or make any bomb or other explosive device.

15. No person shall without authority disturb, frighten, shoot at or throw missiles at, or otherwise attempt to capture or kill any bird, fish or animal.

16. No person shall without authority sell or hire, expose or offer for sale or hire, or solicit orders for the purchase or hire of any goods or services, or solicit donations for charity or beg.

17. No person shall without authority bring any animal on to College lands.

18. (1) No person shall without authority, arrange, advertise or take part in:

- (a) any fete, picnic or concert or other performance; or
- (b) any public speaking or preaching,

but this by-law does not apply to any activity exempted either generally or specifically by the Director or any activity specified in a declaration by the Director under By-law 4.

(2) Subject to these by-laws, meetings of associations of academic staff, other salaried staff and enrolled students which, in the opinion of the Director, are being conducted in an orderly manner, may be held on the College lands.

19. No person shall without authority—

- (a) bet or offer to bet or accept a bet;
- (b) sell, purchase or offer for sale or purchase any ticket or coupon for or which purports to be for a sweep, horse race or other lottery; or
- (c) play cards for money or engage in any other form of gambling.

20. No person shall do or engage in any act or behave in any manner that is declared by an authorised sign to be prohibited or not allowed.

21. No person shall obstruct—

- (a) any member of the Police Force or member of the staff of the College in the discharge of his duty; or
- (b) any person in the exercise and enjoyment by him of any lawful activity.

22. No child apparently under the age of 15 years may enter or be taken into or allowed to remain on the College lands unless at all times in the charge of an adult person.

23. A person shall if and when required to do so by a member of the Police Force or an authorised officer who reasonably believes that the person is on the College lands in breach of a by-law or that he has otherwise committed a breach of a by-law, given his name and address and if required by the member of the Police Force or authorised officer, leave the College lands or such part of the College lands as may be specified by the member of the Police Force or authorised officer.

24. A member of the Police Force or authorised officer may remove from the College lands a person whom the member of the Police Force or authorised officer reasonably believes is causing an annoyance or inconvenience, or is using any obscene, blasphemous or indecent language.

25. A person shall, if and when required to do so by a member of the Police Force or an authorised officer, remove any vehicle, animal or other thing of whatever kind over which he has control or which he owns from the College lands.

26. (1) The Director may notify in writing any person whose presence on the College lands is in the opinion of the Director detrimental to the welfare of the College, that he is forbidden to enter or remain on the College lands or any specified part thereof and after receipt of such notification, notwithstanding any other provision of these by-laws, the person notified shall not enter or remain or attempt to enter or remain on the College lands or the specified part, and if he should do so or attempt to do so he shall commit a breach of these by-laws.

(2) The Director may in writing direct that a specified part of the College lands be forthwith cleared and closed and that all persons then or thereafter in or on that part of the College lands (other than authorised officers) shall forthwith leave and disperse. If any person fails to leave the specified part of the College lands as directed he shall commit a breach of these by-laws.

(3) If a person shall commit a breach of any of these by-laws, an authorised officer may give to the person a notice, in a form approved by the Director, which notice shall—

- (a) be identified by a serial number;
- (b) if the name of the person is known to the authorised officer be addressed by name to the person;
- (c) state that it is alleged that a breach of a by-law has been committed and in general terms the breach which it is alleged has been committed;
- (d) state that the breach will be reported and that further action may be taken unless within the time and manner stated in the notice—
 - (i) the modified penalty specified in By-law 52(3) indicated on the notice be paid; or
 - (ii) within 7 days an explanation in writing addressed to the Director is given for the breach, in which case further notice will be given either that the explanation is accepted or that the explanation is not accepted and further action will be taken failing payment of the modified penalty indicated on the notice within 14 days after the date on the further notice;
- (e) state the modified penalty payable.

(4) If the authorised officer is unable to give the notice to the person by handing it to him, it may be given by posting it to the person at his last known place of abode.

(5) If the person to whom the notice under By-law 26(1) is given, gives a written explanation to the Director in accordance with the terms of the notice, the Director may either accept the explanation or not accept it, and he may give the person a further notice stating that further action may be taken if the modified penalty indicated on the notice is not paid within 14 days after the date of the further notice.

Part III—Traffic By-laws.

27. A person who brings a vehicle upon the College lands does so at his own risk and the College is not and shall not be liable or responsible in any way for the safe custody of a vehicle or its contents.

28. No person shall without authority drive, or bring a vehicle on the College lands except on the roadways or parking areas.

29. No person shall drive a vehicle on the College lands in a dangerous or careless manner or without all reasonable consideration for other persons and vehicles in the vicinity.

30. No person shall drive a vehicle at a speed exceeding 25 kilometres an hour or such lower maximum speed as may be specified by a traffic sign with respect to a particular area or stretch of roadway.

31. A person who is about to drive or is driving a vehicle into or out of a parking area shall give way to all other vehicles passing along a roadway.

32. A person driving or in charge of a vehicle shall obey every signal, order or direction addressed to him by a member of the Police Force or an authorised officer in relation to the movement or control of traffic.

33. A person driving a vehicle shall comply with all directions relating to traffic shown on traffic signs.

34. No person driving or in charge of a vehicle on a roadway shall commit or do any act which would be a breach of any Act or Regulation of the State of Western Australia if such roadway were a "road" for purposes of the Road Traffic Act 1974.

35. (1) The Director or an authorised officer may set apart a place or places as a parking area for vehicles, and may by a traffic sign displayed on or near a parking area specify the hours during which it may be used for parking, the kinds of vehicles that may be parked there, the persons who are entitled to use, the length of time a vehicle is permitted to be parked there, or otherwise regulate its use.

(2) A person shall not park a vehicle except in a parking area so set apart for parking by him and during permitted hours.

36. An authorised officer may by an authorised sign placed on or near a parking bay in a parking area, reserve that parking bay for a specific purpose or a specified person or class of persons.

37. A parking permit shall be issued with respect to a particular vehicle in such form as may be approved by the Director from time to time, signed by the Director or an authorised officer and unless the permit is varied, suspended or revoked it shall be current until the date of expiry specified in the permit.

38. A parking permit affixed to a vehicle in accordance with these By-laws entitles the holder to park the vehicle during the currency of the permit in an unreserved parking bay in that section of any parking area set aside for such persons or categories or classes of persons unless such permit is varied, suspended or revoked.

39. (1) If the holder of a parking permit changes the vehicle or the registration number of the vehicle in respect of which the permit has been issued, he shall forthwith give notice in writing to the Director or as he shall from time to time direct.

(2) Parking permits shall not be transferable.

40. Except as provided in By-law 42, no person shall park a vehicle unless he holds a parking permit or parks a vehicle on behalf of a person who holds a permit. The holder of a parking permit or a person who parks a vehicle on behalf of a person who holds a parking permit shall not park a vehicle except in accordance with the terms of the permit.

41. The holder of a parking permit shall affix the permit to the vehicle for which it was issued in such manner as shall be required by the permit.

42. A visitor to the College, which expression shall include the persons specified in paragraphs (b), (c), (d), (e) and (f) of By-law 6(1), may park a vehicle in an unreserved parking bay in an area marked by a traffic sign as a visitor's car park.

43. (1) This By-law applies whenever—

- (a) a vehicle is parked in a manner that is in breach of these by-laws;
- (b) a vehicle is driven by a person in a manner that is in breach of these by-laws; or
- (c) there is otherwise a breach of these by-laws with respect to a vehicle.

(2) If a current permit has been issued with respect to the vehicle, the permit holder shall be deemed to have committed a breach of these by-laws as described in by-law 43(1). If no permit has been issued which is current, or the permit holder is not residing at the address on the permit at the time of the breach of these by-laws, the owner of the vehicle (for the purposes of the Road Traffic Act 1974) shall be deemed to have committed a breach of these by-laws.

(3) It shall be a defence to a charge under By-law 43 that the permit holder or owner of the vehicle (as the case may require) has satisfied an authorised officer that the vehicle was stolen or was being unlawfully used at the time of the alleged breach.

(4) If the permit holder or owner of the vehicle did not himself park or drive the vehicle in the manner that is in breach of these by-laws, the person who did so park or drive the vehicle in breach of these by-laws shall also have committed the breach of these by-laws (whether or not By-law 43(3) applies).

(5) The driver or person in charge of a vehicle shall, upon being required by a member of the Police Force or an authorised officer who reasonably believes he has committed a breach of these By-laws, furnish that officer with his full name and address.

44. No person shall without authority—

- (a) park a vehicle in a no parking area, or in a loading bay or other place reserved by an authorised sign for a particular purpose, except in accordance with that purpose;
- (b) park a vehicle other than wholly within the marked boundary of any parking bay marked on a parking area;
- (c) park a vehicle in such a position as to interfere with traffic or obstruct other vehicles;
- (d) park a motor cycle, motor scooter, or bicycle on any roadway or other area on which there are marked parking bays of an area appropriate for the parking of four-wheel vehicles.

45. (1) A vehicle parked in breach of these by-laws or in such a position as to interfere with traffic or obstruct other vehicles, or apparently abandoned, may be removed under the authority of the Director, a member of the Police Force or an authorised officer to such a place whether on or off the College lands as the Director, a member of the Police Force or authorised officer may determine.

(2) A person removing a vehicle under the authority of this by-law is entitled to take such action whether by way of unlocking, entering by any means, driving or towing the vehicle or otherwise as may be reasonably necessary for the purpose of effecting the removal.

(3) The owner of a vehicle so removed shall pay all costs and expenses incurred by the College in moving it and neither the College nor any officer, employee or agent of the College shall be liable to the owner of any vehicle so removed for any loss or damage suffered by him arising out of or in consequence of the vehicle being so removed.

(4) The College may retain possession of a vehicle so removed until any amount payable under By-law 45(3) is paid.

46. (1) If a person drives a vehicle in a manner that is in breach of these by-laws or there is otherwise a breach of these by-laws with respect to a vehicle, an authorised officer may affix on the vehicle or give to the driver or person in charge of the vehicle a notice, in a form approved by the Director, which notice shall—

- (a) be identified by a serial number;
- (b) if the name of the person driving the vehicle, or the holder of a permit issued with respect to the vehicle or the owner of the vehicle is known to the authorised officer, be addressed by name to the driver, holder of the permit or owner or otherwise be addressed to the driver, holder of the permit or owner by the registration number of the vehicle;

- (c) describe the vehicle by make and registration number;
- (d) state that it is alleged that a breach of a by-law with regard to the driving or parking, or otherwise with respect to the vehicle has been committed and in general terms the breach which it is alleged has been committed;
- (e) state that further action may be taken unless within the time and manner stated in the notice—
 - (i) the modified penalty specified in By-law 52 (3) and indicated on the notice is paid; or
 - (ii) within 7 days an explanation in writing addressed to the Director is given for the breach, in which case further notice will be given either that the explanation is accepted or that the explanation is not accepted and further action will be taken failing payment of the modified penalty indicated on the notice within 14 days after the date of the further notice;
- (f) state the modified penalty payable.

(2) If the authorised officer is unable to affix the notice to the vehicle or to give it to the driver or person in charge of the vehicle by handing it to him, it may be given by posting it to the holder of the permit issued with respect to the vehicle or to the owner of the vehicle at his last known place of abode.

(3) If the person to whom a notice under By-law 46 (1) is given, gives a written explanation to the Director in accordance with the terms of the notice, the Director may either accept the explanation or not accept it and he may give the person a further notice stating that further action may be taken if the modified penalty indicated on the notice is not paid within 14 days after the date of the further notice.

47. On such days or nights and during such time or times as the Director may direct, members of the Police Force and authorised officers shall have complete control over all traffic within the College lands, whereupon every person in charge of any vehicle or animal within the College lands shall obey every order and direction of any member of the Police Force or authorised officer relating to the movement or control of such traffic, and shall stop or proceed or park in such manner and direction as the member of the Police Force or authorised officer may from time to time order. This by-law shall apply notwithstanding the terms of any issued permit.

48. The Council may from time to time prescribe parking fees to be paid by applicants for parking permits or by persons parking vehicles, whether holders of a permit or not, in specified parking bays or areas set aside for parking.

Part IV—Offences and Penalties.

49. A person who commits a breach of these by-laws shall be guilty of an offence and liable to a penalty not exceeding the amount from time to time prescribed by the Act as the maximum penalty that may be imposed for any breach of a by-law and to pay compensation for any damage done by him to College property.

50. Proceedings may be taken in any court of summary jurisdiction in accordance with the Justices Act 1902, in respect of any offence committed under these by-laws and any penalty imposed or compensation made payable may be recovered in a summary manner in accordance with the Act.

51. Proceedings may be taken by any authorised person or by any member of the Police Force who shall be reimbursed out of the funds of the College for all costs, charges, expenses and damages which he may incur or become liable by reason of taking proceedings.

52. (1) A person who does not contest an allegation that he has committed a breach of these by-laws may pay to the Director or an authorised officer within the time prescribed by a notice given under By-law 26 (3) or By-law 46, the modified penalty prescribed for that breach by By-law 52 (3). The production of an acknowledgement from the Director or the authorised officer of the payment of the modified penalty shall be a defence to a charge of the breach in respect of which the modified penalty is paid.

(2) If it appears to the Director or the authorised officer that an alleged breach of these by-laws cannot be adequately punished by the payment of a modified penalty, the Director may refuse to accept payment of the modified penalty and may take proceedings against the alleged offender. A breach of a by-law by an enrolled student is a disciplinary offence for which a complaint may be brought, heard and determined under disciplinary rules of the College instead of before a court of summary jurisdiction.

(3) For any breach of these by-laws the modified penalty shall be \$10.00.
