PROCLAMATION

WESTERN AUSTRALIA GORDON REID, Governor. [L.S.] By His Excellency Professor Gordon Reid, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

UNDER section 2 of the Acts Amendment (Potato Industry) Act 1985, I, the Governor, acting with the advice and consent of the Executive Council, do hereby fix the day on which this proclamation is published in the *Government Gazette* as the day on which the provisions of section 6 of the Acts Amendment (Potato Industry) Act 1985, other than paragraph (a), shall come into operation.

At a meeting of the Executive Council held in the Executive Council Chamber, Perth, this 24th day of March, 1986, the following Order in Council was authorised to be issued.

Land Drainage Act 1925.

Uniting and Naming of Various South West Drainage Districts.

ORDER IN COUNCIL.

G.3497.

WHEREAS by section 12 subsection (1) paragraph (a) of the Land Drainage Act 1925 the Governor may at any time by Order in Council unite any two or more districts so as to form one district: And whereas by section 11, paragraph (c) of the said Act he may assign a name to such district: And whereas by section 12 subsection (1) paragraph (g) of the said Act he may repeal, vary or amend any of the provisions of any previous order relating to any district: Now, there

fore, His Excellency the Governor, by and with the advice and consent of the Executive Council on the recommendation of the Minister does hereby unite various South West Drainage Districts and assign names to them and amend the provisions of previous orders by renaming other South West Drainage Districts in accordance with the Schedules hereunder.

Schedules.

First Schedule.

Wungong Drainage District and Serpentine-Mundijong Drainage District united and named Mundijong Drainage District.

Wungong Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 30 June 1916 and as subsequently specified by Orders in Council published in the Government Gazette on 27 September 1918, 2 March 1984 and 7 December 1984, and Serpentine-Mundijong Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 24 November 1950 and as subsequently specified by Order in Council published in the Government Gazette on 14 November 1958, united and named Mundijong Drainage District.

Second Schedule.

Pinjarra Drainage District and Waroona Drainage District united and named Waroona Drainage District.

Pinjarra Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 1 September 1944 and as subsequently specified by Order in Council published in the Government Gazette on 4 June 1971, and Waroona Drainage District as originally constituted and defined by Order in Council and Published in the Government Gazette on 23 August 1940 and as subsequently specified by Orders in Council published in the Government Gazette on 1 September 1944, 12 January 1962 and 16 May 1969, united and named Waroona Drainage District.

Third Schedule.

Harvey, West Harvey, Myalup, Parkfield and Benger Drainage Districts united and named Harvey Drainage District.

Harvey Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 24 August 1906 and as subsequently specified by Orders in Council published in the Government Gazette on 24 December 1914, 9 December 1921, 1 July 1932, 8 September 1933, 9 September 1938, 15 December 1944, 28 July 1961 and 16 May 1969, and West Harvey Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 16 May 1969, and Myalup Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 27 October 1961, and Parkfield Drainage District as originally constituted and defined by Order in Council in the Government Gazette on 12 November 1976, and Benger Drainage District as originally constituted and defined by Order in Council in the Government Gazette on 23 August 1918, united and named Harvey Drainage District.

Fourth Schedule.

Collie River Drainage District renamed Roelands Drainage District.

Collie River Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 25 September 1931 and as subsequently specified by Orders in Council published in the Government Gazette on 29 April 1938, 29 November 1940, 1 October 1948, 10 August 1962, 30 August 1963, 13 September 1968, 19 February 1971 and 20 July 1984, renamed Roelands Drainage District.

Fifth Schedule

Busselton, Capel-Boyanup and Stirling Drainage Districts united and named Busselton Drainage District.

Busselton Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 21 August 1942, and Capel-Boyanup Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 18 April 1952 and as subsequently specified by Orders in Council published in the Government Gazette on 1 November 1968 and 27 March 1975, and Stirling Drainage District as originally constituted and defined by Order in Council and published in the Government Gazette on 1 November 1968 and as subsequently specified by Order in Council published in the Government Gazette on 11 August 1978, united and named Busselton Drainage District.

Sixth Schedule.

Wilson-Torbay Drainage District renamed Albany Drainage District.

Wilson-Torbay Drainage District as originally constituted and defined by Order in Council and published in the *Government Gazette* on 9 August 1946 and as subsequently specified by Orders in Council published in the *Government Gazette* on 5 September 1947, 10 April 1953, 28 December 1956, 6 April 1962, 2 December 1983 and 14 June 1985, renamed Albany Drainage District.

NOISE ABATEMENT (EXHIBITION WORLD, GERALDTON) EXEMPTION ORDER 1986.

MADE by the Minister for the Environment with the approval of His Excellency the Governor in Executive Council under section 6 of the Noise Abatement Act.

1. This Order may be cited as the Noise Abatement (Exhibition World, Geraldton) Exemption Order 1986.

 - (a) creates three escape gaps that are as nearly as practicable rectangular in shape and when measured internally each shall measure not less than 305 millimetres in length and not less than 54 millimetres in height;
 - (b) is constructed of steel flat-bar having a width of not less than 20 millimetres and a thickness of not less than five millimetres or more than six millimetres, and shall be constructed in accordance with diagram 1 in the schedule to this notice;
 - (c) shall be located at least 150 millimetres away from the attachment point or points of the hauling rope and not between the attachment points if there are two;
 - (d) shall be positioned on the side of the pot so that the longer sides of the gaps that they create are generally parallel to the base of the pot and the lower internal edge of the escape gaps are not more than 110 millimetres from the base of the pot and shall be positioned in accordance with diagram 2 in the schedule to this notice;

- (e) the material to which the escape gap is, or escape gaps are, attached must not be—
 - (i) constructed of material, the thickness of which, exceeds 13 millimetres;
 - (ii) in the horizontal plane, within five millimetres of the internal edge of the escape gap.
- 4. Every batten rock lobster pot shall have therein three or four escape gaps that:—
 - (a) are as nearly as practicable rectangular in shape and each escape gap when measured internally shall measure not less than 305 millimetres in length and not less than 54 millimetres in height, except where the length of the pot is varied in accordance with paragraph (b) (iv) of this clause;

(b) where-

- (i) three escape gaps are fitted, they are positioned one on each side, other than the base in the rear half of the pot and one at the end of the pot opposite the hauling rope attachment point or points in accordance with diagram 3 in the schedule to this notice;
- (ii) where three escape gaps are fitted, and the length of the pot does not exceed 770 millimetres, they are positioned one on each side, other than the base of the pot and one at the end of the pot opposite the hauling rope attachment point or points;
- (iii) four escape gaps are fitted, they are positioned two on each side, other than the base or the end to which the hauling rope is attached to the pot in accordance with diagram 4 in the schedule to this notice;
- (iv) four escape gaps are fitted in accordance with this clause to pots which do not exceed 770 millimetres in length the length of one of the gaps fitted to each side of the pot may be less than 305 millimetres provided that the combined length of two escape gaps on each side of the pot shall be not less than 610 millimetres and provided that the smallest gap on each side of the pot shall be not less than 200 millimetres;




DIAGRAM 3 - BATTEN POTS




DIAGRAM 5 - BATTEN POTS (Clause 4(c)(i))




DIAGRAM 6 - BATTEN POTS

(Clause 4(c)(ii)) (Aluminium)




DIAGRAM 7 - BATTEN POTS

(Clause 4(c)(iii)) (Fibreglass)




DIAGRAM 8 - PLASTIC POTS





DIAGRAM 9 (Clause 12)

The Municipality of the Shire of Port Hedland.

By-laws Relating to the Establishment, Maintenance and Equipment of Bush Fire Brigades.

IN pursuance of the powers conferred upon it by the abovementioned Act, and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 23 January, 1986 to make and submit for confirmation by the Governor the following by-laws:

Establishment of Brigade.

- 1. (a) By resolution, the Council may establish, maintain and equip a bush fire brigade under the provisions of the Bush Fires Act 1954 and regulations thereunder, the brigade shall be formed in accordance with these by-laws; and a name shall be given to the brigade. Details of the brigade and its officers shall be entered in the register of the Bush Fire Brigades held by the Council.
- (b) A bush fire brigade may be established for the whole of the Shire or for any specified area thereof.

Appointment of Officers.

- 2. The Council shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants as it shall deem necessary to act as officers of the brigade.
- 3. Members of the brigade shall elect a person to act as secretary to the brigade and shall inform the Council accordingly.
- 4. The Council may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances required by the Council for the purposes of the brigade. Such officer may station such equipment at a depot approved by the captain.

Powers and Duties of Officers.

5. The powers and duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act 1954 and each officer so appointed shall be supplied with a copy of the Act and Regulations.

Membership of Brigade.

- 6. (1) The membership of a bush fire brigade may consist of the following:
 - (a) subscribing members; and
 - (b) fire-fighting members.
- (2) Subscribing members shall be those persons, who being interested in forwarding the objects of the brigade, pay an annual subscription to the funds of the brigade at the following rates:
- (3) Fire-fighting members shall be those persons, being able bodied persons over 18 years who are willing to render service at any bush fire when called upon; and who sign an undertaking in the form contained in the First Schedule to these by-laws.
- (4) No fees or subscriptions shall be payable by fire-fighting members and the enrolment of persons as such members shall in every case be subject to the approval of Council.
 - (5) A subscribing member shall be eligible for enrolment as a fire-fighting member.

Finance.

7. The expenditure incurred by the Council in the purchase of equipment, payment for services and generally for the purposes of this Act, shall be a charge on ordinary revenue of the Council and records of such expenditure shall be maintained in accordance with Municipal audit requirements.

Meetings of Brigades.

8. Meetings will be held as necessary.

 - (ii) in paragraph (c) by deleting "2" and substituting the following—

 - (3) Subject to this clause each appointed member shall hold office for such period not exceeding 3 years as is specified in the instrument of his appointment and is eligible for reappointment.

- 17.25 cents per litre for milk for pasteurised cream and yogurt;
- 31.69 cents per litre for milk for flavoured milk and ships' stores; and
- 20.12 cents per litre for other special products milk.

MAXIMUM PRICES TO AUTHORITY.

 - is found by the Department of Agriculture of Western Australia on a certain day to contain antibiotic or other inhibitory substance on a second occasion after 1 January 1986 or a second occasion in any subsequent quota year, milk supplied by that dairyman for that one day will not be accepted by the Authority as market milk or special products milk.

- is found by the Department of Agriculture of Western Australia on a certain day to contain antibiotic or other inhibitory substance on a third or succeeding occasion after 1 January 1986 or on a third or succeeding occasion in any subsequent quota year, milk supplied by the dairyman for the duration of that testing period in which that day occurs will not be accepted by the Authority as market milk or special products milk.
- is found by the Department of Agriculture of Western Australia on a certain day to contain added water on the first occasion after 1 January 1986 or on the first occasion in any subsequent quota year, milk supplied by that dairyman for that one day will not be accepted by the Authority as market milk or special products milk.
- is found by the Department of Agriculture of Western Australia on a certain day to contain added water on a second or succeeding occasion after 1 January 1986 or on a second or succeeding occasion in any subsequent quota year, milk supplied by that dairyman for the duration of the testing period in which that day occurs will not be accepted by the Authority as market milk or special products milk.
- is found by the Department of Agriculture of Western Australia on a certain day to contain added solids on the first occasion after I January 1986 or on the first occasion in any subsequent quota year, milk supplied by that dairyman will not be accepted by the Authority as market milk or special products milk for a minimum of two testing periods.
- is found by the Department of Agriculture of Western Australia on a certain day to contain added solids on a second or succeeding occasion after 1 January 1986 or a second or succeeding occasion in any subsequent quota year, milk supplied by that dairyman will not be accepted by the Authority as market milk or special products milk for a minimum of four testing periods.
- is found by the Department of Agriculture of Western Australia on a certain day after 1 January 1986 or on any day in a subsequent quota year, to have a bacterial count of over 50 000 bacteria per millilitre not less than 10 days—

after an initial examination indicating over 100 000 bacteria per millilitre; or

after any two initial examinations within the quota year indicating over 100 000 bacterial per millilitre; or
