Pearling Act 1912. PROCLAMATION

WESTERN AUSTRALIA GORDON REID, Governor. [L.S.] By His Excellency Professor Gordon Reid, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

UNDER section 106 of the Pearling Act 1912, I, the Governor, acting with the advice and consent of the Executive Council, prescribe the dimensions set out in column 2 of the Schedule to this proclamation to be the minimum dimensions of the sorts of pearl-shell described in column 1 of that Schedule below which it shall be unlawful to take or obtain the same within the State, and that a person who so takes or obtains such pearl-shell that are below such dimensions is liable to a penalty not exceeding \$1 000.

ORDER IN COUNCIL.

SUBJECT to Regulation 5 of the Companies and Securities Industry (Retirement Villages) (Exemption) Regulations 1985, the prescribed interests described in Schedule 1 hereto issued by the promoter described in column 1 of Schedule 2 in respect of a retirement village scheme described in Column 2 of Schedule 2 opposite the promoter described in Column 1, are hereby declared to be exempt rights or interests—

THE Public is hereby notified that I have issued a permit to A. V. C. and P. A. Miles, c/- Post Office, Dunsborough, to establish a processing establishment to process fish in pur-suance of the provisions of section 35C of the Fisheries Act 1905 at, Caves Road, Quindalup, subject to the following conditions.

That the processing establishment—

- 1. Shall comply with the requirements of the Fisheries Act 1905-1975 and all Regulations, Orders in Coun-cil, and Notices and Ministerial Directions issued thereunder.
- 2. Shall not be used for the processing of Rock Lobster, or Australian salmon except as provided by clauses 8 and 9.
- 3. Shall comply with the requirements of the Health Act 1911 (amended).

- 4. Shall comply with the requirements of any town planning scheme or interim development order gazetted under the provisions of the Town Planning and Development Act 1928 (amended) or the Metropolitan Region Town Planning Scheme Act 1959 (amended).
- 5. Shall be registered as an export establishment pur-suant to the provisions of the Customs Act 1901 (amended) and the Commercial (Trade Descrip-tions) Act 1905 (amended) of the Parliament of the Commonwealth should it be used to process fish for export.
- 6. Shall not be used for the processing of marron (Cherax tenuimanus) unless a licence is held under section 39C of the Fisheries Act 1905-1975.
- 7. The Licensee shall lodge with the Department of Fisheries no later than the 15th day of each month, a return of Wetfish processed for the preceding month, specifying the name of the fisherman, the boat number or professional fisherman's licence number, anchorage from which the vessel operates, the species and live weight processed. Where no Wetfish have been processed a "Nil" return shall be submitted.
- 8. The Licensee may process Australian salmon as an edible food fish for human consumption.
- 9. The Licensee may process up to seven tonnes of Australian salmon for bait where the licence holder of an authorised salmon team has supplied the salmon and obtained specific approval in writing from the local Fisheries Department Office authorizing the supply and processing thereof.
- 10. The Licensee shall supply such documents and records as determined by a Fisheries Enforcement Officer to provide an adequate record of all Australian salmon processed and the final destination of each sale and quantity.

1. It is hereby notified for public information that the State Planning Commission at its meeting held on 5 February 1986, resolved in accordance with the provisions of section 35C of the Metropolitan Region Town Planning Scheme Act 1959-1985, that the land contained in the First Schedule hereto be declared a Planning Control Area; and that the Minister for Planning has granted approval to the declaration.

2. The plans defining the Planning Control Area are available for public inspection during normal office hours at the places mentioned in the Second Schedule hereto.

3. Please note that such declaration remains in force for a period not exceeding five years from the date of publication of the notice of declaration in the *Gazette*, or until revoked by the Commission with the approval of the Minister, whichever is the sooner.

4. A person shall not commence and carry out development in a Planning Control Area without the prior approval of the Commission. The penaty for failure to comply with this requirement is 2000, and, in the case of a continuing offence, a further fine of 200 for each day during which the offence continues.

5. Compensation is payable in respect of the land injuriously affected by the declaration of a Planning Control Area, and land so affected may be acquired by the Commission in the same circumstances and in the same manner as if the land had been reserved in the Metropolitan Region Scheme for public purposes.

We have been unable to obtain evidence that bank reconciliations for the municipal and trust funds are correctly prepared at 30 June or during the year. Consequently we are unable to obtain assurance that all receipts have been correctly banked into the municipal and trust accounts.

We have not been given adequate details of the following balance sheet items:

(i) sundry debtors;

(ii) sundry creditors;

(iii) stock on hand;

and consequently it has not been possible for us to satisfy ourselves as to the validity of these items.

As a result of the matters referred to in the previous paragraphs, in our opinion proper accounting records have not been kept in accordance with the provisions of the Local Government Act 1960, and the Local Government Ac-counting Directions.

Accordingly we are unable to report as to whether the annual accounts give a true and fair view of:
