# Local Government Act 1960

# ORDERS IN COUNCIL

WHEREAS by section 288 of the Local Government Act 1960, it shall be lawful for the Governor on request by a Council of a Municipal District, by Order published in the Government Gazette to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than 10 years, as a public street and if the Council thinks fit, that the Governor shall declare the width of carriageway and footpaths of the public street; and whereas the Councils mentioned in the Schedule hereto have requested that certain lands named and described in the said Schedule, which have been reserved for streets within the said Councils, be declared public streets: Now therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be public streets and such land shall, from the date of this Order, be absolutely dedicated to the public as streets within the meaning of any law now or hereafter in force.

WHEREAS by section 288 of the Local Government Act 1960, it shall be lawful for the Governor, on request by a Council of a Municipal District, by Order published in the Government Gazette to declare any lands reserved or acquired for use by the public or used by the public as a street, way, public place, bridge or thoroughfare, under the care, control, and management of the Council, or lands comprised in a private street, constructed and maintained to the satisfaction of the Council, or lands comprised in a private street of which the public has had uninterrupted use for a period of not less than 10 years, as a public street and if the Council thinks fit, that the Governor shall declare the width of the carriageway and footpaths of the public street. And whereas the City of Perth has requested that certain lands named and described in the schedule hereunder, which have been reserved for a street within its municipal district be declared a public street. Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council, doth hereby declare the said lands to be a public street, and such land shall, from the date of this Order, be absolutely dedicated to the public as a street within the meaning of any law now or hereafter in force.

# Conservation and Land Management Act 1984 ORDER IN COUNCIL

# Land Act 1933 ORDER IN COUNCIL

WHEREAS by section 33 of the Land Act 1933, it is, inter alia, made lawful for the Governor by Order in Council to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that land is used for the purpose for which the land is reserved as aforesaid: And whereas it is deemed expedient that Reserve No. 39495 (Windell Location

# AMENDMENT OF THE RULES OF THE SUPREME COURT 1971

# Citation.

# RESTRAINT OF DEBTORS ACT 1984 RESTRAINT OF DEBTORS REGULATIONS 1986

MADE by His Excellency the Governor in Executive Council.

- 1. These regulations may be cited as the Restraint of Debtors Regulations 1986.
- Commencement
  2. These regulations shall take effect on the coming into operation of the Restraint of Debtors Act 1984.

# Application for warrant

3. An application for a warrant to issue for the arrest of a debtor under section 5, shall be in the form of Form 1 in the Schedule.

#### Warrant

- 4. A warrant issued in accordance with section 6 shall be in the form of Form 2 in the Schedule and shall—  $\,$ 
  - (a) require the person executing the warrant to forthwith take the debtor to the nearest police station;
  - (b) require the officer in charge of the police station in which a debtor is lodged to cause the debtor to be dealt with in accordance with section 12;
  - (c) set out conditions on which the debtor may be released from custody in accordance with section 13.

#### Summons

- 5. A summons issued in accordance with section 6 shall be in the form of Form 3 in the Schedule and shall—  $\,$ 
  - (a) advise the debtor named in the application that failure to attend in response to the summons may result in a warrant being issued for the arrest of the debtor;
  - (b) set out the manner in which appearance on the summons may be avoided in accordance with section 10.

### **Endorsement of summons**

- 6. The copy of a summons lodged in the registry of a court in accordance with section 8 shall be endorsed to the effect—  $\,$ 
  - (a) that the summons was served personally on the debtor named in the summons on a specified date being not less than 7 days before the day he is summoned to appear; and
  - (b) that the summons was accompanied by a copy of the application upon which the summons was issued and every affidavit in support of the application.

#### Certain notice to be given by applicant

- 7. (1) Where a debtor tenders, or gives security for the payment of, the amount of money specified in a summons issued under section 6 before the time so specified for his appearance, the applicant shall give notice to that effect to the court specified in the summons, in the form of Form 4 in the Schedule.
- (2) Where a debtor tenders or gives security for the payment of the amount of money specified in a warrant that has not been executed the applicant shall give written notice to that effect to the officer in charge of the police station to whom the warrant had been delivered.

#### Notice on release

8. An officer in charge of a police station who releases a debtor from custody under section 13 shall notify the court specified in the warrant in the form of Form 5.

#### Orders

9. An order by a court under sections 14, 16, 18, 19, 20 or 22 may be in the form of Form 6 with such alterations as are appropriate to the case.

# Revocation of order for release

10. Where a court revokes an order pursuant to which a debtor was released, the order of revocation may be in the form of Form 7.

# Application for restraining order

- 11. An application for a restraining order under section 17 shall be in the form of Form 8. Money
- 12. (1) Money received by a police officer shall be paid forthwith to the nearest clerk of courts.
- (2) The clerk or registrar of the court with whom money has been deposited under the Act shall retain the money in a trust account or transmit it to the accountant, Crown Law Department.
- (3) The clerk or registrar, upon production of such documents and orders as may be required, and being satisfied that it is proper to do so, may pay, or authorize the accountant to pay, the money to the appropriate party.

### Fee

13. The fee to be paid in respect of the execution or attempted execution of a warrant shall be \$25 plus 50 cents for each kilometre (one way) from the relevant police station.

### Offence and penalty

14. A person who contravenes or fails to comply with any of these regulations, commits an offence.

Penalty: \$200.
