#### PETROLEUM PRODUCTS PRICING ACT 1983

## PETROLEUM PRODUCTS PRICING (MAXIMUM PRICES FOR MOTOR FUEL) AMENDMENT ORDER (No. 9) 1986

MADE by the Prices Commissioner under section 12.

#### Citation

1. This order may be cited as the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Amendment Order (No. 9) 1986.

#### Commencement

2. This order shall take effect on 10 September 1986.

#### Interpretation

- 3. In this order-
  - "the principal order" means the Petroleum Products Pricing (Maximum Prices for Motor Fuel) Order 1984\*.

#### Clause 3 amended

- 4. Clause 3 of the principal order is amended by inserting, after the definition of "resellers", the following definition—
  - "" "RON", in relation to motor fuel, means research octane number; ".

#### Clause 4 amended

- 5. Clause 4 of the principal order is amended—
  - (a) in subclause (2) by deleting paragraphs (b) and (c) and substituting the following paragraphs—
    - (a) super grade petrol RON 97 may be sold in the free delivery area to persons who are not resellers is hereby fixed at 56c per litre;
      - (b) unleaded petrol RON 91/93 may be sold in the free delivery area to persons who are not resellers is hereby fixed at 56c per litre; and
      - (c) unleaded petrol RON 96 may be sold in the free delivery area to persons who are not resellers is hereby fixed at 60.7c per litre. "; and

- (b) in subclause (4) by deleting paragraphs (b) and (c) and substituting the following paragraphs-
  - (a) super grade petrol RON 97 may be sold in a district or area specified in the second column of the Schedule to persons who are not resellers is hereby fixed at the price specified opposite to that district or area in the third column of the Schedule; and
    - (b) unleaded petrol RON 91/93 may be sold in a district or area specified in the second column of the Schedule to persons who are not resellers is hereby fixed at the price specified opposite to that district or area in the fourth column of the Schedule. column of the Schedule.

#### Schedule amended

- The Schedule to the principal Order is amended by deleting—
  - (a) "Super grade petrol" in the heading to the third column and substituting the follow-
    - " Super grade petrol RON 97"; and
  - "Unleaded petrol" in the heading to the fourth column and substituting the following-
    - Unleaded petrol RON 91/93 ".

#### UNLEADED PETROL ACT 1984

I HEREBY notify for general information that under section 8 of the Unleaded Petrol Act 1984 I authorize that where at any site a petrol retailer sells a quantity of unleaded petrol of a higher octane rating than 91 octane that petrol retailer shall be exempt at that site in respect of that petrol from any price constraint imposed by section 8 of the Act provided always that at the time of that sale the petrol retailer has also available for sale at the site unleaded petrol of the same quantity of at least 91 octane at a price not exceeding that of petrol that is not unleaded sold at the same

This exemption may be varied or revoked by future notice published in the Gazette.
