Therefore, I the Governor, acting with the advice and consent of the Executive Council, in exercise of the powers conferred by section 13 of the Main Roads Act 1930 (as amended), and pursuant to the said recommendations do hereby declare the road sections delineated on the plans and as generally described in Schedule 1 hereto shall be Highways and the road sections delineated on the plans and as generally described in Schedule 2 shall be Main Roads, but the footpaths, if any, of such roads are excluded from this proclamation.

## BUSH FIRES ACT 1954

Shire of Capel

Notice to Owners and/or Occupiers of Land  
Within the Shire of Capel

PURSUANT to the powers contained in section 33 of the above Act, you are hereby required on or before 30 November 1986 to remove from the land owned or occupied by you, all flammable materials or clear firebreaks in accordance with the following, and thereafter to maintain the land or the firebreaks clear of all flammable material up to and including 26 April 1987.

- (A) Rural land (all land other than a pine plantation and that listed as urban):
  1. Firebreaks at least two metres in width and not more than 100 metres from the perimeter of all buildings and haystacks situated on the land as to completely surround the buildings and haystacks.
  2. Firebreaks at least two metres in width immediately inside and along all external boundaries so as to form a continuous break all around the holding except where an exemption has been granted. Roadside firebreaks do not constitute a legal firebreak under the Bush Fires Act.
  3. Leasees of Railway Reserves shall have a firebreak at least three metres in width along the common boundary between the land leased from Westrail and other land owned or occupied.
- (B) Special Rural Land: The owners of all existing small rural holdings zoned as Special Rural under Town Planning Scheme No. 2, must construct and maintain clear of all flammable material a firebreak not less than two metres wide immediately inside and along all external boundaries so as to form a continuous break all round the holding except where an exemption has been granted.
- (C) Urban land (residential, commercial and industrial land within a townsite or within an area subdivided for residential purposes including Gelorup):
  1. Where the area of land is approximately 2 024 m<sup>2</sup> (approximately ½ acre) or less remove all flammable material on the land except, living standing trees from the whole of the land; and
  2. Where the area of land exceeds 2 024 m<sup>2</sup> (approximately ½ acre) clear of all flammable materials, firebreaks of at least two metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.

- (D) Fuel and/or Gas Depots: In respect of land owned or occupied by you on which is situated any container normally used to contain liquids or gas fuels, including the land on which any ramp or supports are constructed, you shall have the land cleared of all flammable material.

Notice to Owners and Occupiers of Land

WITH reference to section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provisions of this order. This work must be carried out by 14 December 1986 and kept maintained throughout the summer months until 30 April 1987.

Persons who fail to comply with the requirements of this order may be issued with an infringement notice (penalty \$40) or prosecuted with an increased penalty, and additionally, Council may carry out the required work at cost of the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials as required by this notice, to where:

- (a) Compliance with this order may aggravate soil erosion problems, or
- (b) The owner or occupier of land considers a more effective system of fire protection can be obtained, or
- (c) Natural features render firebreaks unnecessary,

you may apply to the Council or its duly authorised officers not later than the 15th day of November, 1986 for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land.

## Requirements

Rural and Townsite Land

- (a) Where the area of the land is 2 023 m<sup>2</sup> (approximately ½ acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land, and
- (b) Where the area of the land exceeds 2 023 m<sup>2</sup> (approximately ½ acre) provide firebreaks of at least 4 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings and haystacks situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside and along the external boundaries of the group or lot.

## Fuel and/or Gas Depots

In respect of land owned by you on which is situated any container normally used to contain liquid or gas fuel, including the land in which any ramp or support is constructed, you shall clear the land of all flammable materials.

(b) A bush fire brigade may be established for the whole of the Shire or for any specified area thereof.

## Appointment of Officers

2. The Council shall appoint a captain, a first lieutenant, a second lieutenant and such additional lieutenants as it shall deem necessary to act as officers of the brigade and who in the Council's opinion, have the necessary qualification and knowledge of the district required in such capacities.

3. The Shire Clerk or such other person as the Council may appoint, shall be the Secretary of the brigade.

4. The Council may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Council for the purposes of the brigade. Such officer may station such equipment at a depot approved by the captain where if possible, motor trucks can easily be called upon. If there are more than one such depot in the area, the equipment officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.

5. The Council shall appoint bush fire control officers in accordance with the requirements of the district and may prescribe the area over which each such officer shall have jurisdiction. The employment, dismissal and payment for services of persons (other than officers) employed for duties under this Act shall be vested in the President and Shire Clerk of the Council conjointly.

## Duties of the Officers

6. The duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act 1954 and each officer so appointed shall be supplied with a copy of the Act and regulations. The captain shall have full control over the members of the brigade whilst engaged in fire fighting and shall issue instructions as to the methods to be adopted by the firemen. In the absence of the captain, the first lieutenant; and in the absence of the first, the second lieutenant or senior officer of the brigade present at the fire shall exercise all the power and duties of the captain.

## Membership of Brigade

7. (1) The membership of a bush fire brigade may consist of the following:—

- (a) Subscribing members
- (b) Fire fighting members; and
- (c) Associate members.

(2) Subscribing members shall be those persons, who being interested in forwarding the objects of the brigade, pay an annual subscription to the funds of the brigade at the discretion of the Brigade.

(3) Fire Fighting members shall be those persons, being able bodied members of either sex over fifteen years who are willing to render service at any bush fire when called upon; and who sign an undertaking in the form contained in the First Schedule to these by-laws.

(4) Associate members shall be those persons who are willing to supply free motor transport for fire fighters or equipment, or are prepared to render other approved assistance, and who sign an undertaking in the form contained in the Second Schedule to these by-laws.

(5) No fees or subscriptions shall be payable either by fire fighting members or associate members and the enrolment of persons as such members shall in every case be subject to the approval of the Council.

(6) A subscribing member shall be eligible for enrolment as a fire fighting member.

## Finance

8. The expenditure incurred by the Council in the purchase of equipment, payment for services and generally for the purpose of this Act, shall be a charge on the ordinary revenue of the Council, but the Shire Clerk shall ensure that records of the expenditure incurred under this Act are maintained.

## Meetings of Brigades

9. Meetings will be held as necessary.

##### Powers and Duties of Officers

5. The powers and duties of all officers appointed under these by-laws shall be as laid down in the provisions of the Bush Fires Act 1954 and each officer so appointed shall be supplied with a copy of the Act and regulations.

##### Membership of Brigade

6. (1) The membership of a bush fire brigade may consist of the following:

- (a) subscribing members; and
- (b) firefighting members.

(2) Subscribing members shall be those persons, who being interested in forwarding the objects of the brigade, pay an annual subscription to the funds of the brigade at the following rates:

- (i) owner or occupier of land within the brigade area—minimum subscription of \$5.00;
- (ii) other persons—minimum subscription of \$1.00.

(3) Firefighting members shall be those persons, being able bodied persons over 16 years of age who are willing to render service at any bush fire when called upon; and who sign an undertaking in the form contained in the First Schedule to these by-laws.

(4) No fees or subscriptions shall be payable by firefighting members and the enrolment of persons as such members shall in every case be subject to the approval of the Council.

(5) A subscribing member shall be eligible for enrolment as a firefighting member.

## Finance

7. The expenditure incurred by the Council in the purchase of equipment payment for services and generally for the purpose of this Act, shall be a charge on the ordinary revenue of the Council and records of such expenditure shall be maintained in accordance with Municipal audit requirements.
