WHEREAS it is enacted by section 26B, Part III, of the Rights in Water and Irrigation Act 1914, that the Governor may, by proclamation, declare any part of the State named or defined in the proclamation to be a proclaimed area for the purposes of section 26B, Part III, of the said Act; and may, by subsequent proclamation vary or cancel any such proclamation: Now, therefore, I, the said Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, do hereby vary the Eastern Goldfields Groundwater Area by the addition of that part of the State as shown marked and defined on Plans AJ34-1-1 and AJ34-1-2 as kept in the Water Authority of Western Australia to be a proclaimed area for the purposes of the said section 26B, Part III, of the said Act.

SUPREME COURT ACT 1935 AND ADMINISTRATION ACT 1903

PURSUANT to the powers conferred by the Supreme Court Act 1935, the Administration Act 1903, and all other powers hereunto enabling, the Judges of the Supreme Court of Western Australia hereby make the following rules.

AMENDMENT OF THE NON-CONTENTIOUS PROBATE RULES 1967.

Citation

1. These rules may be cited as the Non-contentious Probate Rules Amendment Rules 1986.

Commencement

2. These rules shall come into operation on the day on which the Administration Amendment Act 1986 comes into operation.

Principal Rules

3. In these rules the Non-contentious Probate Rules 1967* are referred to as the principal rules.

R.9 substituted

4. Rule 9 of the principal rules is deleted and the following rule is substituted:

Administrator's affidavit

9. An application for administration of the estate of a deceased person dying intestate shall be supported by an affidavit setting forth—

- (i) that the applicant (if a natural person) has attained the age of eighteen years;
- (ii) the death of the intestate and the date and place of his death and the status of the intestate, that is whether leaving a widow or widower, or dying a bachelor, widower, spinster, widow, or divorced person;
- (iii) that the deceased died intestate;
- (iv) that the applicant has made careful search and inquiry to ascertain whether the deceased left a will;
- (v) that the intestate left estate within Western Australia, and, where the applicant is a natural person, the gross value thereof;
- (vi) that the applicant has a right to the administration of the estate of the intestate, and the names and addresses of all persons who have a right thereto prior to or equal with the right of the applicant;
- (vii) the names, addresses and ages of the persons entitled in distribution to the estate of the intestate, and whether the deceased had adopted any child;
- (viii) the facts relied on to show who are the persons entitled to the administration of the estate of the intestate, and who are the persons entitled in distribution thereto;
- (ix) that the applicant if given a grant will administer the estate according to law; and
- (x) that no application for probate or administration in the matter has previously been made, or if there has been a previous application, the full particulars thereof.

R.9A amended

5. Rule 9A of the principal rules is amended by deleting subrules (1) and (2) and substituting the following subrules:

(1) An application by the Public Trustee for an order to administer the estate of a deceased person dying testate shall be supported by an affidavit setting forth—

- (a) the information required by rule 8, other than paragraphs (i) and (ix); and
- (b) the grounds upon which the application is based.

(2) An application by the Public Trustee for an order to administer the estate of a deceased person dying intestate shall be supported by an affidavit setting forth—

- (a) the information required by rule 9, other than paragraph (i) and paragraphs (vi) to (viii) inclusive;
- (b) particulars of the persons entitled in distribution to the estate of the intestate, in so far as they are known to the Public Trustee; and
- (c) the grounds upon which the application is based.

R.22 substituted

6. Rule 22 of the principal rules is deleted and the following rule is substituted:

Notice of application for administration

22. (1) Where the applicant for administration is not the sole person entitled to administration, there being another person or other persons within the jurisdiction also entitled thereto, the consents, duly verified, of any such persons shall be filed, or evidence shall be adduced that they were served with notice of the application, or that they cannot be found.

(2) The Registrar may direct that notice of an application for administration be given to any person, wherever he is resident, and whether or not he appears to be entitled in distribution to the estate of the intestate, and may dispense wholly or in part with the requirements of subrule (1) of this rule.

25. Where a creditor intends to apply for administration, he shall first issue a citation calling upon the persons entitled in distribution to show cause why administration should not be granted to him, and prove his debt before the Registrar.

BUSH FIRES ACT 1954

Shire of Harvey

Important Information Relating to Your Responsibility
as a Landholder in The Shire of Harvey

WITH reference to section 33 of the Bush Fires Act 1954, you are required to carry out fire prevention work on land owned or occupied by you, in accordance with the provisions of this order.

This work must be carried out by 15 November 1986, and kept maintained throughout the summer months until the close of the Restricted Burning Period, 1987. Persons who fail to comply with the requirements of the order may be issued with an infringement notice (penalty \$40) or prosecuted with an increased penalty, and additionally, Council may carry out the required work at cost to the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials as required by this notice, or where:

- (a) Compliance with this order may aggravate soil erosion problems; or
- (b) The owner or occupier of land considers a more effective system of the fire protection can be obtained; or
- (c) Natural features render firebreaks unnecessary;

You may apply to the Council or its duly authorised officer, not later than 1 November 1986, for permission to provide firebreaks in alternative positions (strategic breaks) or to take alternative action to abate fire hazards on the land.

Approval of variations to this order must be endorsed by a Fire Control Officer.

If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

A. Rural Land: Firebreaks not less than two metres wide must be provided in the following positions:

- (a) within 60 metres inside and along the boundaries of all land including that which is uncleared, so as to form a continuous break around the holding. (Note: firebreaks constructed on road verges do not constitute a legal firebreak);

- (b) where the area of land exceeds 120 ha (300 acres), additional firebreaks are required so as to divide the land into areas of not more than 120 ha (300 acres) which are completely surrounded by firebreaks;
- (c) not more than 100 metres and not less than 20 metres from the perimeter of all groups of buildings, haystacks and fuel installations provided on that land.

Note: Irrigation Areas—Owners or occupiers may be exempted from all or part of the requirements of the above if, in the opinion of the Fire Control Officer responsible for the area in which the land is located, there is no need to construct breaks on the irrigated land or non-irrigated land, not exceeding 20 hectares in area if surrounded by irrigated land.

B. Special Rural Land: The owners of all existing small rural holdings zoned as "Special Rural" under Town Planning Schemes, must maintain clear of all flammable materials, a firebreak not less than two metres wide immediately inside all external boundaries of the land.

C. Urban Land (Residential, Commercial and Industrial land within a townsite or any other area subdivided for residential purposes): In respect of land owned or occupied by you within any townsite or any area subdivided for other purposes, you shall:

- (a) Where the area of land is 2 024 sq.m (approx. ½ acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land; and
- (b) Where the area of land exceeds 2 024 sq.m (approx. ½ acre) provide firebreaks of at least two metres wide immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside and along the external boundaries of the group or lot.

Note: Myalup and Binningup—Firebreaks two metres wide inside and around all boundaries of land are accepted in lieu of item (a) of the above requirements.

D. Fuel and/or Gas Depots: In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall maintain the land clear of all flammable materials.

E. Pine Plantations: Any pines planted for commercial purposes constitute a pine plantation and you are required to provide firebreaks:

- (a) not less than 10 metres wide around the perimeter of each plantation;
- (b) not less than 6 metres in width in such position that no part or compartment of the plantation exceeds 28 hectares in area.

BUSH FIRES ACT 1954

Shire of Lake Grace

Notice to all Owners and or Occupiers of Land in the Shire of Lake Grace.

(b) Any aerial landing ground used as the motor start up, refuelling and maintenance area to be completely cleared of inflammable materials for a radius of 18 metres; and

(4) Maintain clear of all inflammable materials all townsite blocks; and

(5) Where the bush of land has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether intended to burn the bush or not), provide a firebreak of not less than 13 metres wide immediately inside the external boundaries of the land so prepared. If you become owner or occupier of land after 1 November 1983, the requirements of this notice are varied so as to require you to comply with the terms of this notice within 14 days of the date of your becoming owner or occupier of such land, instead of on or before 1 November 1983. The firebreaks required by this notice are to be maintained clear of inflammable materials up to and including 31 March 1984.

If it is considered to be impracticable for any reason to clear firebreaks as required by this notice, you may apply to the Council or its duly authorised officer for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Council or its duly authorised officer, you shall comply with the requirements of this notice.

If it is considered for any reason to be impractical to clear firebreaks as required by this notice or if natural features render firebreaks unnecessary, you may apply to the Council or its duly authorised officer not later than 8 December 1986, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by Council or its duly authorised officer, you shall comply with the requirements of this notice. If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

A. Rural Land: (All land other than a pine plantation and that listed as Urban).

Firebreaks not less than two (2) metres wide must be provided in the following positions:

(a) "Strategic Break" means a firebreak constructed wherever the lie of the land permits or where it is most convenient for fire protection. Rivers, creeks and green flats and subdivisional roads including Forests Department firebreaks outside a property constitute a strategic break. A copy of the plan to be held in the Shire Office.

That each Brigade draw up a strategic plan to cover their area.

(b) Not more than 100 metres and not less than 20 metres from the perimeter of all buildings and/or haystacks situated on the land. Haystacks includes hayrolls.

(c) Forestry firebreaks will only be accepted if approved by the Department of Conservation and Land Management and a Fire Control Officer in writing.

NOTE: Grassed lawns around dwellings are construed as firebreaks.

B. Special Rural Land: The owners of all existing small rural holdings zoned as Special Rural under Town Planning Schemes must retain clear of all flammable materials a firebreak not less than two (2) metres wide immediately inside all external boundaries of the land.

C. Urban Land: (Residential, Commercial and Industrial land within a townsite or within any area subdivided for residential purposes).

In respect of land owned or occupied by you within any town site or within any area subdivided for other purposes, you shall:

(a) Where the area of land is 2 024 sq. m (approximately ½ acre) or less, remove all flammable material on the land except living standing trees, from the whole of the land; and

(b) Where the area of land exceeds 2 024 sq. m (½ acre), provide firebreaks of at least 2 metres wide, immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier, the firebreaks may be provided inside and along the external boundaries of the group or lot.

D. Fuel and/or Gas Depots: In respect of land owned or occupied by you on which is situated any container normally used to contain liquid or gas fuel, including the land on which any ramp or supports are constructed, you shall maintain the land clear of all flammable materials.

E. Pine Plantations: Any pines planted for commercial purposes constitute a pine plantation and you are required to provide firebreaks:

- (a) Not less than 20 metres wide around the perimeter of each plantation;
- (b) Not less than 20 metres wide along those portions of the plantation which abut a used public road;
- (c) Not less than 6 metres in width in such position that no part or compartment of the plantation exceeds twenty-eight (28) hectares in area.

New Plantation: Pines or any other non-indigenous trees planted for commercial purposes on or after 17 August 1978, constitute a new plantation and you are required to provide firebreaks not less than forty (40) metres wide in the above situations.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act, which include the necessity for permits to burn during the restricted burning season.

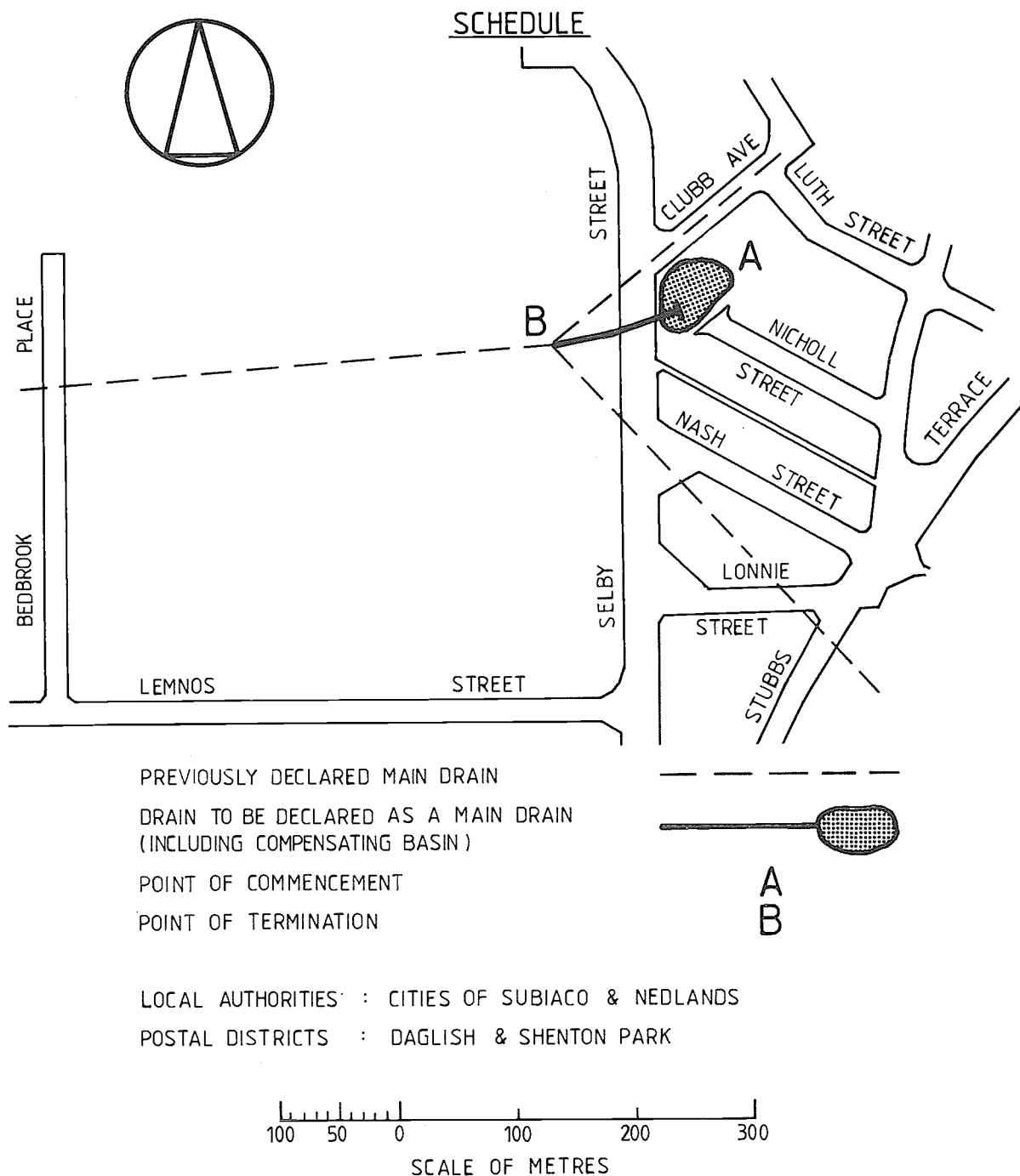
