TRAVEL COMPENSATION FUND

TRAVEL AGENTS ACT 1985

For the general information of the Public, Travel Agents, Carriers and Tour Wholesalers, published below is a list of persons and corporations that at 15 June, 1987, have applied for membership of the Travel Compensation Fund, have not been refused membership of the Travel Compensation Fund and also who have applied for licensing in Western Australia as a Travel Agent. The list will be periodically updated and the updated list published in the Government Gazette.

The list is divided into 2 parts and within each part into 2 further sub-parts as follows:-

1. Applicants for membership of the Travel Compensation Fund - not yet admitted to the Fund as a member (Application pending).
 - (i) Natural Persons
 - (ii) Corporations
2. Applicants who have been admitted as members of the Travel Compensation Fund.
 - (i) Natural Persons
 - (ii) Corporations

If a Travel Agent is not shown on either of the above lists, then that Travel Agent either has not applied for membership of the Travel Compensation Fund (at least in respect of that Travel Agent's Western Australian operations), has had that Travel Agent's application for membership of the Travel Compensation Fund refused, or is exempt from the need to be licensed as a Travel Agent in Western Australia.

In respect of those Travel Agents that are exempt from the necessity to be licensed in Western Australia, the Commercial Tribunal does not grant exemptions. It is up to the individual Travel Agent to determine whether or not he/she/it is required to be licensed, and for every person/firm/corporation that deals with that Travel Agent to determine whether or not that Travel Agent is exempt from licensing.

Exempt Travel Agents are not required to be members of the Travel Compensation Fund, although they are urged to become members.

The exemption is set forth on page 110 of the Government Gazette of 16 January, 1987. The relevant Section is Section 3 which reads -

- "3. It is hereby declared that Part 11 of the Act does not have effect in relation to -
 - (a) a person who carries on business as a Travel Agent only insofar as he makes arrangements for travel within the Commonwealth, the total value

of which arrangements does not in any one financial year exceed \$30,000.00; or

(b) a person specified in the Schedule.

Westrail and Western Australian Tourism Commission are exempt by virtue of Section 5 of the Travel Agents' Act, 1985, as is The Rural and Industries Bank of Western Australia which is a prescribed Public Statutory Authority for the purposes of Section 5(2)(c) of the Act. (See clause 5 of the Travel Agents' Regulations, 1986).
