### WATER AUTHORITY ACT 1984

#### LAND DRAINAGE (RATING GRADES) AMENDMENT REGULATIONS 1987

MADE by His Excellency the Governor in Executive Council for the purposes of section 89 of the *Land Drainage Act 1925*.

#### Citation

1. These regulations may be cited as the *Land Drainage (Rating Grades) Amendment Regulations 1987*.

#### Commencement

2. These regulations shall come into operation on 1 July 1987.

#### Schedule amended

3. The Schedule to the *Land Drainage (Rating Grades) Regulations 1986\** is amended by deleting the part of the Schedule under the heading "Urban Land" and substituting the following—

##### " Urban land—general grades

1. These grades comprise all urban land within a district that does not come within the definition of urban land—caravan bay grade in the Schedule.

2. These grades are defined according to the area of the land concerned as follows—

- (a) not exceeding 2 500 m<sup>2</sup>;
- (b) exceeding 2 500 m<sup>2</sup> but not exceeding 10 000 m<sup>2</sup>;
- (c) exceeding 10 000 m<sup>2</sup> but not exceeding 15 000 m<sup>2</sup>;
- (d) exceeding 15 000 m<sup>2</sup> but not exceeding 20 000 m<sup>2</sup>; and
- (e) exceeding 20 000 m<sup>2</sup>.

##### Urban land—caravan bay grade

This grade consists of all land in a district comprising a single caravan bay that is a lot within the meaning of the *Strata Titles Act 1985*.

3. Regulation 12D of the *Rights in Water and Irrigation (Construction and Alteration of Wells) Regulations 1963\** is amended in subregulation (3) by deleting "\$5" and substituting the following—

“ \$5.50 ”.

2. These regulations shall come into operation on 1 July 1987.

**Regulation 24 amended**

3. Regulation 24 of the *Rights in Water and Irrigation Act Regulations 1941\**, is amended—

(a) by deleting "85.00" and substituting the following—

“ 89.00 ”;

(b) by deleting "38.00", wherever occurring, and substituting in each case the following—

“ 40.00 ”; and

(c) by deleting "2.00" and substituting the following—

“ 2.50 ”.
