## Rules of Trotting

## Notice of Amendment

NOTICE is hereby given that at a meeting of the Committee of the Western Australian Trotting Association held at Gloucester Park, East Perth on 1 March 1988 it was resolved by an absolute majority of the Committee that the Rules of Trotting be amended as follows.

1. By the deletion of paragraphs (iii) and (iv) of Rule 359A and the substitution therefor of the following—

(iii) The Controlling Body may from time to time publish a schedule of substances and maximum levels for the purpose of Sub-Rule 359A (i).

2. That Rules 108 to Rule 116 inclusive as published on 26 June 1987 be deleted.

3. By inclusion after Rule 107A of the following Rule 107AA—

A claiming race is a race in which any horse starting therein may be claimed for a designated amount in conference with the rules.

4. That Rule 136A be amended by the deletion thereof and the substitution therefor of the following—

(a) Where in the opinion of the stewards any driver and/or trainer licensed under these Rules is under the influence of alcohol or drugs the stewards may require such licensed driver and/or trainer to undergo a test by means of a Drager Alcotest Model breathalyser or any instrument approved by the Road Traffic Authority and any person with a reading equal to or above 0.02 shall be deemed to be under the influence of alcohol and accordingly be deemed to be unfit pursuant to these Rules.

(b) Where a driver and/or trainer licensed under these Rules provides a sample of breath for analysis pursuant to the abovementioned paragraph (a) and the analysis indicates—

(i) that there is no alcohol present in the blood of the licensed driver and/or trainer; or

(ii) that the percentage of alcohol present is such that it does not reasonably explain the conduct, condition or appearance of the licensed driver and/or trainer;

the stewards and/or security officer may require the person to allow a medical practitioner to take a sample of his blood and/or urine for analysis by the Government Laboratories and if any person licensed under these Rules as a result of the analysis by the Government Chemical Laboratories is found to be under the influence of a drug or drugs he or she shall be deemed to be unfit pursuant to these Rules.

(c) Any licensed driver and/or trainer under these Rules who fails to comply with the requirements of paragraph (a) or (b) abovementioned shall commit an offence against these Rules and shall be liable to be dealt with accordingly under Rule 368 (c).

## WILDLIFE CONSERVATION AMENDMENT REGULATIONS 1988

1. These regulations may be cited as the *Wildlife Conservation Amendment Regulations 1988*.

## Regulation 63 inserted

2. The *Wildlife Conservation Regulations\** are amended by inserting after regulation 62 the following regulation—

## “ Suspension of section 63

63. The operation of section 23 (1) of the Act is indefinitely suspended—

- (a) in all parts of the State with respect to the taking of any fauna, other than the dugong (*Dugong dugon*), declared under section 14 (2) (ba) of the Act to be fauna which is likely to become extinct, or is rare, or otherwise in need of special protection; and  
(b) in all parts of the State with respect to the taking of flora declared under section 23F of the Act to be rare flora. ”

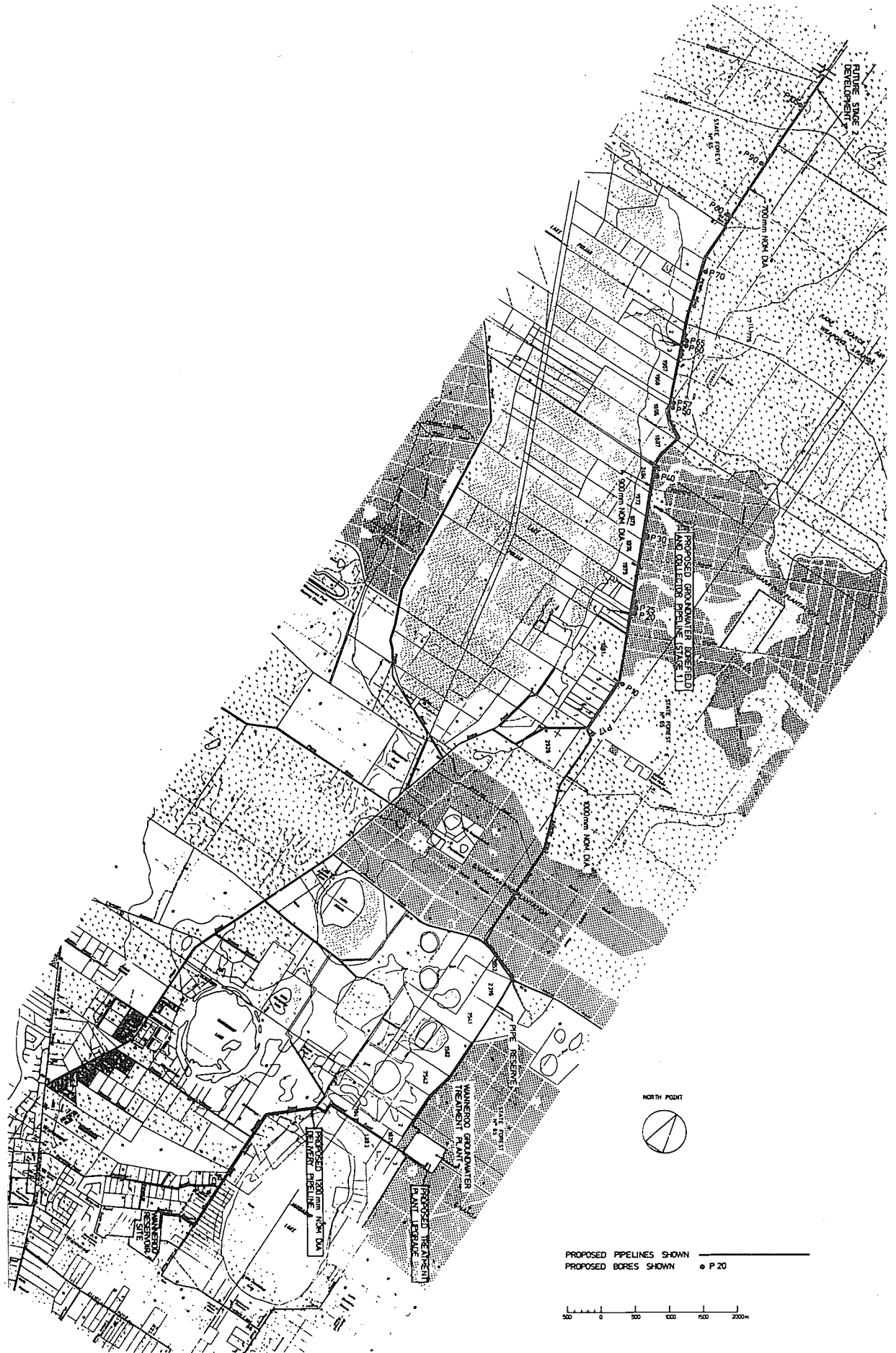

## Auditors' Report

We have audited the attached accounts of the Shire of Chittering for the year ended 30 June 1987 being the Balance Sheet and Municipal Fund Summary of Financial Activity, in accordance with the requirements of the Local Government Audit Directions and Australian Auditing Standards and report thereon as follows—

1. Only limited provision has been made in the accounts for depreciation of fixed assets. Whilst this policy is in accordance with the Local Government Audit Directions it constitutes a departure from the Australian Accounting Standard in respect to depreciation of non-current assets. In our opinion, provisions for depreciation should have been made against all fixed assets (except freehold land), with a corresponding charge to the Municipal Account, so as to absorb the cost of these assets over their useful economic lives. We are unable to determine the amount of depreciation that should have been provided.
2. The Shire Clerk's Advance Account has been overdrawn on a number of occasions during the year. This contravenes the borrowing provisions of the Local Government Act.

Subject to the above, in our opinion—

- (a) the accompanying accounts, being the Balance Sheet and Municipal Fund Summary of Financial Activity, are in accordance with the books of the Council and have been prepared in accordance with the Local Government Act, Local Government Accounting Directions and the accounting policies stated in Note 1 to the Accounts, so as to give a true and fair view of the financial position of the Council as at 30 June 1987 and the results of its activities for the year ended on that date; and
- (b) the accounting records required by the Local Government Act to be kept by the Council have been properly kept in accordance with the provisions of that Act.

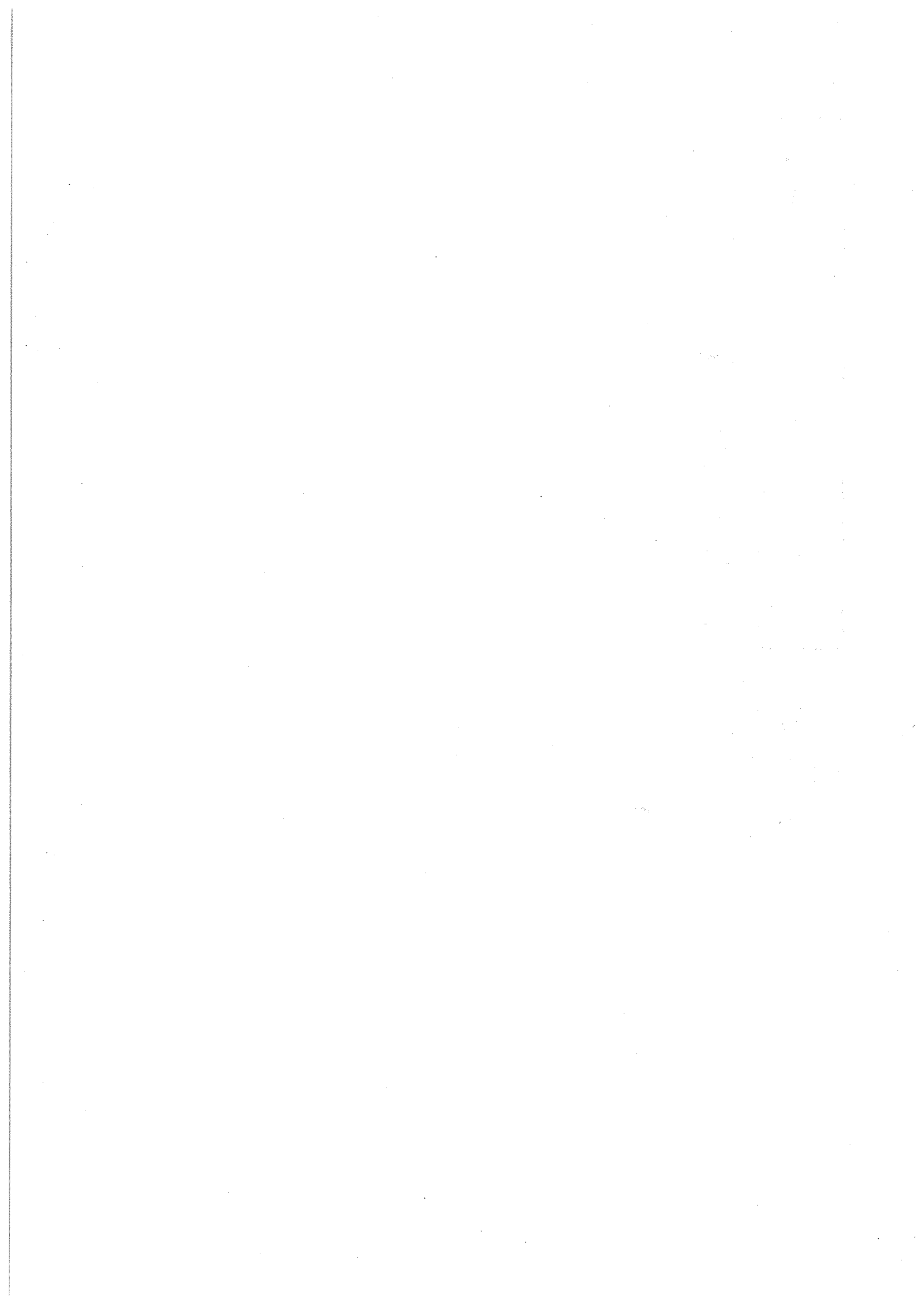
