LEGAL PRACTITIONERS ACT 1893

Legal Costs Report and Determination by the Legal Costs Committee

ON 12 February 1988 the Acts Amendment (Legal Practitioners, Costs and Taxation) Act ("the Act") was proclaimed. The Act—

- repealed the legislative provisions which empowered the courts to set costs; and
- established the Legal Costs Committee ("the Committee") to determine legal practitioners' remuneration.

The previously existing costs scales achieved two purposes—

- regulated the payment that legal practitioners could command (the Committee notes that by agreement between practitioner and client the scales may be contracted out of but a Judge has power to review any such agreement. In cases of review, the scales provided an important indicator); and
- regulated party and party costs in cases where a successful litigant was awarded costs to be paid by an unsuccessful litigant.

Following a request by the Law Society of Western Australia (Inc) ("the Law Society") for an urgent review and taking into account the three year period which has elapsed since costs scales were last reviewed, and the repeal of the then existing costs scales by the proclamation of the Act, the Committee decided to proceed to a report and determination as quickly as possible.

In compliance with section 58Y of the Act, the Law Society was notified by letter dated 15 March 1988 of the intention of the Committee to make a determination. Advertisements were placed in *The West Australian* newspaper on 16 and 19 March 1988 advising the intention of the Committee to make a determination and inviting submissions.

A written submission was received from the Law Society. The Law Society also requested an oral hearing which took place on the 19 May 1988. No other submissions were received.

In compliance with section 58Y of the Act the Committee also wrote to the Chief Justice of the Supreme Court, the Chairman of Judges of the District Court, the Chief Stipendiary Magistrate and the Chairman of the Workers' Compensation Board advising the intention of the Committee to make a determination and inviting comments. Replies have been received from the relevant Courts and comments made taken into account.

The Committee has determined, pending carrying out a detailed investigation under the provisions of section 58T of the Act, that costs scales which were in existence prior to the proclamation of the Act should form the basis of this determination.

The Committee believes that before undertaking a major study into the manner in which practitioners are remunerated, all interested parties and members of the public should have ample time to prepare considered submissions. Any fundamental change from the manner in which costs have been charged in Western Australia to date should be, and be shown to be an improvement on the system which has existed to date. That study would be a major undertaking and is one with which the Committee proposes to proceed after the gazettal of this report and determination.

There has been no increase in legal practitioners' remuneration for a period of three years. The Law Society in its written submission initially requested a 15 per cent increase across the board on the previously existing costs scales. At its oral hearing The Law Society sought to have that figure increased to 30 per cent. The Society submitted that legal practitioners' overheads, particularly relating to the payment of professional and non-professional salaries, rent, communication costs, professional indemnity insurance (particularly since such insurance will become compulsory from the 1 July 1988) and library costs had increased enormously in the last two to three years. The Committee recognised that there has been a large increase in overhead costs in the past three years.

The Committee had no information concerning efficiency and technology gains, if any, which may have been achieved in the legal profession during the last three years.

The Committee has emphasized that it does not propose in this determination to conduct a detailed enquiry. In the Committee's view it is in the interests of both practitioners and members of the public that the cost structure system upon which all parties have come to rely in Western Australia be retained for the time being.

Bearing in mind the submissions received from the Law Society, increases in the commercial costs of undertaking legal practice, the general cost of living increases experienced in the past three years, and with a view to establishing a reasonable balance between the interests of the public and legal practitioners, the Committee has determined that the costs scales in existence immediately prior to the proclamation of the Act on the 12 February 1988 should be reinstated and increased by 18 per cent.

Determination

Pursuant to section 58ZA of the Act the Committee makes the following determination—

1. The costs scales which governed the remuneration of legal practitioners immediately prior to the proclamation of the Act are hereby re-introduced to regulate the remuneration of practitioners in respect of the business specified in paragraph 3 of this determination.
2. The costs scales referred to in paragraph 1 are hereby increased by 18 per cent as from the date of the publication in the *Gazette* of this determination. Where the increase leads to a calculation resulting in a fraction of a cent the fraction is to be disregarded.
3. The business referred to in paragraph 1 is—
 - (a) non-contentious business carried out by practitioners;
 - (b) contentious business carried out by practitioners in or for the purposes of proceedings before—
 - (i) the Supreme Court;
 - (ii) the District Court;
 - (iii) a Local Court;
 - (iv) a Court of Petty Sessions;
 - (v) the Workers' Compensation Board constituted under the Workers' Compensation and Assistance Act 1981.

SALARIES AND ALLOWANCES ACT 1975

Variation of a Determination made by the Salaries and Allowances Tribunal

IT is notified for general information that the Determination of the Salaries and Allowances Tribunal published in the *Government Gazette* (No. 49) of 20 May 1988 is varied as follows.

Remuneration of Persons Holding Prescribed Offices

Following a report from a firm of remuneration consultants in 1987 the Tribunal issued a Determination increasing the number of salary levels within the Special Division from five to seven.

The new levels were introduced to give some recognition to levels of responsibility assumed by the holders of the more senior offices within Government. In issuing its Determination, the Tribunal indicated that whilst aware of the situation prevailing in respect of Chief Executive salaries within the private sector, it was not prepared at that stage to match levels and benefits extended to such Chief Executives.

Much has been said in the last 12 months concerning executive remuneration and the most recent indications are that Governments, both State and Federal, are of necessity moving to free restrictions on certain senior positions.

This Tribunal cannot, with fair conscience, ignore the demands being placed upon it in terms of "one off" salaries for particular positions. Whilst the review that culminated in the publication of the 1987 salary rates was the first involving remuneration consultants, further reviews will be conducted utilising the services of such consultants in the future.

The tendency to appoint persons to senior positions on a contract or term basis, without an ongoing security of tenure, requires amongst other considerations, that the levels of remuneration paid be competitive with the market place where similar situations apply.

The Tribunal, in accepting that senior executive positions have become more onerous and complex, cannot simply maintain the indexing of pay levels for all positions that fall within its jurisdiction, but must have regard for the conditions prevailing within the private sector. It is for this reason that the Hon Premier has been advised that when it is considered that a situation exists where special circumstances apply, the Tribunal will consider individual determinations for such positions to ensure the salary offered is sufficient to attract and retain the most competent persons.

It is envisaged that generally, though not necessarily always, such positions will fall within organisations that are subject to commercial market disciplines or where a particular expertise is sought for a specific position.

To avoid the possibility of a flow on of higher salaries to other senior positions within Government, the maintenance of existing relativities is seen as essential and for this reason is proposed that all positions, irrespective of the final salary approved, will be dealt with by classifying them within the normal salary ranges already determined by the Tribunal i.e. the seven levels. Any additional amount paid to the occupants of these special positions above the basis salary determined will be negotiated by the Public Service Commissioner within a nominated salary range and will be subject to ratification by this Tribunal. Such determinations will, as a general rule, not be made without the advice of independent consultants.

Salaries determined in accordance with the new arrangements will be subject to periodic review. Upon a position becoming vacant, any additional salary component will lapse pending a further review by the Tribunal.

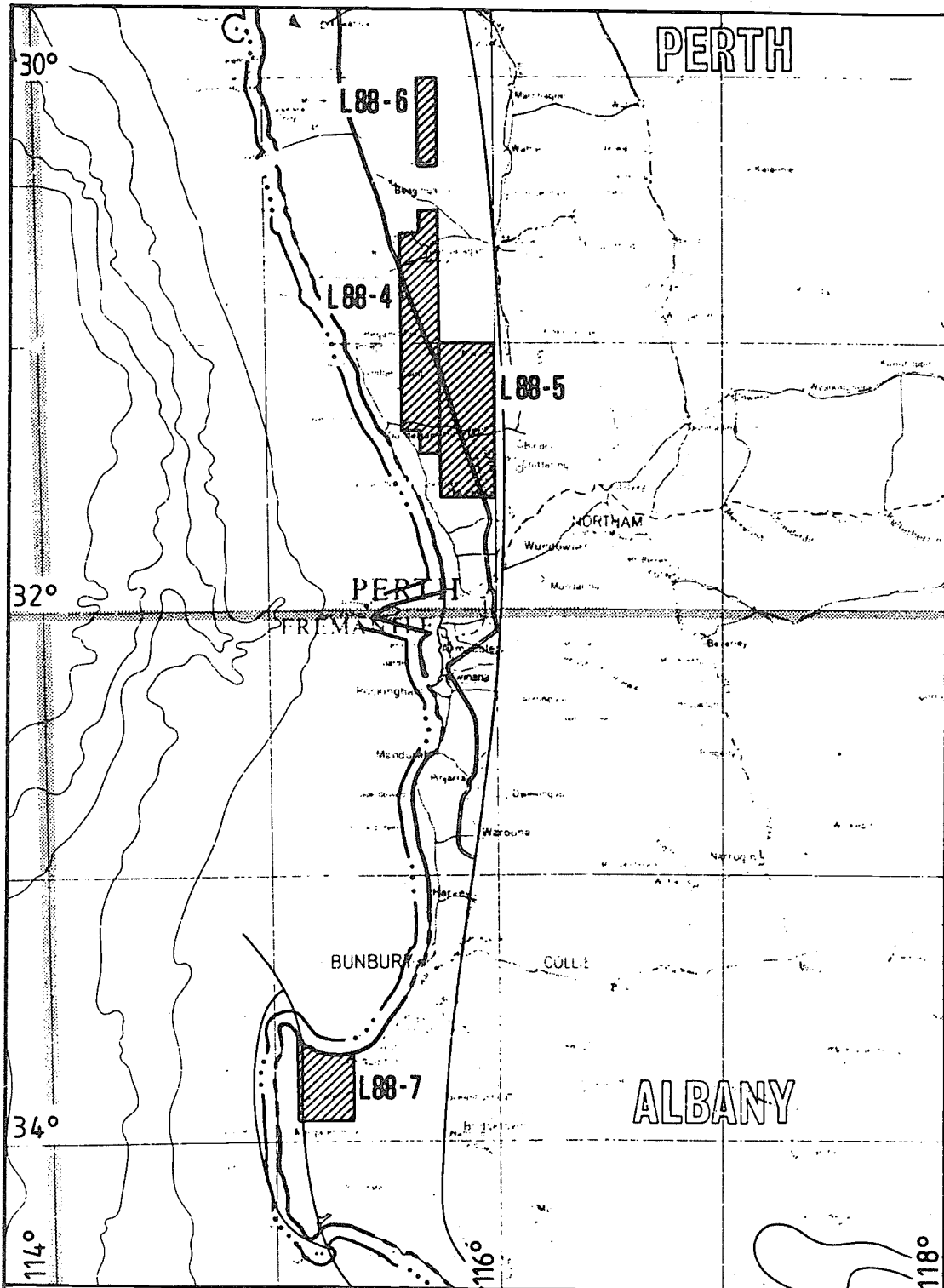

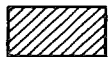

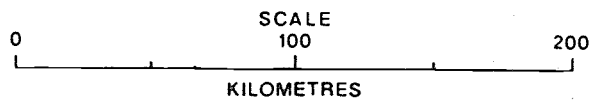
