Petroleum Act 1967 PROCLAMATION

WESTERN AUSTRALIA GORDON REID, Governor. [L.S.] By His Excellency Professor Gordon Reid, Companion of the Order of Australia, Governor of the State of Western Australia.

WHEREAS it is enacted by Subsection (2) of Section 15 and Subsections (2) and (3) of Section 152 of the Petroleum Act, 1967-81 that notwithstanding the Land Act, 1933 or any other Act the Governor, by proclamation, may declare that any land of the Crown or part thereof reserved for or dedicated to any public purpose under any Act and howsoever classified that—

- (a) is not Crown land within the meaning of that expression in Section 5 of the Act; and
- (b) is specified in the proclamation, is Crown land for the purposes of the Petroleum Act, 1967-81 and is land to which that Act applies so long as the proclamation remains in force.

At a Meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 11th day of October 1988, the following Orders in Council were authorised to be issued—

Notice to all Owners or Occupiers of Land in the District of the City of Wanneroo Regarding Firebreaks.

THE City of Wanneroo hereby gives notice pursuant to Section 33 of the Bush Fires Act 1954 to all owners or occupiers of land in its district that they are required on or before 30 November 1988 or within 14 days of becoming the owner or occupier of land if that occurs after 30 November 1988 to plough, cultivate, scarify, burn or otherwise clear firebreaks as specified in this Notice and thereafter up to and including 30 April 1989 to maintain the firebreak clear of inflammable matter.

- 3. Buildings: A firebreak not less than three metres wide immediately around all external walls of every building must be cleared of inflammable material by ploughing, cultivating, mowing, slashing or chemical application.

Whenever a firebreak is cleared by burning the provisions of the Act and Regulations made thereunder must be observed.

If pursuant to Item 2 of this Notice, mowing or slashing is carried out the height of vegetation thereafter must not exceed, as far as is reasonably practicable, 20 mm over the entire area of the land. The use of chemicals is subject to all restrictions imposed by the Department of Agriculture.

 - (iv) A ballot box shall be available for the receipt of ballot papers and the Returning Officer shall be responsible for its safekeeping.
 - (v) The ballot paper shall list the names of the candidates in an order determined by lot by the Returning Officer.
 - (vi) Each candidate nominated for election may, in writing, appoint a person to be a scrutineer in respect of that election, being a person other than a candidate, and may, in writing appoint another such person to carry out the functions of the scrutineer where the first-mentioned person does not carry out those functions. Each scrutineer shall be entitled to be present on all occasions when the Returning Officer is taking any step in the conduct and counting of the ballot. It shall be the duty of each scrutineer so to conduct himself as not to interfere with the due performance of the Returning Officer's duties and to report to the Returning Officer forthwith any irregularities which he may observe. He shall, if so required by the Returning Officer, make any objection or any request for information in writing. The Returning Officer shall answer all reasonable enquiries by any scrutineer as to the time and place at which he will take

any step in connection with the election, but shall not otherwise be under any duty to notify scrutineers of such matters.

- (vii) An election shall not be invalidated by inadvertent failure to give any person qualified to vote any notice required by this statute.
- 3.5.7 Ballot papers shall be initialled by the Returning Officer or other person nominated by the Returning Officer in writing for that purpose.
- 3.5.8 The system of voting to be used shall be an optional preferential system and shall be conducted as follows:
 - (i) Ballot papers may be marked by placing the numeral 1 beside the name of the candidate for whom the voter wishes to vote provided that a voter who wishes to express a second subsequent any or preference shall place the numeral 1 beside the candidate of his first preference and the numerals 2, 3, 4 and so on in numerical order beside the name or names of any candidate or candidates for whom he wishes to express a second or subsequent preference. A ballot paper shall not be invalid merely because the voter has not expressed a preference for all of the candidates provided that in an election to fill two or more vacancies it shall be necessary to express a preference for at least the same number of candidates as there are vacancies to be filled.
 - (ii) Upon the close of the ballot the Returning Officer shall scrutinise the ballot papers and eliminate any invalid votes. He shall then count and record the number of votes (other than second or subsequent preferences) expressed for each candidate.
 - (iii) In the case of an election at which only one vacancy is to be filled, the Returning Officer shall declare elected the candidate (if any) who has an absolute majority of votes provided that if no candidate has an absolute majority on the first count, the Returning Officer shall eliminate the candidate with the lowest number of votes and shall distribute these votes amongst the remaining candidates according to their next preferences (if any) expressed thereon. This procedure shall be repeated until one candidate has absolute majority whereupon that candidate shall be declared elected.
 - (iv) In the case of an election at which two or more vacancies are to be filled, the Returning Officer shall declare first elected the candidate (if any) who has an absolute majority provided that if no candidate has an absolute majority on the first count, the Returning Officer shall eliminate the candidate with the lowest number of votes and shall distribute these votes amongst the remaining candidates according to their next preference expressed thereon. This procedure shall be repeated until one candidate has an absolute majority whereupon that candidate shall be declared first elected. Once the first candidate has been elected, the Returning Officer shall return all the ballot papers to the candidates of their first preferences. The Returning Officer shall then distribute the votes of the first elected candidate

according to their next preferences expressed thereon. The Returning Officer shall then declare second elected the candidate (if any) who now has an absolute majority of votes provided that if no candidate has an absolute majority on this count, the Returning Officer shall eliminate the candidate with the lowest number of votes and shall distribute these votes amongst the remaining candidates according to their next preferences (if any) expressed thereon. This procedure shall be repeated until a second candidate shall be declared second elected. The Returning Officer shall then return all the ballot papers to the candidates of their first preferences and shall continue to repeat the procedures outlined in this section until the required number of vacancies are filled.

- (f) in subsection 3.7, repealing the subsection and substituting the following—
 - 3.7 In matters not covered by the provisions of this Statute, the Returning Officer shall adopt the procedures as outlined in the Commonwealth Electoral Act.
 - 3.8 Right of Appeal

A candidate shall have the right of appeal to the Chairman within seven (7) days of the declaration of the poll should he feel that the conduct of the election was in any way contrary to this Statute.

The Chairman shall have the power to make such enquiry as he deems necessary into the matter complained of and after such enquiry may confirm the election or annul the election and direct that a fresh election be held."
