QUEEN ELIZABETH II MEDICAL CENTRE ACT 1966
 QUEEN ELIZABETH II MEDICAL CENTRE (DELEGATED SITE)
 AMENDMENT BY-LAWS 1988

MADE by the Board of the Sir Charles Gairdner Hospital under section 13 (2e) in its capacity as a delegate under section 13 with the approval of His Excellency the Governor given on the recommendation of The Queen Elizabeth II Medical Centre Trust.

Citation

1. These by-laws may be cited as the *Queen Elizabeth II Medical Centre (Delegated Site) Amendment By-laws 1988*.

Principal by-laws

2. In these by-laws, the *Queen Elizabeth II Medical Centre (Delegated Site) By-laws 1986** are referred to as the principal by-laws.

By-law 25 amended

3. By-law 25 of the principal by-laws is amended—
 - (a) by inserting after sub-by-law (3) the following sub-by-law—

“ (3a) The charge prescribed for the purposes of sub-by-law (3) is 20c for every 3 hours or part thereof. ”; and
 - (b) in sub-by-law (4) by deleting “valid”.

By-law 26 repealed and a by-law substituted

4. By-law 26 of the principal by-laws is repealed and the following by-law is substituted—

Parking permits

- “ 26. (1) The secretary may issue to a person who complies with this by-law an annual permit or a temporary permit authorizing that person to park a vehicle in a parking facility.
- (2) The fee payable for an annual permit shall be \$52 which shall be payable—
 - (a) in advance in full;
 - (b) in advance for each 3 monthly period; or
 - (c) each fortnight by payroll deduction.
 - (3) The secretary may issue a temporary permit to a person where he considers the issue of an annual permit would be impracticable or inappropriate and a temporary permit may be in respect of such period and shall be paid for at such time and in such manner as the secretary may determine in each case but the fee in all cases shall be payable and calculated at the rate of \$1 per week or part thereof.
 - (4) An application by a person for an annual permit or a temporary permit shall be—
 - (a) made in accordance with the form approved by the secretary;
 - (b) accompanied by a deposit fee of \$10 for the issue of a boomgate control card, except where the payment of that fee is waived by the secretary,
 and in the case of an application for an annual permit—
 - (c) accompanied by the fee payable under sub-by-law (2) (a) or (b) or where a person intends to pay each fortnight by way of payroll deduction, a pro-curation authority in the form approved by the secretary.
 - (5) A person holding an annual permit or a temporary permit which will soon expire who desires to obtain a further permit of either class may without completing a further application form request the secretary to issue a further permit and the secretary may issue a further permit—
 - (a) in the case of an annual permit, on payment of the fee referred to in sub-by-law (2) in the manner prescribed by that sub-by-law; or
 - (b) in the case of a temporary permit, in accordance with sub-by-law (3).
 - (6) Notwithstanding sub-by-laws (1) to (5), the secretary may waive the fee for an annual permit or a temporary permit in any case where he considers there are proper grounds for so doing.
 - (7) A permit may authorize parking in a specified portion of a parking facility or anywhere within either a specified parking facility or any parking facility.
 - (8) The use of a permit issued to a person is valid—
 - (a) if issued in relation to a specified vehicle or class of vehicle, for the purposes of parking only the vehicle or class of vehicle so specified;
 - (b) if issued for the purposes of parking a vehicle owned by a specified person or class of persons, for the purposes of parking only a vehicle owned by the person or class of persons so specified;
 - (c) if issued for the purposes of parking a vehicle in a specified portion of a parking facility or a specified parking facility, for the purposes of parking a vehicle only in the portion of a parking facility or parking facility so specified;
 - (d) if issued for the purposes of parking a vehicle during specified hours, for the purposes of parking a vehicle only during the hours so specified;
 - (e) for the purposes of parking a vehicle only during the period of time specified in or provided for by the permit.
 - (9) The Secretary may cancel a permit if—
 - (a) a vehicle in respect of which the permit is issued is parked in the site in contravention of these by-laws;
 - (b) the person in relation to whom the permit is issued commits an offence against these by-laws;
 - (c) the person in relation to whom the permit is issued ceases to have a connection with the site; or
 - (d) any charge required to be paid in relation to the permit remains unpaid.

(10) A person shall not use a permit for a purpose that is not valid under sub-by-law (8).

(11) In this by-law—
“specified” means specified in the relevant permit. ”.

By-laws 26A and 26B inserted

5. After by-law 26 of the principal by-laws the following by-laws are inserted—

Refund of parking permit fees

“ 26A. (1) A refund in relation to a fee for a permit paid in advance shall be made in accordance with sub-by-law (2) to a person whose employment at the Hospital terminates or who is granted absence on long service leave or sick leave in relation to employment at the Hospital for a period of 4 consecutive weeks or longer.

(2) The refund shall be—

(a) in the case of a person whose employment terminates, an amount in the same proportion to the amount of fee paid as is represented by the period of the permit which remains unexpired after the last day of service of the person in proportion to the period for which the permit was issued; and

(b) in the case of a person granted absence on long service leave or sick leave, an amount in the same proportion to the amount of fee paid as is represented by the period of leave in proportion to the period for which the permit was issued.

Removal of vehicles

26B. (1) A vehicle parked in breach of these by-laws or a vehicle which is believed to have been left on the site for more than 3 days may be removed by order of the secretary to the security compound within the site and there stored.

(2) For the purpose of removing a vehicle under sub-by-law (1), an authorized person may take such action by way of unlocking, driving, towing or otherwise as is reasonably necessary.

(3) The Board of the Hospital may retain possession of a vehicle removed and stored under this by-law until the owner of that vehicle has paid to the Board fees for recovery of it at the rate of \$50 for the first 24 hours or part thereof and \$5 for each 7 days or part thereof thereafter. ”.

By-law 27A inserted

6. After by-law 27 of the principal by-laws, the following by-law is inserted—

Offences

“ 27A. A person who contravenes or fails to comply with any of the provisions of these by-laws commits an offence. ”.

By-law 30 amended

7. By-law 30 of the principal by-laws is amended in sub-by-law (1) by deleting “officer” and substituting the following—

“ attendant ”.

By-law 32 repealed and a by-law substituted

8. By-law 32 of the principal by-laws is repealed and the following by-law is substituted—

“ 32. (1) Subject to sub-by-law (2), an authorized person may by notice in the form of Form 3 in Schedule 3 served on the alleged offender withdraw an infringement notice.

(2) A person shall not be authorized to withdraw an infringement notice which was issued by that person. ”.

By-law 34 repealed and a by-law substituted

9. By-law 34 of the principal by-laws is repealed and the following by-law is substituted—

Prosecutions

“ 34. Proceedings for an offence against these by-laws may be taken by an authorized person holding the post of Administrative Officer under the control of the secretary. ”.

(e) by deleting the item relating to by-law 26 and substituting the following—

“ 26 (10) Using a permit for a purpose that is not valid 10 ”.

HEALTH ACT 1911

HEALTH (PESTICIDES) AMENDMENT REGULATIONS (No. 3) 1988

MADE by His Excellency the Governor in Executive Council on the advice of the Pesticides Advisory Committee.

Citation

1. These regulations may be cited as the *Health (Pesticides) Amendment Regulations (No. 3) 1988*.

Commencement

2. These regulations shall come into operation on 1 January 1989.

Principal regulations

3. In these regulations the *Health (Pesticides) Regulations 1956** are referred to as the principal regulations.

Regulation 6B inserted

4. After regulation 6A of the principal regulations the following regulation is inserted—

Review of registered pesticide and label every 6 years

- “ 6B. (1) Notwithstanding regulation 6A (4), the Executive Director, Public Health shall review a registered pesticide and the label relating to it within—
- (a) 6 years from the day on which the application for registration was recorded in the register under regulation 5; and
 - (b) every following 6 year period.
- (2) After carrying out a review referred to in subregulation (1) the Executive Director, Public Health may—
- (a) cancel the registration of a pesticide or the label relating to it, or both; or
 - (b) subject to subregulation (3) direct the person in whose name the pesticide and the label relating to it is registered to provide a new label within a period of 3 months.
- (3) The Executive Director, Public Health may vary the period referred to in subregulation (2) (b). ”

Regulation 19AA inserted

5. After regulation 19A of the principal regulations the following regulation is inserted—

Transportation of diluted pesticides

- “ 19AA. A person shall not transport a pesticide in a public place in a diluted form or to which any other substance has been added unless the name and concentration of the chemical is clearly marked on the container in letters with a minimum height of 100 mm. ”

Regulations 21A to 21D repealed and regulations 21A to 21F substituted

6. Regulations 21A to 21D of the principal regulations are repealed and the following regulations are substituted—

Definition of “used pesticide container”

- “ 21A. (1) Subject to subregulation (2) for the purposes of regulations 21B, 21C, 21D and 21E—
- “used pesticide container” means a container—
- (a) which has contained pesticide; or
 - (b) in which pesticide is contained.
- (2) Subregulation (1) does not apply to a container designed to contain less than—
- (a) 2 L of liquid pesticide; or
 - (b) 2 kg of solid pesticide,

when used for domestic or home garden purposes.

Disposal of used pesticide containers

21B. Unless the Executive Director, Public Health in any particular case otherwise directs, a person shall, after disposing of the contents (if any) in accordance with regulation 21F and washing out the used pesticide container, dispose of a used pesticide container by one of the following methods—

- (a) by arrangement with a local rubbish collection agency;
- (b) at a local shire rubbish tip after the owner of the container, by puncturing, breaking or flattening it, has rendered the container unusable; or
- (c) subject to regulation 21C by burying on the property of the owner of the used pesticide container.

Disposal on private property

21C. Where a used pesticide container is disposed of by the method referred to in regulation 21B (c) the owner shall ensure that the used pesticide container—

- (a) is rendered unusable by puncturing, breaking or flattening it; and
- (b) is buried at least 0.5 m below natural ground level in a place which is situated at least 30 m from any water course and a minimum of 3 m above the water table.

Cleansing, reuse and labelling of a used pesticide container

21D. (1) Subject to subregulation (2), a used pesticide container may be reused after it has been—

- (a) cleansed in a manner approved by the Executive Director, Public Health; and
 - (b) subject to subregulation (3) clearly labelled "USED PESTICIDE CONTAINER".
- (2) A container referred to in subregulation (1) shall not be—
- (a) used to contain substances or foodstuffs for human or animal consumption; or
 - (b) reused as a pesticide container.

(3) A person who reuses a used pesticide container on the property of the owner of the used pesticide container is not required to comply with subregulation (1) (b).

Authority required for disposal etc. of used pesticide containers

21E. (1) A person shall not undertake to collect and dispose of used pesticide containers for reward unless the person holds a written authority from the Executive Director, Public Health approving the person's methods of collection and disposal.

(2) The Executive Director, Public Health may—

- (a) impose any conditions on an authority referred to in subregulation (1); or
- (b) at any time cancel or revoke any such authority.

Disposal of pesticides

21F. (1) Pesticides may be disposed of—

- (a) by using in accordance with the label registered in respect of the pesticide;
- (b) by destroying by chemical means approved by the Executive Director, Public Health;
- (c) by incinerating at high temperature in an incinerator approved by the Executive Director, Public Health;
- (d) in a manner approved by the Executive Director, Public Health in a gazetted land-fill site;
- (e) where the pesticide contains less than 500 mL or 500 g of active constituent and the material does not contain a prescribed organochlorine or a substance specified in the Seventh Schedule in Appendix A to the *Poisons Act 1964*, by burying at least 0.5 m below natural ground level in a pit lined with an equal volume or weight of lime situated at least 30 m from any water course and a minimum of 3 m above the water table;
- (f) where the pesticide contains a prescribed organochlorine or a substance specified in the Seventh Schedule in Appendix A to the *Poisons Act 1964*, by burying the pesticide in accordance with paragraph (e) after obtaining the permission of and subject to any conditions imposed by the Executive Director, Public Health; or
- (g) by any other method approved in writing by the Executive Director, Public Health.

(2) For the purposes of subregulation (1) "prescribed organochlorine" shall have the same meaning as in regulation 54. "

(1) When pesticides are used by being sprayed, spread or dispersed from an aircraft in flight, a person taking part in the spraying, spreading and dispersal shall not leave used pesticide containers unattended on any land which is not owned or occupied by him unless the owner or occupier of the land is notified in writing before the containers are left on the land.

(2) When used pesticide containers are left on any land—

- (a) the person leaving the containers shall ensure that they are sealed and clearly labelled with particulars of their previous contents; and
- (b) the owner or occupier of the land shall ensure that the containers are—

(i) cleaned, reused and labelled;

or

(ii) disposed of,
in accordance with these regulations.

(3) In subregulation (1)—

"the owner or occupier" in relation to land which is Crown land means the Executive Director, Public Health.

(4) In this regulation—

"used pesticide container" shall have the same meaning as in regulation 21A (1). "

HOUSING LOAN GUARANTEE ACT 1957

HOUSING LOAN GUARANTEE (APPROVED HOUSING SCHEME) ORDER 1988

MADE by the Lieutenant-Governor and Deputy of the Governor in Executive Council under section 7C.

Citation

1. This Order may be cited as the *Housing Loan Guarantee (Approved Housing Scheme) Order 1988*.

Commencement

2. This Order shall come into operation on the day on which it is published in the *Government Gazette*.

Low Start Loan Scheme

3. The housing scheme in the Schedule to this Order is an approved housing scheme for the purposes of the Act.

SCHEDULE

Low Start Loan Scheme

1. To be eligible under this scheme—

- (a) the applicant shall declare in a manner satisfactory to the Minister that the applicant intends to use the house the subject of the application for the applicant and spouse and dependants of the applicant; and
- (b) the applicant shall not be the owner either as joint tenant or tenant in common, of any residential property other than the land the subject of the application.

2. The maximum value of the land and house to be erected or purchased by the applicant shall not exceed \$61 000 or such other amount as is fixed by the Minister in relation to the area in which the house is or will be situated.

3. The minimum deposit to be paid by the applicant in respect of the property shall be 10 per cent of the lending institution valuation subject to a reduction in respect of dependent children of an amount to 5 per cent of that valuation at the discretion of the lending institution.

4. The maximum value of the loan shall not exceed \$51 000 or such other amount as is fixed under section 7B of the Act by the Minister in relation to the area in which the house is or will be situated.

5. Provision is to be made for repayment of the loan including provisions for—

- (a) instalments during the first year of the loan to be not less than 25 per cent of the gross family income of the applicant as assessed by the lending institution by its usual procedures;
- (b) calculation of a notional rate of interest, using the 25 per cent referred to in paragraph (a), the *credit foncier* method and the initial loan value, that notional rate of interest to be below the prevailing rate of interest charged by the lending institution on new owner occupier home loans (the "specified rate"); and
- (c) deferring of interest on the loan with—
 - (i) the initial deferment being not more than 5 percentage points below the specified rate and the minimum notional rate of interest so reached being not less than 10 per cent;
 - (ii) the notional rate of interest at the start of the loan to be increased by 0.5 percentage points on each anniversary date of the loan until the notional rate equals the specified rate prevailing at the time; and
 - (iii) the deferment to cease by the end of the 10th year of the loan with the lending institution to adjust the instalments payable during the first 10 years to ensure that the specified rate is so achieved.

Council’s objective is to encourage medium density residential development in specified areas, to promote development for both permanent and rental accommodation to the highest possible standard.

Notwithstanding the conditions of the R 50 Code nothing shall prevent the Council from limiting any building to a height of two storeys.

- (e) Landscaping

Any application for development of any residential building other than a single dwelling shall be accompanied by a plan showing the proposed landscaping on the site.

(ii) The location and nature of materials to be used on non-planted areas.

The applicant shall commence the implementation of the approved landscape plan from within six calendar months of the completion of all other approved works. In the R 30 and R 50 code areas all car parking areas shall be located and/or screened such that they are not visible from the street.

IN pursuance of the powers conferred upon it by the abovementioned Act, and of all other powers enabling it, the Council of the abovementioned Municipality hereby records having resolved on 3 May 1988 to make and submit for confirmation by the Governor, the following amendments to the By-laws.

The By-laws of the Town of Northam published in the *Government Gazette* on 5 May 1978 and amended as published in the *Government Gazette* on 15 April 1988 is hereby amended in the following manner.

1. By-law 88 is revoked and remade as follows—

Committees Standing Committees

- (3) Accounting and Administration Committee.
- (4) Health and Urban Development Committee.

Each of the Committees shall consist of four members who shall be elected each year at the first meeting of the Council held after the annual election.

2. By-law 90 is revoked and remade as follows—

Duties of Standing Committees

90.

Standing Committees shall have the powers and duties as follows—

Establishment and Co-ordination Committee

- (a) Consideration and recommendation to Council on all matters of new policy whether suggested by a Committee of Council or Officers.
- (b) Consideration and examination of any report made by the Council Officers on any matter of organisational structure.
- (c) Consideration and adoption of each 5 yearly programme of capital works and 3 yearly financial strategy.
- (d) Consideration and recommendation to Council of the Budget for all funds, including recommendation on rates, charges and dues.
- (e) Consideration of matters relating to major land acquisitions and/or entrepreneurial proposals.
- (f) Consideration and review of salaries, wages and working conditions of all Officers and employees.

- (g) Consideration of all aspects of Councillor and staff training requirements.
- (h) Examination on a quarterly basis of Council's current financial position.
- (i) Claims against Council arising out of the exercise of its powers, functions and duties.
- (j) Consideration of all requests for expenditure not included in the Budget.
- (k) Consideration of By-laws with relation to matters as may be determined by Council, provided that another Committee may recommend the draft of a By-law, the oversight of which it is responsible.
- (l) Consideration of ward and/or Council boundary alterations.

Accounting and Administration Committee

- (a) Management and use of Council property including the following—
 - (1) Housing
 - (2) Swimming Pool
 - (3) Recreation grounds and associated facilities
 - (4) Cemeteries
 - (5) Halls
 - (6) Recreation Centre
- (b) Management and conduct of Library service.
- (c) Pass accounts for payment.
- (d) Consideration of the leasing, renting and dealing with any property vested in Council, or owned by Council.
- (e) Preparation and arrangement of civic functions.
- (f) Oversight of matters pertaining to public relations, publications and the dissemination of information on council activities.
- (g) Promotion of recreational and cultural activities in liaison with community groups.
- (h) Considerations for the recovery of all debts due to the Council including where appropriate the sale of land for unpaid rates.
- (i) Consideration of all aspects relating to the development of tourism, economic development, Avon Descent and Avon River.
- (j) Planning of all recreation, sporting grounds and playgrounds.
- (k) Such other matters not under the care/control of another Committee.

Health and Urban Development Committee Health

- (a) Matters pertaining to the health and well being of the community pursuant to the relevant statutes.
- (b) Surveillance over sanitary provisions for collection and disposal of sewerage, refuse and liquid wastes.
- (c) Control of nuisance offensive trades, insects and pests, distribution and sale of drugs and food to the public.
- (d) Providing for the protection of health and life of the community, including immunisation, welfare and health education.

Urban Development

- (a) Control of Council's Ranger services, including dogs, stray animals, traffic, litter and fire protection services.
- (b) Hawkers, stalls and itinerant food vendors.
- (c) Control of building operations, supervision of construction in respect to all buildings the subject of the Uniform Building By-laws, and/or appropriate Council or Uniform By-laws.
- (d) Oversight of dangerous, neglected or dilapidated buildings and demolition as may be ordered by Council.
- (e) Control of erection, location and upkeep of signs, hoardings, bill postings and fencing pursuant to the By-laws relating thereto.
- (f) Construction and maintenance of buildings for Council purposes (in conjunction with Finance and Administration Committee where appropriate).
- (g) Matters relating to the regulation and uses of land pursuant to the provisions of the Town Planning Act, a Town Planning Scheme or By-laws.
- (h) Oversight of the subdivision of land, classification or zoning of land use, location and layout of streets and ways, reserves, parks and grounds for public use.
- (i) Control of the height, location, design, purpose, dimensions or general character of buildings or other structures as provided under a Town Planning Scheme or By-law.
- (j) Preparation of Town Planning Schemes for planning, re-planning or reconstruction of areas for the purpose of improving and development of land, and the supervision and operation of such scheme.

Works and Reserves Committee

- (a) Construction, maintenance and management of works in streets, ways and other public places including private streets and places as approved by Council involving design, alignment, levels, drainage, widening, relocation, lighting, care and protection.
- (b) Purchase, maintenance and upkeep of plant and equipment, procurement of materials required for carrying out of works.
- (c) Construction and maintenance of road signs and street furniture.

- (d) Engagement and dismissal of employees in respect to performance of works.
- (e) Control of quarries and supervision of quarrying operations.
- (f) Layout, design, construction and maintenance of parks and reserves for recreation and public use, street trees and road verges.
- (g) Preparation of draft works and plant programmes.

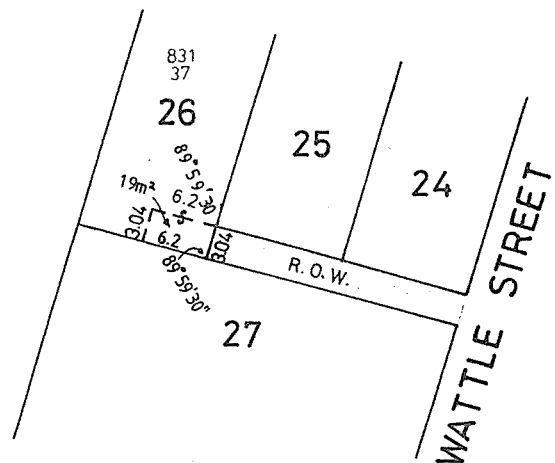

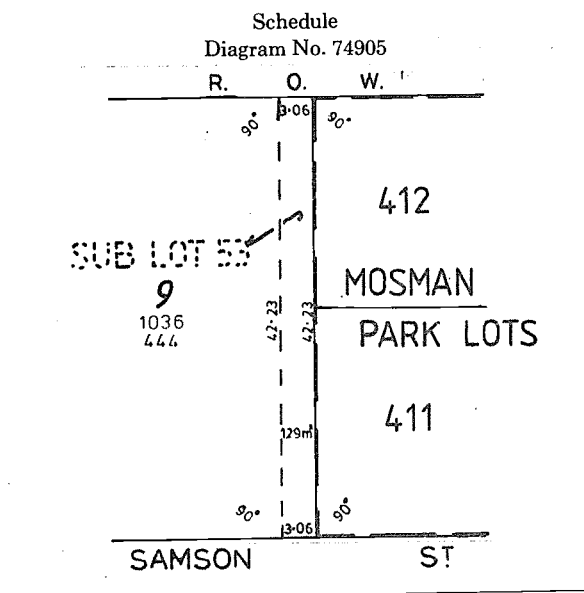
